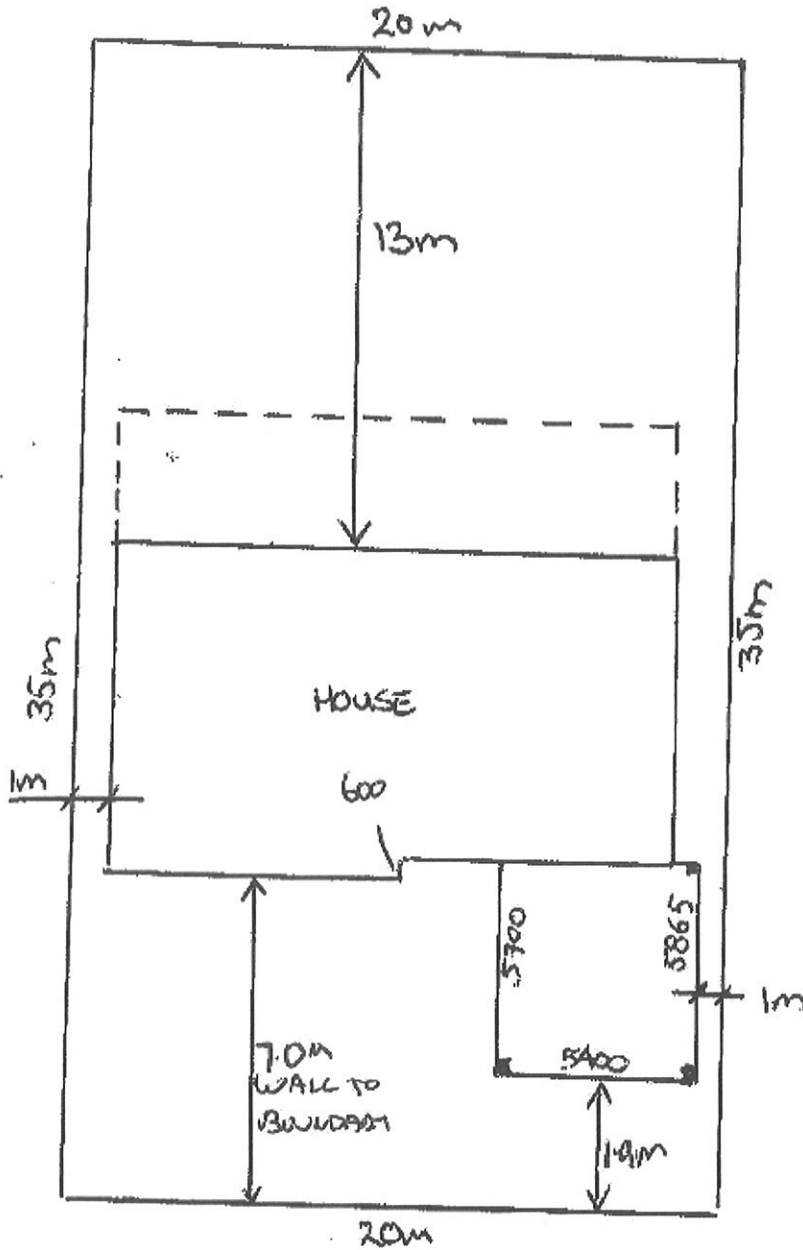

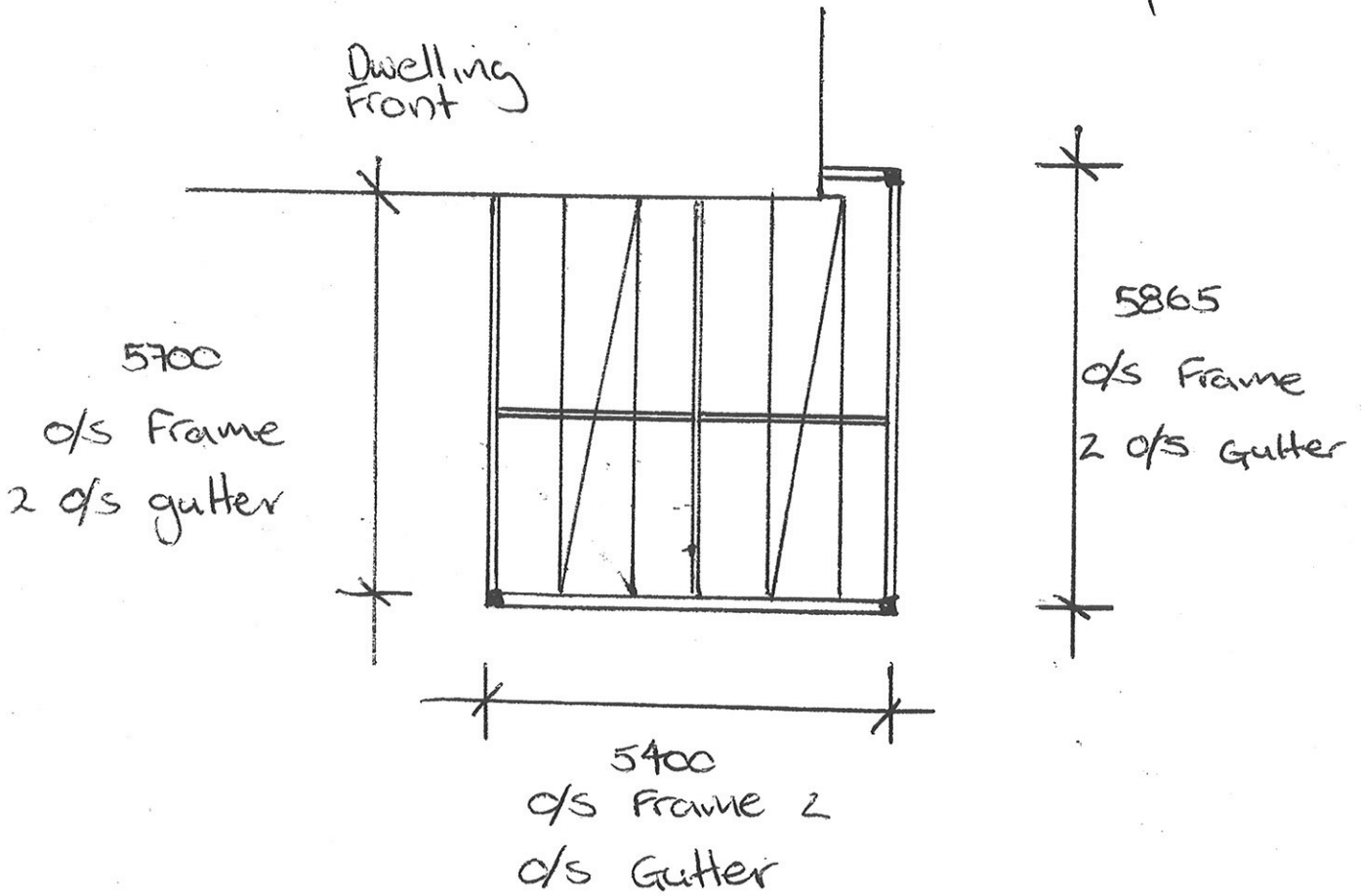

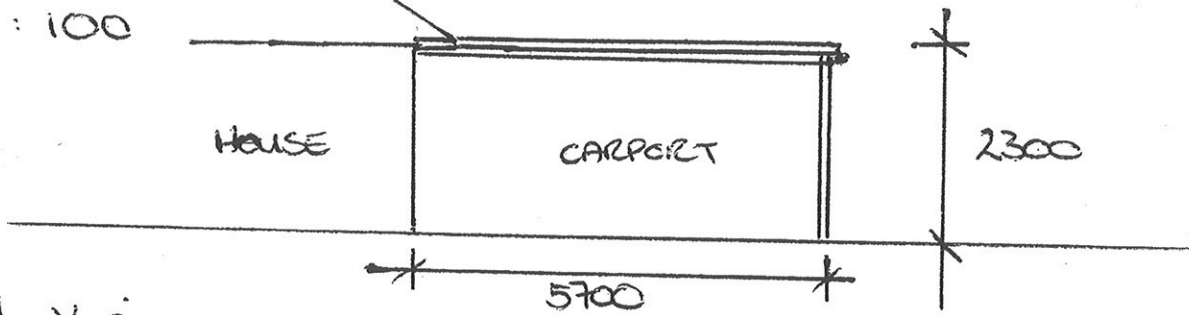

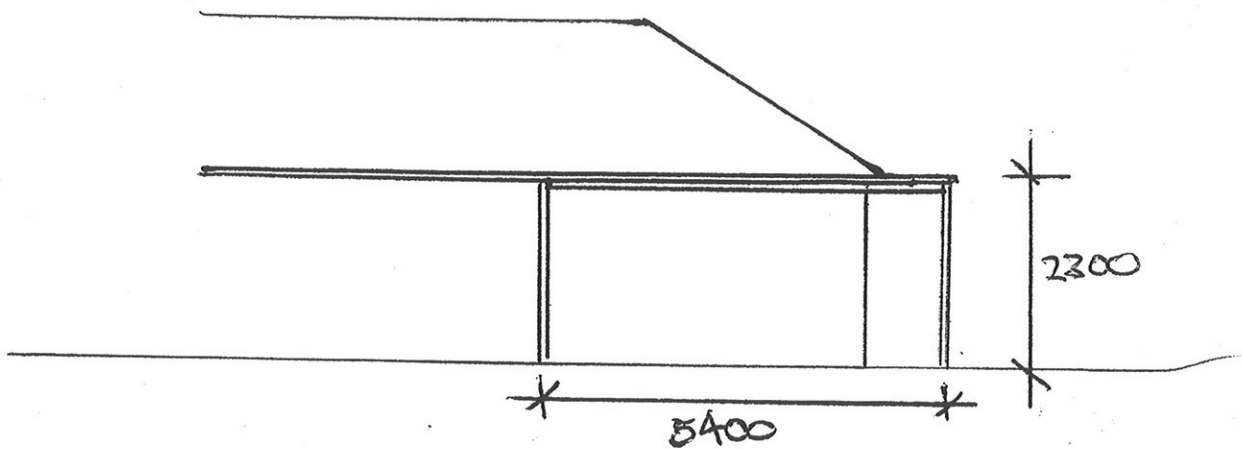

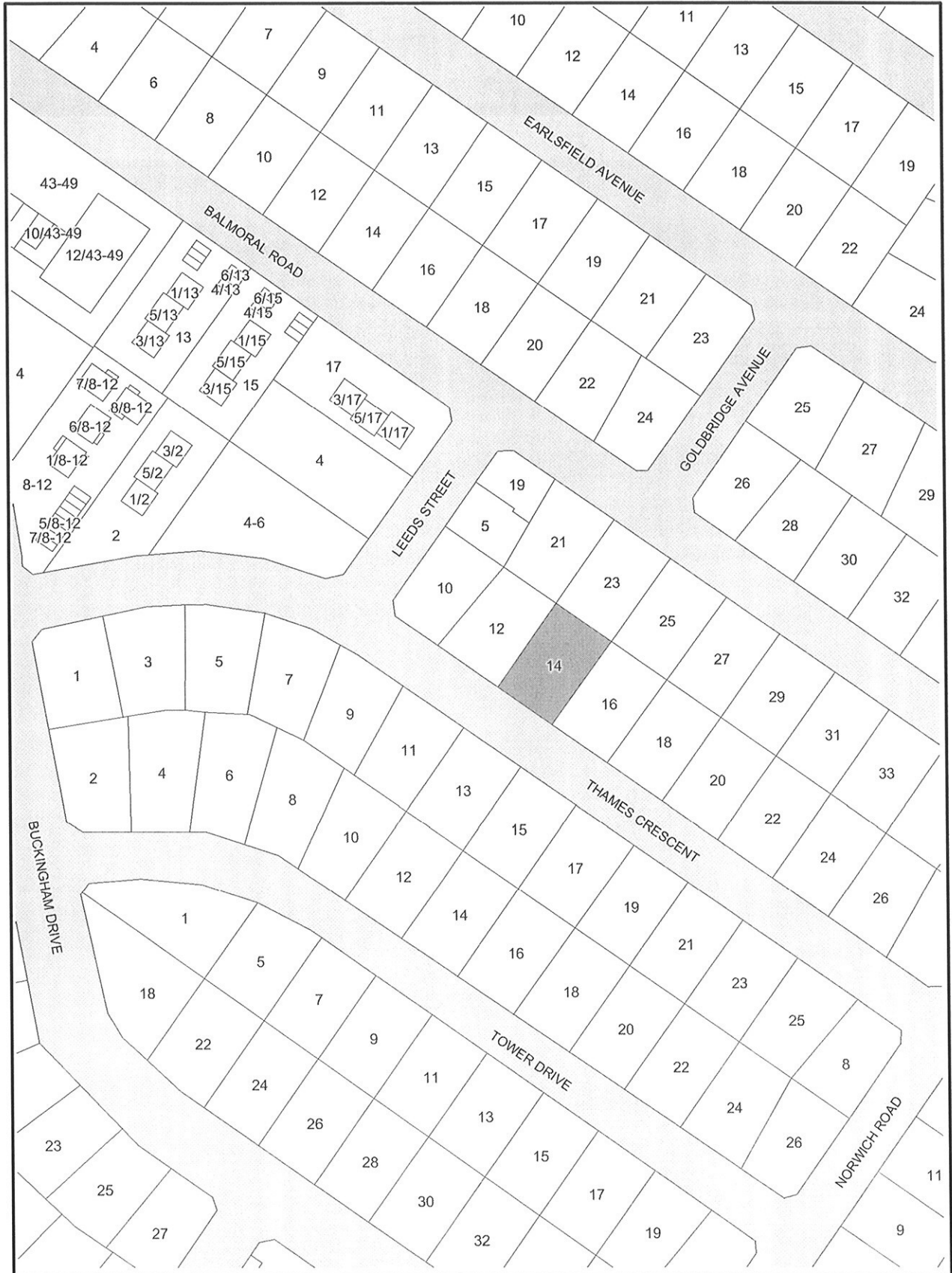


Front View

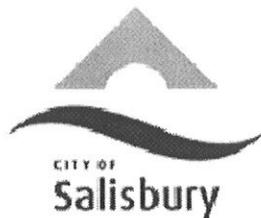
