

## Streetscape Renewal Program, Community Consultation

In June 2022, Council conducted an initial community consultation (Stage 1) to obtain background information on how the existing streetscape of Boyara Crescent is viewed by its residents, and what they would like to see included as part of the future renewal.

Following the initial Stage 1 consultation, a draft concept plan has been developed for Boyara Crescent (overleaf) and Council are now seeking community feedback on the draft plan.

The draft concept plan has been prepared based on feedback from the previous Stage 1 consultation and the technical requirements for the street.

## Next Steps

As part of the design development process the City of Salisbury will review the feedback provided by residents.

Based on this feedback, and the technical requirements for the street, a final design will be developed for community consultation. The final design will be provided to residents, including a summary of how community feedback was considered throughout the process.

Construction works are expected to occur within the 2022 / 23 financial year..

## Vegetation

Feedback received during Stage 1 consultation with residents indicated that while street trees are an important element of the streetscape, there are concerns about safety and maintenance for some of the existing street trees. The Streetscape Renewal Program will provide a greater mix of vegetation sizes and species. Residents are encouraged to provide feedback on the preferred tree species for their street (see options across).
