Frequently Asked Questions

Church and John Streets provide important connection to the Salisbury City Centre which includes supermarkets, retail shops, eateries, entertainment venues, banking and community services. It is also an essential public transport route.

This renewal project will undertake works to re-activate the City Centre as a vibrant, enjoyable and safe place for people to visit and work.

The renewal of Church and John Streets is a \$8 million investment by the City of Salisbury. This project forms part of the City of Salisbury's City Plan 2035, aligning with the Salisbury City Centre Renewal Strategy.

Q What is included in the renewal?

A The renewal will see the continued revitalisation of the City Centre, complementing the Salisbury Community Hub. It will continue to create a sense of place which reflects Salisbury's heart and identity.

The renewal will improve lighting and landscaping to create a renewed pedestrian environment and improved experience for visitors, shoppers, diners, and workers. The renewal aims to:

- support the community, traders and visitors to the City Centre
- develop Church Street and John Street as main street boulevards
- improve social benefit and diversity of the Salisbury City Centre for residents and traders
- set the foundations to encourage economic investment.

Q What are the project timeframes?

A In 2020, feedback from traders and the community was invited on a preliminary concept plan for the renewal of Church and John Streets.

This feedback, along with technical, environmental and financial information is now being used to finalise the design.

A contractor is in the process of being engaged to deliver the works.

It is expected that works will commence in the coming months and be completed by the end of the year.

Q Will Church and John Streets stay open during construction?

A Yes. The construction will be managed to allow Church and John Streets to continue to be a place where people shop, dine, visit and spend time. This means that no businesses will need to close during the construction.

Pedestrian access will always be available along the streets and into all businesses and buildings during the day.

Given the busy nature of the streets, construction works are likely to cause some disruption to businesses and people using the streets. It is a priority of the project to manage the staging of the construction phases efficiently and in a timely manner, while managing disruption.

Q How will nearby traders, businesses and building owners be supported?

A Church and John Streets will remain open for business during construction, with activities to account for business needs to minimise disturbance.

We will work with Church and John Street traders, businesses, building owners and other stakeholders before construction starts to understand individual requirements during the works. This will continue throughout construction to manage any impacts.

During construction, we will let visitors know that Church and John Streets are 'open for business'.

Regular updates will also be provided to the Church and John Street traders, businesses, building owners and other stakeholders to keep them informed about the progress of construction and to provide advanced notice of upcoming works. We will work with individual traders and businesses on any specific impacts.
