At least 150 people took part in this engagement via the following methods:

• 120 people took part in face-to-face interviews carried out in St Kilda precinct from 18 February 2017 and until 27 February 2017



FEEDBACK FROM THE SURVEYS




Percentage of respondents who engage in the top most popular activities



Survey respondents were divided into four groups (boating community, playground users, recreational users and fishing community), based on the dominant activity that they carried out in St Kilda precinct.

Survey results were broken down by these four user group types.





CULTURAL DIVERSITY OF RESPONDENTS

20% of the survey respondents were born in overseas countries.

16% of the survey respondents speak languages other than English at home.

30% of survey respondents have ancestry other than Australian.

61% of the survey respondents were not aware that St Kilda was part of the International Bird Sanctuary.

Many respondents commented during interviews that they are supportive of Council investing in the area. The proposal that received the highest approval rate was for asphalting and line marking of the existing main playground car park with 78% either agreeing or somewhat agreeing that this proposal would be beneficial to the St Kilda precinct.

FEEDBACK FROM THE COMMUNITY WORKSHOPS

Proposal 1

Supported by a majority of the participants. Some respondents questioned the need for the roundabouts. Engineering alignment needs to be checked to accommodate large coaches and trailers.

Proposal 2

Supported by a majority of the participants. Adjacent residents were not supportive due to envisaged impacts. Impacts should be minimised.

Proposal 3 Supported.

Proposal 4

Consider an alternative option for a layover area in Cockle St.

Proposal 5

Consider an alternative proposal described in one of the submissions.

Proposal 6

Supported by a majority of the participants. Some residents questioned the need. Consider compacted dolomite surfacing instead.

Proposal 7 Supported.

Proposal 8

May not be needed if alternative to proposal 4 is constructed.

Proposal 9

Supported by a majority of the participants. Consider parking for coaches.

Proposal 10

Supported by a majority of the participants. Consider opportunities for shortening the path.

BACKGROUND



SCOPE OF THIS STUDY

Intermethod was commissioned by the City of Salisbury to carry out community engagement in the St Kilda precinct in relation to the Stage 2 Masterplan. The scope of this stage relates to the Marine Recreation Precinct and Mangroves. This draft Masterplan was endorsed for community engagement at the November 2016 Council meeting.

Engagement sought specific feedback on the following recommendations from the St Kilda Stage 2 Masterplan (see the map on the next page for locations):

- 1. Construct two new roundabouts in Cockle Street to improve traffic movement and safety.
- 2. Create a new parking area off Cockle Street, stabilise and line mark 164 additional car parks.
- 3. Stabilise and resurface the existing trailer park and line mark for 120 long trailer bays and 51 standard carparks.
- 4. Asphalt the Fooks Tce car park and include coach layover and drop off area and additional 61 car parking spaces.
- 5. Construct new layover area for motorised homes (RVs) near the boat launch toilet block.
- 6. Asphalt and line mark existing main playground car park.
- 7. Construct an additional boat ramp, additional mooring pontoons and pedestrian path connections.
- 8. Modify the intersection with the roundabout at St Kilda Road and Whiting Street to direct coaches to the secondary car park near the hotel.
- 9. Asphalt Mangrove Trail parking near main entrance.
- 10. Establish a pedestrian path from the kiosk to the Mangrove Trail.
- 11. Repair closed sections of the mangrove boardwalk.
- 12. Make improvements to the footpath along the breakwater and install solar lighting.

In addition to feedback on specific street improvements, the engagement sought open-ended comments and suggestions for other improvements in the area.



ENGAGEMENT ACTIVITIES

For this engagement, feedback was obtained via the following four methods:

Face-to-face surveys	Face-to-face surveys were conducted in St Kilda on Saturday 18 February (by 3 interviewers), Sunday 19 February (by 1 interviewer), Tuesday 21 February (by 2 interviewers), Saturday 25 February (by 1 interviewer) and Sunday 27 February (by 1 interviewer). During each day, interviews were conducted over a 4-5 hour period.
	The target sample size for these surveys was 100 respondents with at least 40% to be persons sailing boats from the marina.
	A sample size of 120 respondents was achieved, with 50% persons sailing boats, 7% fishing, 35% using playground and 8% engaging in recreational activities (walking a dog, walking along the beach and bird watching).
	An on-line survey was available from 17 February 2017 and until 10 March 2017. A total of 3 electronic surveys were received.
Submissions	8 members of the public submitted their comments via letters and e-mails.
Workshops	Two workshops were held on 21 March and 22 March 2017. Invitees to these workshops were: all residents of St Kilda, local stakeholders, Ward Councillors, the Mayor and state government stakeholders.

During all five days, generally good weather was observed. There were small episodes of rainfall during the first two survey days. Interviews were not conducted during rainfall.


ACTIVITIES THAT RESPONDENTS ENGAGED IN OVER THE LAST YEAR IN ST KILDA PRECINCT

St Kilda precinct offers a great diversity of recreational activities, such as boating, fishing, visiting the Adventure Playground, bird watching and walking along the coast. St Kilda Masterplan envisages improvements to support these activities. All engagement participants were asked questions about all proposed improvements, irrespective of what activities they engaged in at St Kilda in the last 12 months. Feedback will be attributed to respondents, based on their key interest in uses in St Kilda precinct, as explained in this section.


• How many times in the last year (including today's visit) did you do the following in the St Kilda precinct?




RESPONDENT TYPES - APPROACH TO SORTING FEEDBACK



DISTANCE TRAVELLED TO ST KILDA FROM HOME


All 123 survey respondents provided post code for the place of their residence. 16 (13%) of the respondents came from outside of Metropolitan Adelaide: 3 from Nuriootpa, 3 from Mount Pleasant, 2 from Tailem Bend, 2 from Murray Bridge, 2 from Wall Flat and one each from Barmera, Port Paterson, Barossa and Cambrai.

Note that the closest significant population to St Kilda is 5 kilometres away.

13% of all survey respondents were visitors from regional Adelaide.
Average distance travelled from home to St Kilda precinct (visitors from Metropolitan Adelaide) was 19.5 kilometres.
Playground users travelled the longest distances, 22.6 kilometres on average.




Level of support for each proposed improvement for all respondents combined

would be beneficial to the St Kilda precinct.



LEVEL OF SUPPORT FOR CONSTRUCTING TWO NEW ROUNDABOUTS IN COCKLE ST




LEVEL OF SUPPORT FOR CREATING NEW PARKING AREA OFF COCKLE ST



LEVEL OF SUPPORT FOR STABILISING AND RESURFACING EXISTING **TRAILER PARK**




LEVEL OF SUPPORT FOR ASPHALTING FOOKS TCE CAR PARK


LEVEL OF SUPPORT FOR CONSTRUCTING NEW LAYOVER AREA FOR RV'S










LEVEL OF SUPPORT FOR ESTABLISHING PEDESTRIAN PATH TO MANGROVE TRAIL




LEVEL OF SUPPORT FOR REPAIRING CLOSED SECTIONS OF MANGROVE **BOARD WALK**







This submission proposed an additional 'new safe hard stand zone where recreational vehicles (RVs), self-contained motorhomes, caravans, fifth wheelers and similar type vehicles are able to stay in a separate fenced off area away from the car parks.

Proposed features/work components should include:

- Location close to the boat channel and other amenities
- Lockable fence with key available from the kiosk
- Removal of old tram lines
- Upgrade of maintenance roads
- Heavy duty entry and exit gates
- Provision for large RVs to park off the main road while picking up the key at the kiosk
- New fresh water tap
- Minimal impact on vegetation
- Signage.

Main topic	Not supportive of major additional investment in St Kilda
Date	7 March 2017

Respondent type	City of Salisbury resident

- Not supportive of much of the investment on the grounds that proposed investment is excessive 'for a community of 247 people'.
- Believes that St Kilda has already received sufficient funding in the past and that there are other areas in the City of Salisbury, which appear to be neglected.
- Believes that expenditure is excessive and detrimental to investment in other areas.
- Current facilities appear fine as they are and people already like the Mangrove Trail, in its current state.
- Concerned about the lack of capital works and maintenance in the wider council area, despite many faults having been reported.
- Noted a dramatic decline in maintenance in Montague Farm/Pooraka in the last couple of years.
- Concerned that there are many instances of infrastructure elsewhere in Salisbury where basic provisions have not been made (e.g. bus stops, benches, park facilities, footpaths etc), while other areas are receiving excessive unequitable levels of funding.
- Concerned that there is a lack of transparency with regard to actual costs for all St Kilda masterplan stages.
- Concerned that there is no information on the context and costs for future stages 3 and 4 of works at St Kilda and Council's overall financial commitment to the precinct.
- Queried whether a cost/benefit analysis has been carried out.

- Queried whether benefits to the wider City of Salisbury economy were identified and projected returns on investment assessed.
- Queried whether Environmental Impact Study was carried out and impacts on the Bird Sanctuary were assessed.
- Questioned validity of usage statistics due to assumptions made.
- Made an observation that a very small amount of the City of Salisbury residents used the area.

As part of the submission, a range of alternative proposals were suggested that would present cheaper and simpler solutions than current St Kilda Stage 2 Masterplan proposals.

Main topic	Request for Bird Sanctuary signage and a bird hide

- Raised that there is a lack of signage and interpretive boards in relation to bird watching and Adelaide International Bird Sanctuary status.
- · Raised that there is a lack of maps or online maps/directions for observing birds in St Kilda.
- Suggested construction of a bird hide for observing birds from a quiet vantage point, away from playground noise.
- Sought installation of Bird Sanctuary and Indigenous signage/interpretive information.
- Supportive of the playground and boat ramp area upgrades.

Main topic	Alternative proposal for the Mangrove Trail board walk route

- Due to sea levels rise, current board walk route is more exposed to storm surge damage. Previous widening without changes to the piled base also made it more suspectable to damage.
- Sea level rise has resulted in habitats moving.
- Proposed new route for the board walk that:
 - » will utilise existing paths on the old seawall built in the 1890s and the salt field embankment built in the 1930s
 - » will allow people to walk through the salt ponds, salt marshes and the mangrove forests.

- Concerned that the St Kilda Tramway was not shown on the plan.
- Concerned that the modified intersection at the corner of St Kilda Rd and Mangrove St would reduce safety and increase hoon driving.

Main topic	The need to minimise impacts of visitor activities on residents

Respondent type	Local St Kilda resident

- Not supportive of the proposal to create a coach layover and a new car park at Fooks Tce (proposal 4) as it impacts the adjacent residents.
- Residents do not want an expansion of car parks in the area, as there are already plenty car parks and car parks are unattractive to look at.

- Plant more grass, vegetation and trees to attract more birds to the area and to suppress the dust.
- Concerned with tree removal by contractors and the boat club.
- Wants to see bike and walking trails in the area.
- Not supportive of the proposed investment in the Mangrove Trail, due to its poor accessibility and because the car park in front of the Trail attracts undesirable uses at night time.
- Concerned with the boat club lease arrangements, their land management/ development, boat club's fencing that interrupts the walking path and inhibits emergency vehicle access, and boat club members' habits of speeding in the area.
- Not happy about Council's cheap sale of the land to the boat club on the south side.
- No need for any lights at the end of St Kilda Rd.

Main topic	Considerations for the proposed roundabout at intersection of St Kilda Rd with Whiting St

Respondent type	Local St Kilda resident

- Generally in support of all of the proposals.
- With regard to the roundabout at the corner of St Kilda Rd and Whiting St (proposal 8); given the narrowness of Beach Rd and Whiting St, suggests to either line mark to separate traffic on those streets or make it a one way loop down Beach Rd and back via Whiting Street
- Consideration should be given to streetscaping/landscaping if the roundabout at St Kilda Rd intersection with Whiting St is constructed. Suggest council talks to the Adelaide International Bird Sanctuary people about how those plantings could be used to create additional bird habitat.



FEEDBACK FROM THE WORKSHOPS



On Tuesday 21 March 2017 a local community workshop was held at the Progress Association Hall (St Kilda Community Hall). All St Kilda residents were invited to attend this workshop via a leaflet delivered to letter boxes. Intermethod facilitated the workshop, and three City of Salisbury staff and an Elected Member were in attendance and contributed to the discussions. A total of 23 residents attended and feedback was explored at two discussion tables. During this workshop, each of the 12 proposals were discussed.

Feedback from this community workshop was summarised and presented on the next day, Wednesday 22 March 2017, to the participants of the St Kilda Stakeholders meeting at the City of Salisbury. During this second meeting, feedback was verified and added to by the stakeholder group.

This report section provides a combined feedback summary from both of these workshops. In this section, 'workshop 1' relates to the resident workshop on 21 March 2017 and 'workshop 2' refers to the stakeholder workshop on 22 March 2017.

Proposal 1

Construct two new roundabouts in Cockle Street to improve traffic movement and safety.



Feedback from workshop 1:

- 5 residents at one of the discussion tables were not supportive stating that:
 - » The roundabouts are not needed.
 - » The roundabout are a waste of money, as they will not prevent speeding and there are no issues with traffic.
 - » Many of the visitors to the area do not know the right of way rules for the roundabouts, so roundabouts are dangerous in this area.

- » Bus movement will be restricted by the roundabouts and kerbing will be continuously hit.
- Second discussion table was generally supportive of this proposal.

Feedback from workshop 2:

- Proposal was generally supported.
- It was highlighted that many vehicles that come to St Kilda are large: buses and large cars with trailers and boats. Therefore, alignment of the design needs to be verified to ensure it can accommodate all vehicle types.

Proposal 2

Create a new parking area off Cockle Street, stabilise and line mark 164 additional car parks.



Feedback from workshop 1:


- Residents living adjacent to the car park opposed the proposal stating that:
 - » Car park is facing the residential street and the proposal does not address impacts on residents.
 - » Extending the bitumen will attract more hoons and drug users to the area, who will now be coming closer to residential homes.
 - » This area should be vegetated instead.
 - » Additional car parking can be installed across from the Progress Hall.
- Second discussion table was generally supportive of this proposal.

Feedback from workshop 2:

- It is logical to have a car park here, as it is used for parking already.
- Effective buffers should be installed to screen this car park from the residential properties with consultation from the residents. Residents should decide whether they want an unobstructed view or a view of a vegetation barrier.
- Dust from this patch of land will be minimised as it will be either bitumenised or vegetated.

Proposal 3

Stabilise and resurface the existing trailer park and line mark for 120 long trailer bays and 51 standard carparks.



Feedback from workshops 1 and 2:

• Residents and stakeholders were supportive of the proposal.

Proposal 4

Asphalt the Fooks Tce car park and include coach layover and drop off area and additional 61 car parking spaces.



Feedback from workshop 1:

- 6 residents were not supportive of the proposal stating that:
 - » The proposal will impact on hotel parking.
 - » Existing parking around the hotel will seriously hinder the ability to drive through.
 - » It would be much better to construct coach layover area in Cockle St (between two proposed roundabouts).
- Second discussion table supported car park near the hotel being no through road and was generally supportive of the new car park.

Feedback from workshop 2:

- Currently the hotel is not using this area for car parking.
- It may be a valid concern that coaches and buses may have a difficulty manoeuvring past hotel's on-street parking in St Kilda Rd adjacent to the Progress Association Hall.
- It is worth investigating whether this coach layover area can instead be constructed

between the two proposed roundabouts in Cockle St, as it would save money, will gain more support from the residents and will not require intersection modifications (proposal 8). Also this alternative location is better for further separating visitors from local residential uses.

Proposal 5

Construct new layover area for motorised homes (RVs) near the boat launch toilet block.



Feedback from workshop 1:

- Participants from one of the discussion tables did not support this proposal stating that:
 - » It will be too difficult for large vehicles to manoeuvre into this area with the current line marking arrangements.
 - » Parallel parking in the proposed arrangement will physically not be possible due to the large size of the RVs that will not be able to turn into the area.
 - » Removal of established vegetation is not desirable.
 - » Campers would want to spread out much more than the proposed arrangement would allow.

- » An alternative proposal described in the e-mail to Council dated 1 March 2017 (summarised in the previous section) was supported instead.
- Second consultation table would also prefer to retain vegetation and utilise instead the area adjacent to the tram tracks.
- Overall, residents were supportive of keeping RVs separate from the car park area and the playground.

Feedback from workshop 2:

- Residents have a preference for an alternative arrangement described in the e-mail to Council dated 1 March 2017 (summarised in the previous section).
- There is a need to extend RV area even further North to allow room for backpackers and tents.
- Consideration must be given that if RVs are screened by vegetation from the car parking areas, this will minimise passive surveillance, which was one of the key drivers for this proposal.
- Convert one of the disabled toilets to also accommodate a shower, which is much needed in this area.

Proposal 6

Asphalt and line mark existing main playground car park.



Feedback from workshop 1:

- Some of the residents at one of the discussion tables did not support the proposal stating that:
 - » There is nothing wrong with the existing car park. The proposal is not needed and is a waste of money.
 - » Angled parking would work better.
 - » This is not a priority improvement and it should be placed on hold.
- The proposal was supported by the participants at the second discussion table.

Feedback from workshop 2:

- This car park has to be fixed. There is no line definition, which creates parking problems.
- It may be possible to compact dolomite over the area, rather than asphalting it.

Proposal 7

Construct an additional boat ramp, additional mooring pontoons and pedestrian path connections.



Feedback from workshops 1 and 2:

• Residents and stakeholders were supportive of the proposal.

Proposal 8

Modify the intersection with the roundabout at St Kilda Rd and Whiting Street to direct coaches to the secondary car park near the hotel.



Feedback from workshop 1:

- Some of the residents (5) did not support the proposal stating that:
 - » The intersection modifications are impractical.
 - » There are no traffic issues at this intersection.
 - » The proposal is not needed and is a waste of money.
- The proposal was supported by the participants at the second discussion table.

Feedback from workshop 2:

• This proposal may not be needed if the coach layover area will be constructed in an alternative location in Cockle St (see feedback on proposal 4).

Proposal 9

Asphalt Mangrove Trail parking near main entrance.



Feedback from workshop 1:

- Some residents were supportive, because the Mangrove Trail is a great asset and will attract even more visitors to the area.
- Better usage of the interpretive centre needs to be made.
- Signage needs much improvement and new bird hides constructed.
- Some residents (3) were not supportive of the proposal stating that:
 - » Very few people come to the area.
 - » Current car parking arrangements are fine, though more consideration should be given to coach parking in this area.
 - » The area will be misused with undesirable congregations.
 - » Spend is not warranted.

Feedback from workshop 2:

- Supportive of the proposal in general.
- It should also consider parking location for coaches.

Proposal 10

Establish a pedestrian path from the kiosk to the Mangrove Trail.



Feedback from workshop 1:

- The need for a walking path was broadly supported.
- Some residents (3) felt that alignment of the path was not optimal and could be improved. Suggestions made were:
 - » The path is too long and convoluted, as it is constrained by the lease arrangements with the boat club. The lease should be cancelled so as not to cut off the path.
 - » The path should be made shorter and more direct. The fence should be taken off.

Feedback from workshop 2:

• The proposal was supported.

Proposal 11

Repair closed sections of the mangrove boardwalk.

Feedback from workshops 1 and 2:

• Residents and stakeholders were supportive of the proposal.

Proposal 12

Make improvements to the footpath along the breakwater and install solar lighting.

Feedback from workshop 1:

- Supported by all of the residents.
- There was a further suggestion of installing seating along the breakwater.

Feedback from workshop 2:

- Participants were supportive of the proposal.
- Note that a grant application has been submitted to the State Government to fund lighting installation. If successful, committed funding can be diverted to other improvements.

Further suggestions

- A reliable CCTV is needed in the area.
- Construct a new safety crossing across the tramline for children's safety.
- Install more seating at the playground between the pirate ship and the breakwater.
- Maintain coast for bird habitat: remove some of the mangrove shoots and seaweed.
- Improve signage throughout. Install signage around the beach to warn of soft sand and black mud.
- Upgrade road near the hotel along the sea wall.
- Encourage kiosk to make sales at the playground.
- Install more swings at the playground.
- Create tram separation at Shell/Fooks Tce intersection.
- Remove unused tram tracks.
- Improve maintenance of the area.
- Manage growth in the area and attract/build amenities.
- Make the area more bike friendly (which does not necessarily mean sealed paths).
