## TERMS AND CONDITIONS

1. It is the responsibility of the permit holder to ensure all steps are taken to prevent dog(s) from creating a nuisance to the public such as:
  - Excessive barking from your dog(s)
  - Failing to keep the property clean from dog faeces
  - Not preventing dogs escaping your property
  - Dog(s) from your property being involved in a dog attack
2. Council may inspect the property at any time to ensure the conditions of the approval are being complied with.
3. The permit is only valid for the dogs listed on this application, should a dog leave the property it cannot be replaced with a different dog.
4. Council must be notified within 14 days if the number of dogs on the property reduces. The permit will be reviewed and amended to reflect the change.
5. Having more than the permitted number of dogs, or dogs other than those approved in the permit is a breach of conditions.
6. Permits are not transferable from property to property; therefore if you move to another property, you will need to apply for a new permit.
7. All dogs must be registered each financial year at all times.
8. All dogs must be microchipped - exemptions will not be issued unless evidence of this is provided.
9. All dogs born after July 2018 must be desexed - exemptions will not be issued unless evidence of this is provided.
10. Failure to actively address issues and or any breaches of these Terms and Conditions may result in cancellation of this permit and all additional dogs requiring relocation or surrender.
