

By-Law Determinations and Resolutions

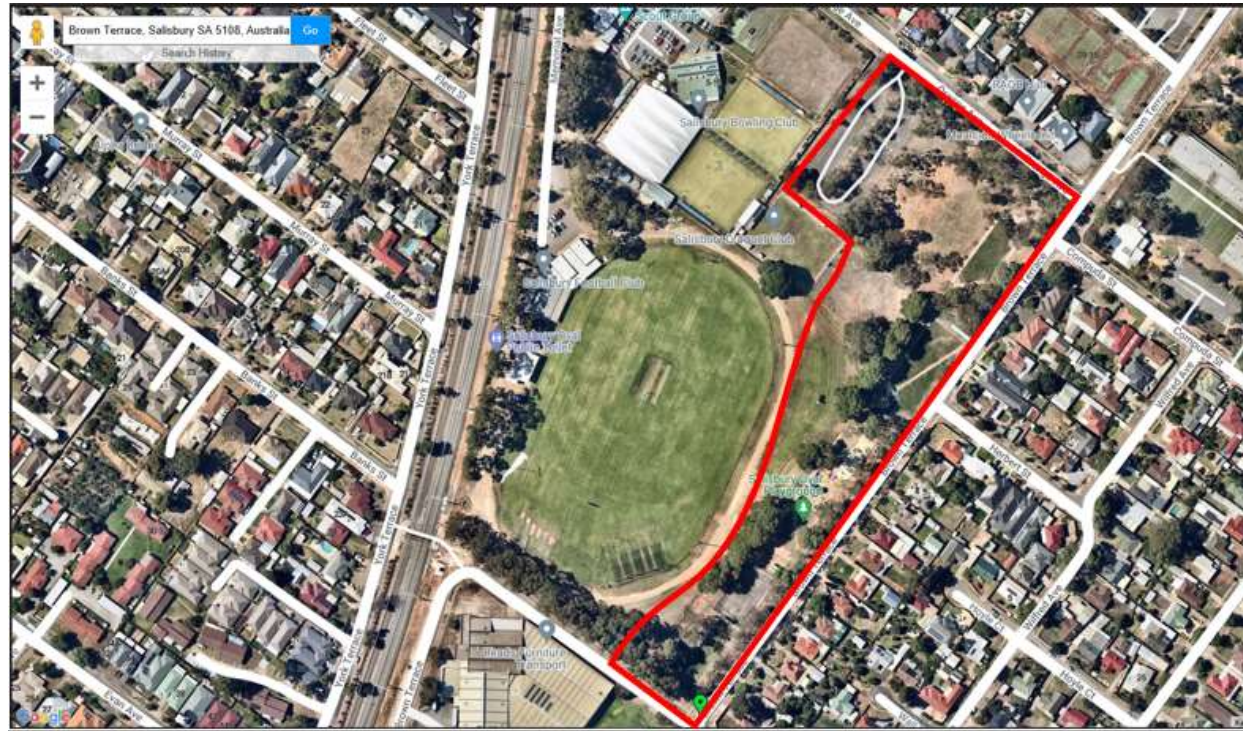
