2. REPORT

Resignations

2.1 Julie Ping tendered her resignation on 9 November 2016 as she has moved interstate.

End of membership term: Youth Member

- 2.2 Michael Santos will not be re-applying for a second term on youth council as he would like to concentrate on work and his studies.
- 2.3 Roshan Chamlagai will not be re-applying for a second term on youth council as he has decided to apply for a mentor position which will commence in 2017 if he is appointed.

End of membership term: Mentors

- 2.4 Danielle Stewart has completed her 2 year term as a mentor and has decided not to continue with Youth Council due to work and study commitments.
- 2.5 Kimberly Daniels, who had been sharing the mentor role representing Mission Australia with Danielle Stewart will now fulfil that role in a full time capacity.

New Members

- 2.6 The Terms of Reference provide that Youth Council membership consists of 18 youth members, 6 mentors and 3 Elected Members. A number of resignations from youth members throughout the year has resulted in low youth member numbers and difficulties in achieving a quorum for a meeting. Whilst ordinarily membership recruitment is conducted on an annual basis, a decision was taken to recruit new members to fill current vacancies so that a meeting of the Youth Council could be convened in December.
- 2.7 Following a recruitment process the new youth members are as follows:
 - Liam Bilsborow;
 - Braden Thompson; and
 - Teya Gribble

3. TERMS OF REFERENCE

- 3.1 In order to facilitate the maintenance of a quorum for the term of the Committee it is proposed that the Sub-Committee consider a change of the terms of reference relating to Membership Selection.
- 3.2 It is proposed that the relevant section of the Terms of reference be changed to the following;
 - **4.9 Membership Selection** Elections will be held annually for vacant committee positions, or as required to fill a casual a vacancy that arises during a term of appointment, for the balance of the remaining term.
- 3.3 This change will allow continuous replacement of Youth Council members as vacancies arise, and was a recommendation of the Youth Council Review.

1. BACKGROUND

- 1.1 At its February meeting, Council endorsed a youth-adult partnership model of community evaluation as the methodology to be used for the development of the new Youth Action Plan (YAP).
- 1.2 A number of working parties were formed under the banner of Diversity, Development, Active and Creative Lifestyles to facilitate information and engagement on the following areas of youth concern:
 - Diversity working parties: Lesbian, Gay, Bi-sexual, Trans, Intersex, and Questioning (LGBTIQ); and Culturally and Linguistically Diverse (CALD), both completed June 2016;
 - Development working parties: Health; and Education and Employment, both completed September 2016; and
 - Active and Creative Lifestyles (current), due to be completed December 2016.
- 1.3 Current working party membership is as follows:
 - Active Lifestyles (formerly Sports) Michael Santos, Cresilda Daitol, Mimona Abdalla, Nick Griguol, Taylor Sawtell, Cameron Rowe and Eric Ngirimana; and
 - Creative Lifestyles (formerly Arts) Bianca Bilsborow, Rebecca Etienne, Joel Winder, and Mark Verdini.

1.4 The following report provides a summary update on the works undertaken by the current Active and Creative lifestyles working groups.

2. CONSULTATION / COMMUNICATION

2.1 Internal

2.1.1 Youth Council member Nick Griguol has attended four meetings of the Internal Youth action Plan Project Team to represent Youth Council.

2.2 External

2.2.1 The Active Lifestyles and Creative Lifestyles working parties have various external consultations booked in for November and December and these consultations are detailed below.

3. REPORT

- 3.1 This report contains a summary update from the following working parties: Active Lifestyles and Creative Lifestyles. The Current working parties will ceace activities in late December.
- 3.2 The Creative Working Party:
 - Has partnered with Every Life Matters Salisbury Suicide Prevention Network to design mugs with positive sayings on them to be given out to people at events;
 - Will be running a mug making workshop at the Dec Youth Arts Christmas Market to be held in the Gallery on December 21.
- 3.3 The Active Lifestyles Working Party:
 - Will be running youth consultation sessions with sporting clubs and recreation centres within the City of Salisbury. These sessions will include (but not be limited to) the following clubs: the Pines football club, Ingle Farm Little Athletics club, Salisbury North football Club and the Gardens Rec Centre.

1. BACKGROUND

- 1.1 At its February 2016 meeting Council endorsed a youth-adult partnership model of community evaluation, as the methodology to be used for the development of the new Youth Action Plan (YAP).
- 1.2 The YAP is being developed via the Youth Council project team (which consists of Youth Council members), and a council project team (which consists of internal council staff). The internal council staff team consists of Nick Griguol who represents Youth Council on the council to assist with developing and strengthening youth-adult partnerships.
- 1.3 The YAP methodology includes a range of external consultations and responsibility for leading the various consultations is shared between Youth Council and council staff.
- 1.4 This report will provide an update of the works that have undertaken and planned activity by the project team.

2. CONSULTATION / COMMUNICATION

Internal

2.1 The YAP is a whole-of-council plan which supports the achievement of several key directions of the City Plan. The council project team has been established to reflect and represent the range of stakeholders in this project, including the Youth Council.

- 2.2 Since the previous status update report in August, three project team meetings and two project board meetings have been held.
- 2.3 The Community Planner, Youth has also met with:
 - Manager Business Systems and Solutions regarding placement opportunities for disengaged youth
 - Community Planning Project Officer and external stakeholders relevant to Aboriginal youth development to plan culturally competent consultations
 - Manager Twelve25 Salisbury Youth Enterprise Centre and Workskil Inc. place manager to plan a consultation workshop in partnership with Workskil Transition Centre
 - The Inclusion Project Officer and external stakeholders relevant to disability sector to plan an accessible and inclusive forum for young people living with disability; and
 - City of Salisbury employees, trainees and volunteers under 25 years of age to include their voices and feedback into the Youth Action Plan.
- 2.4 Project updates have also been presented to Council's Executive Group and at the November Informal Strategy meeting.

External

- 2.5 External youth consultations conducted in partnership with Youth Council since the August Youth Council Sub Committee meeting included:
 - Para Hills High School;
 - Salisbury High School;
 - Temple Christian College years 9-12 SRCs;
 - Paralowie R-12 year 12 Student Voice cohort;
 - Endeavour College;
 - Parafield Gardens High School;
 - Salisbury East High School;
 - Workskil Transition Centre;
 - Paralowie Youth Services; and
 - Workabout Centre.

3. REPORT

- 3.1. Youth Council members continue to enthusiastically undertake community consultations with youth in Salisbury.
- 3.2. The second Youth Council Project Team theme of 'Development' is complete.
- 3.3. The Development working groups conducted youth consultations in the areas of Health/Wellbeing and Education/Employment.
- 3.4. The third Youth Council Project Team theme of 'Active and Creative Lifestyles is underway.
- 3.5. Internal project team consultations have generated the following key ideas:
 - Holding a Youth Arts Market in December 2016;
 - Targeting consultations in sport and recreation centres;
 - Ways to engage with Aboriginal youth; and
 - Ways to engage with young people in the 19-25 age bracket.
- 3.6. Twelve25 have conducted numerous consultations with groups attending the centre.
- 3.7. Nick Griguol will continue to represent Youth Council on the council project team.
- 3.8. The Community Planner Youth and Nick Griguol presented a project update to the Executive Group on September 20.
- 3.9. Pizza and Pathways was held on September 23 at Twelve25. The purpose was to consult with young people not engaged in education, employment and training (NEET).
- 3.10. A forum for young people living with a disability was held on October 14 in the John Harvey Gallery in partnership with key external stakeholders, NDIS northern office, and Purple Orange, Julia Farr's youth participation team.
- 3.11. The Community Planner Youth attended a workshop with Elected Members at the Informal Strategy meeting on November 7.
- 3.12. At the time of writing this report, 1263 young people have now been directly consulted.
- 3.13. Upcoming consultations are booked for the Salvation Army youth group (The Rev); and numerous sporting clubs and recreation centres.
- 3.14. The YAP is due to be completed by April 2017.

1. BACKGROUND

- 1.1 National Youth week is celebrated across Australia as a unique opportunity for the community to recognize and celebrate the contribution of young people. It provides an opportunity for local youth to influence, plan and develop a significant community event. This contributes to our young people's wellbeing in our community.
- 1.2 National Youth Week 2016 was celebrated from 8 April to 17 April.
- 1.3 In 2016 Twelve25 and Youth Council hosted a major event being the Northern Youth Arts Market at the John Harvey Gallery in collaboration with the City of Tea Tree Gully.
- 1.4 Other activities included: An art exhibition in the John Harvey Gallery and The Mawson Centre, Movie Night, Comic Labs with Georgina Chadderton at the Len Beadell Library, Youth Arts Enterprise Bootcamp in Tea Tree Gully.
- 1.5 These activities were funded through the support of Office for Youth, City of Salisbury and City of Tea Tree Gully.

1.1 The staff from Twelve25 participates in the Youth Council Sub Committee Meetings to ensure a strong working relationship with the Youth Council.

2. CITY PLAN CRITICAL ACTION

3. REPORT

3.1 The report provides summary information about Twelve25 programs for the balance of 2016 and initial planning for 2017.

3.2 **Program Update:**

- 3.2.1 A Wheels in Motion Forum was held on Saturday 3rd September in the John Harvey Gallery. 70 young people from Playford and Salisbury attended.
- 3.2.2 The Beyond Racism program concluded for 10 participants on Thursday 8th September with a celebration dinner, jumpers provided to each participant, their recorded stories and guest speaker Basil Colman covering Aboriginal Culture & Emotional Healing. Feedback from all participants has been positive.
- 3.2.3 Salisbury Youth Performing Arts Group performed their written script to family and friends in September. Their next project is working on a script to perform to school groups in the Fringe Salisbury Secret Garden 2017.

- 3.2.4 The Parafield Gardens High School and Twelve25 Duke of Edinburgh program concluded the two term program with their four day Adventurous Journey at Seeonee Hills in the October School Holidays.
- 3.2.5 The documentary screening of Embrace was held on 14 October with support from City of Playford, Headspace, the Butterfly Foundation and the Salisbury Rotaract Club. The night was very well received with 70 people in the audience and \$117.00 raised from the door entry going to the Butterfly Foundation.
- 3.2.6 Twelve25, Salisbury Youth Council and Headspace celebrated the FEAST Festival in collaboration with an art competition and documentary screening. This was held on Friday 28th October with 40 people in attendance and five artists entering work into the art exhibition.
- 3.2.7 Swim Club for new arrival young people aged 12 -16 years commenced on 4 November at the Salisbury Pool. The first week had 30 young people attend and then only 10 for week 2 due to the inclement weather. This program is held weekly on Friday afternoons until December 16.
- 3.2.8 As a follow on from Swim Club, the young people will be invited to participate in a free two hour Surf Education Session on Tuesday 20th December at Semaphore beach with Surf Life Saving SA.
- 3.2.9 The latest project of the Jibba Jabba TV program was a gambling advert about poker machines which has received over 250,000 video views on Facebook. A new video project about healthy relationships and challenging stereotypes is currently underway. Jibba Jabba TV young people continue to produce a weekly youth news episode (Jibba Jabba News) and we are also now running a series of 5 movie review shows (Jibba Jabba @ the movies). On average over 2000 people watch a Jibba Jabba TV short video each week. Young people are also involved in a number of other short video projects.
- 3.2.10 The first Basic Car Maintenance Workshop was held on Saturday 12th November with 25 young people in attendance. This initiative is an addition to the Wheels in Motion Program and will be opened up to all young people in 2017. The workshop is three hours in duration and is delivered in conjunction with a young mechanic from Peter Kittle Toyota. Expression of Interest:
