1. BACKGROUND

- 1.1 At its meeting in February 2017, the Youth Council established two project teams and appointed project team leaders to undertake two projects during 2017, those projects being;
 - Safe City; and
 - Pathways and Opportunities
- 1.2 This report will provide an update on the work undertaken by the project teams. Team leaders will also provide an overview of the works undertaken to date at the meeting.

2. CONSULTATION / COMMUNICATION

2.1 Internal

2.1.1 The Project Teams were established and Project team leaders appointed at the February 2017 Youth Council sub-committee meeting. Membership of the project teams was included in the February Project Team report.

3. REPORT

Safe City

- 3.1 The aim of this project is to work with local agencies to host a community event providing young people with information and education about staying safe in their community.
- 3.2 This will be achieved through working in partnership with SAPOL and agencies that offer services to young people in the areas of (but not limited to) domestic violence, drugs and alcohol, homelessness and health and well-being.

Pathways and Opportunities

- 3.3 This project will focus on enhancing employability and networking skills for young people aged between twelve and twenty five years in the City of Salisbury.
- 3.4 One aspect of the project will be to host an employment expo focusing on skills of resume writing, cover letters, presentation and interview skills. Youth Council will partner with local job service providers and high schools to achieve a positive outcome for the young people who attend. This aspect of the projects focuses on 'job seekers'.
- 3.5 The second aspect of the project will be a "Shark Tank" working with local business owners to provide feedback for young people interested in starting a business and tips for those who already have market and Facebook businesses. This aspect of the project focuses on 'job makers'.

4. CONCLUSION / PROPOSAL

- 4.1 Project Teams provide the opportunity for Youth council members to plan, develop and implement key projects that address issues of importance to young people in Salisbury.

1. BACKGROUND

- 1.1 At its February 2016 meeting Council endorsed a Youth-Adult Partnership model of community evaluation as the methodology to be used for the development of the new Youth Action Plan (YAP).
- 1.2 The YAP has been developed via the Youth Council project team (which consists of Youth Council members), and a council project team (which consists of internal council staff). Nick Griguol who represents Youth Council also works with the internal council staff team to assist with developing and strengthening Youth-Adult Partnerships.
- 1.3 The YAP methodology has included a range of external consultations and responsibility for leading the various consultations has been shared between Youth Council and council staff.
- 1.4 This report will provide a summary of the works that have been undertaken and an update on the status of the YAP.

1. CONSULTATION / COMMUNICATION

- 1.1 Internal consultation and communication has occurred throughout the development of the updated Plan with:
 - Twelve 25 Youth Enterprise Centre, manager, staff and volunteers
 - Community Development staff
 - Youth Action Plan project team (comprised of representatives from various council departments)

- Youth Action Plan project board
- City of Salisbury youth workforce
- 1.2 External consultation and communication has occurred throughout the project with:
 - 1551 young people
 - 156 youth service providers
 - 29 teachers and school executive staff
 - 10 secondary school campuses
 - Various community groups, services and program coordinators (full details are contained in the attached Engagement Report)

2. REPORT

- 2.1 Community consultations were completed in February 2017, on time and within allocated resources.
- 2.2 The original target of 1500 participants was exceeded, 1551 young people were ultimately engaged in face-to-face conversations.
- 2.3 A draft of the Youth Action Plan and comprehensive Engagement Report was prepared during February-March 2017.
- 2.4 A draft report containing the draft Youth Action Plan and Engagement Report is currently undergoing internal review.

3. CONCLUSION / PROPOSAL

3.1 A further update will be provided at the next Youth Council Sub Committee meeting in June 2017.

1. BACKGROUND

1.1 The staff from Twelve25 participate in the Youth Council Sub Committee Meetings to ensure a strong working relationship with the Youth Council.

2. CITY PLAN CRITICAL ACTION

2.1 N/A

3. REPORT

- 3.1 The report provides Youth Council members with an update and information on previous and upcoming programs and activities.
- 3.2 Twelve25 continues to support driving programs which build skill development and lead to employability. The Wheels in Motion program held a Road Safety Forum on Saturday 18th March attended by 60 Salisbury and Playford young people. Getting your L's course (at Twelve25 but in partnership with Bagster Road Community Centre) recently ran on 20th and 21st of March with the test on 24th March. The 7 young people who sat the test all passed.
- 3.3 National Youth Week was celebrated across Australia from 31 March 9 April. Salisbury celebrated with a market, gift tag making workshop and exhibition. Twelve25 and the Salisbury Youth Council worked in conjunction with the City of Tea Tree Gully to host a Youth Arts Market on Saturday 1st April at the Tea Tree Gully Library. There were over twenty stalls holders and airbrush tattoos, coffee and pizza were provided by Twelve25's youth social enterprise programs. The Salisbury Youth Council hosted a stall promoting their projects and supporting Every Life Matters Salisbury Suicide Prevention Network through a

- mug making activity. Young people's art work was displayed in the Len Beadell Library 31 March 9 April with an opening night on Monday 3rd April with MCing and prizes being awarded by Youth Council members.
- 3.4 The third LAN Esports Tournament was held on Friday 31st March. The game for this tournament was Rocket League and the workshop was delivered by OPAL, highlighting the impact sugar and caffeine has on your body. Planning is underway for an April tournament.
- 3.5 The Pizza Gioventu youth social enterprise participants took the pizza trailer to their first major event for the Salisbury Secret Garden in Civic Square and sold over 200 pizzas.
- 3.6 The Coffee Connoisseurs youth social enterprise program has now started providing coffees at Carisbrooke Park on Saturday and Sunday's, from 9:30am-1pm.
- 3.7 Twelve25 is again supporting a Certificate III in Community Services training program. The new group has eighteen students and started on Monday 3 April.
- 3.8 Twelve25 continues to facilitate the Salisbury Youth Services Network (a professional network of workers delivering frontline youth services in Salisbury and the northern suburbs). We have recently facilitated a 2 day Youth Mental Health First Aid Course for 25 workers and a professional development session on 6th April looking at Youth Sexual Health (delivered by ShineSA). The next professional development session is on 29th May and looks at the topic 'how to engage with disengaged youth' and has a speaker from Operation Finders. Continued support of this sector network aims to support a strong, informed and well connected youth service sector in Salisbury.
- 3.9 A Twelve25 Airbrush Tattoo Operator will be at the Connect2U Community Day on Thursday 27 April. There are a variety of activities being provided at Lake Windermere B-7 School from 10am 2pm. This is a free event.
- 3.10 Twelve25's School Based Trainee Reece has coordinated a school holiday activity of Go Karting and Laser Tag for Thursday 27 April. For more details and bookings: http://e.mybookingmanager.com/karts
- 3.11 A Basic Car Maintenance Workshop delivered by a mechanic from Peter Kittle Toyota is being held on Saturday 29th April. For more details and bookings: http://e.mybookingmanager.com/BCMApril2017
- 3.12 Parafield Gardens High School and Twelve25 will again deliver the Duke of Edinburgh program to students on Monday nights. Participants of the Bronze Award will receive their First Aid Certificate and Gold/Silver Awardees will develop skills in cooking by providing weekly dinner and fundraising. The program will run over term two and three and finish with an Adventurous Journey.
- 3.13 Twelve25 is supporting the Rotary Club of Salisbury to host Rotary Youth Driver Awareness Program (RYDA) on 25 May. One hundred and fifty year 10 and 11 students from Thomas More College will attend the one day out of school program learning practical road safety information.

- 3.14 Twelve25 is hosting a screening of The Sapphires during NAIDOC Week. The event is being held on Friday 7 July, 7pm, free entry with light refreshments. For more information and bookings: http://e.mybookingmanager.com/thesapphires
- 3.15 The partnership between Australia Refugee's Association and Twelve25 continues to grow with a second afternoon (now Mondays and Thursdays 4pm-6pm) of Homework Help for CALD students now being based at the centre and a specific CALD art program on Tuesdays (4pm 6pm). Attendance has been strong at homework help following the ceasing of the Smith Family Homework help in Library.
