1. BACKGROUND

1.1 Youth Council Terms of Reference states that for Membership Selection (4.9) that:

Appointments will be held annually for vacant committee positions, or as required to fill a casual vacancy that arises during the term of appointment, for the balance of the remaining term.

1.2 In June 2017, Youth Council mentor Andrew Chapman, stated his intention to resign from Youth Council, which was accepted and subsequently a mentor position became vacant.

3. REPORT

3.1 In July 2017 David Waylen expressed an interest in a mentor position on Youth Council. David was interviewed as a potential mentor for Youth Council by Julie Brett and two Youth Council members. David was informed that there was no current vacancy; however he would be considered and invited to formally apply when a mentor position became available.

- 3.2 Youth Council mentor, Andrew Chapman tendered his written resignation in July 2017. This notification of resignation was included on the August subcommittee agenda and accepted by Policy and Planning Committee Meeting on 21 August 2017.
- 3.3 David was provided with an application form for mentor membership after his initial interview and the resignation of Andrew Chapman.
- 3.4 With regard to his suitability for a mentor position on the Youth Council, David Waylen brings a vast knowledge of working within the community across all ages. These roles include volunteer management and mentoring. He has worked across areas of sport and recreation, the arts, education and business development. He is a keen supporter of the Adult/Youth partnership model.

4. CONCLUSION / PROPOSAL

- 4.1 The application received from David Waylen for a mentor role on Youth Council has been has completed through a formal process of written application and an interview.

Safe City Project Team update – Joel Winder, Project Team Leader.

The Safe City Project team has been working in partnership with three local young people in the community to host a fundraiser event in memory of Luke Morris who was a Jibba Jabba Radio participant and who was also known by many young people in the local community, the fundraiser which has been titled: "R U Ok? Stand Together to Make a Change" will be held on R U OK Day, Thursday September 14th at Twelve25 Salisbury Youth Enterprise Centre, we have also collaborated with Twelve25 for this event.

Six performers have donated their time to the event and the event will also be supported by Every Life Matters Salisbury Suicide Prevention Network and Headspace

The event will include: performances, badge making, mug making and guest speakers. All proceeds will be donated to Beyond Blue

The Safe City team had also planned to host an event on Friday the 13th of October, the working title of the event was 'Safe City Civic Square Event' upon receiving a unanimous vote from all project team members and with also reviewing the 2016 consultations and the low feedback we have had from service providers we have decided to alter outcome for the project team and cancel the event in favor of a Social Media campaign through the Youth in Salisbury Facebook page, this campaign will select a topic once a week with posts in regards to Mental Health, LGBTI support services, Homelessness support and Domestic Violence support services available to young people in the northern suburbs. By utilizing our online presence it will give us a far greater long term outreach to young people in the community rather than hosting a limited small temporary event, this will also allow us to make better use of our budget and resources.

1. BACKGROUND

- 1.1 National Youth Week has been previously celebrated across Australia as a unique opportunity for the community to recognise and celebrate the contribution of young people. It provides an opportunity for local youth to influence, plan and develop a significant community event. This contributes to our young people's wellbeing in our community.
- 1.2 In the 2015-16 federal budget, the Australian Government reduced funding for National Youth Week in South Australia.
- 1.3 As the largest annual celebration of young people in Australia, the State Government of South Australia will continue to support Youth Week. Youth Week is an opportunity for all South Australians to recognise the positive contributions that young people make to our community, as well as a chance for young people to make their voices heard on the issues they care about.
- 1.4 Therefore, National Youth Week will officially become SA Youth Week as of 2018.
- 1.5 To minimise changes to the scope of SA Youth Week, the Department for Communities and Social Inclusion will provide an additional \$10,000 to the current National Youth Week allocation of \$90,000. This total funding pool of \$100,000 will then be distributed in the form of grants, as has been the case in previous years.

- 1.6 Applications for SA Youth Week grants will open on 21 August 2017 and close on 22 September 2017. Grants of up to \$1,500 will be available for individual organisations, up to \$3,000 for collaborative events involving two or more organisations, and up to \$5,000 to host a State launch.
- 1.7 While a funding shortfall of \$30,000 remains in the absence of Australian Government funding, they propose to minimise the impact of this by discontinuing provision of State Government funded SA Youth Week merchandise. In all other respects, SA Youth Week will take place as it has in previous years, including a commitment to involving young people in the planning and development of activities and events.
- 1.8 In 2016, Twelve25, Salisbury Youth Council and City of Tea Tree Gully hosted a Youth Arts Market at the John Harvey Gallery in Salisbury. In 2017, Twelve25, Salisbury Youth Council and City of Tea Tree Gully hosted a Youth Arts Market at the Tea Tree Gully Library. A youth art exhibition was also held at the Len Beadell Library.
- 1.9 The 2017 activities were funded through the support of City of Salisbury and City of Tea Tree Gully. As the market was in their area, the City of Tea Tree Gully applied for Office for Youth funding in 2017 and was not successful.

2. CITY PLAN CRITICAL ACTION

2.1 N/A

3. REPORT

- 3.1 SA Youth Week will be held from 13 22 April 2018 with the theme of Your Future Your Way.
 - 3.1.1 In preparation for the 2018 SA Youth Week, a review and analysis of the Youth Arts Market 2017 was conducted. This review identified that there were many benefits in partnering with City of Tea Tree Gully including increased participation from both stall holders and overall participation in the event.
 - 3.1.2 The focus on youth social enterprise at the Youth Arts Market 2017 was successful and provided broader exposure to the existing Salisbury youth enterprise initiatives, Pizza Gioventu and Coffee Connoisseurs. It further developed youth enterprise opportunities for other new youth stall holders.
 - 3.1.3 Based on these successful outcomes and positive feedback from 2017, there is an opportunity for City of Salisbury and City of Tea Tree Gully to partner for another youth arts market during Youth Week 2018. It is proposed that for 2018 City of Salisbury host the youth arts market at the Len Beadell Library and that City of Tea Tree Gully host an 'enterprise boot camp' at Tea Tree Gully before the youth arts market.

- 3.1.4 As the grant application for this proposal was 22 September 2017, an expression of interest was put to Youth Council members to join a working party to progress youth arts market event for Youth Week 2018. This working party members consist of City of Salisbury and City of Tea Tree Gully staff, volunteers and members from Salisbury Youth Council and Tea Tree Gully Youth Advisory Committee.
- 3.1.5 The working party met on 8 September 2017 to commence initial planning of the Youth Arts Market and to formulate an application for grant funding from the Office for Youth.

4. CONCLUSION / PROPOSAL

- 4.1 That Twelve25 (as per previous years) coordinate an application for grant funding from the Office for Youth in order to work collaboratively with Youth Council and to partner with the City of Tea Tree Gully to fund an initiative for SA Youth Week 2018.
- 4.2 Twelve25, Salisbury Youth Council and City of Tea Tree Gully partner to plan and host a Youth Arts Market at Len Beadell Library in Salisbury, and an 'enterprise boot camp' at Tea Tree Gully for SA Youth Week 2018.

1. BACKGROUND

1.1 The staff from Twelve25 participate in the Youth Council Sub Committee Meetings to ensure a strong working relationship with Youth Council.

2. CITY PLAN CRITICAL ACTION

2.1 N/A

3. REPORT

- 3.1 The report provides Youth Council members with an update and information on past and upcoming programs and activities.
 - 3.1.1 Wheels in Motion @ Bagster program for over 26 year olds hosted a road safety forum on 9 August 2017. Thirty one people (nine were youth participants to join Twelve25's program) attended with the first driving sessions commencing on 30 August 2017.
 - 3.1.2 Basic Car Maintenance Workshop delivered by a mechanic from Peter Kittle Toyota was held on 19 August 2017, with fifteen youth participants attending and three volunteers assisting. Participants were taught how to change a tyre, check tyre pressure, jump start a car and check oil and water levels.

- 3.1.3 Twelve25 and Incompro have formed a new partnership to deliver the Wheels in Motion Getting Your Ps for Incompro's youth Aboriginal clients. An Aboriginal mentor driver has been engaged as a City of Salisbury volunteer to drive with young people on Tuesday afternoons. These sessions will start and finish at Incompro in Salisbury North. The first road safety forum was held on 13 September 2017. To date, eighteen young people have expressed interest to attend the forum.
- 3.1.4 Youth Tutoring one hour sessions on Tuesdays, Thursdays and Fridays have grown with seven of eight timeslots filled, facilitated by three active tutors and six young people. Students are years 9-12 and require tutoring assistance in math's, english, physics, biology, chemistry and research.
- 3.1.5 A new initiative of Youth Employment Family Conversations has started on Thursday afternoons with an employment mentor/youth worker. This program builds on a family's structure and support to help move a young person from unemployment through to employment. Parents and guardians of a young person aged 17 -25 years book a 1 hour 'family conversation' with the specialist mentor. The purpose of the initiative is to involve family members to provide support to the young person to and understand the employment options. More information can be found at: https://youthemploymentfamilyconversations.eventbrite.com.au.

As an addition to this, a series of weekly employment resources (what job suits you, cover letters, interview preparation, career pathways, career sector trend check) have been shared on the Youth in Salisbury Facebook Page. The employment series posts have appeared in local young people's feed over 45,000 times, 2255 times young people engaged in the topic (comments / shares / linking others). To date, 716 people clicked through to the employment resource we highlighted.

- 3.1.6 Twelve25 and Salisbury Youth Council are providing a free sausage sizzle at the Salisbury North Skate Park on 5 October 2017, 11am 1pm as a School Holiday Activity. Other activities include basketball challenges and music.
- 3.1.7 Northern Adelaide Senior Colleges Academy, Gaming Film & Animation (AGFA) teachers and participants are hosting the second Gaming Day as a school holiday activity on 12 October 2017, 10:30am 4:30pm. More information can be found at: https://gamingdayoct.eventbrite.com.au.

- 3.1.9 The next Gaining Your L's, 2 day workshop and test delivered by Bagster Road Community Centres trainers & assessors will be held at Twelve25 on 30 and 31 October 2017 and test 3 October 2017. Expressions of interest at: <u>http://e.mybookingmanager.com/gettinglsEOI2017</u> to then receive the booking link for next workshop dates.
- 3.1.10 Twelve25 and Parafield Gardens High School Duke of Edinburgh program's twenty five awardees had their last weekly Monday afternoon session on 25 September 2017. The Adventurous Journey component of the award is being held 9 13 October 2017 at Emmaus Campsite, Halbury. A program celebration will be held late October/early November 2017 for the participants to receive their awards.
- 3.1.11 Five young people completed the Coffee Connoisseurs training at the end of August 2017 and are now approved operators. Coffee Connoisseurs continue to operate at Carisbrooke Park (weather permitting) on Saturday's and Sunday's as well at other events such as Carisbrooke Park Classic, Together SA Community Event at The Stretton Centre, Burton Community Centre Market, Every Life Matters - Salisbury Suicide Prevention Network Official Launch, R U OK? Let's Stand Together Youth Band Event, All Sorts Shed and Salisbury Plays - Bridgestone Reserve.
- 3.1.12 Event bookings for the Pizza Gioventù wood oven pizza trailer are starting to pick up with operators making pizzas at the Lake Windermere Schools Father's Day Event and Salisbury Food and Cultural Festival.
- 3.1.13 Airbrush Tattoo Operators and a youth DJ will be supporting some events at the Salisbury Recreation Precinct including the Open Day and Swim School Christmas Party. This may also continue with two or three events in the New Year.
- 3.1.14 Salisbury Esports Tournament date changed from 2 September to 16 September 2017, with the games being Rocket League and FIFA. The working party consisting of Twelve25 youth volunteers, Academy Gaming Film Animation (AGFA) Esports participants and staff from Twelve25 & Northern Adelaide Senior College have planned future tournament dates of 25 November, 8 December 2017 and 19 January 2018.
- 3.1.15 Twelve25, Salisbury Youth Council & Volunteer Services are hosting interactive information stalls at Salisbury High School 18 October 2017 and Salisbury East High School's 26 October 2017 Wellbeing Days.
