  - 3.4.5 To create an awareness of, and value, for Australia's heritage
  - 3.4.6 To promote the observance and celebration of Australia Day
  - 3.4.7 To make recommendations to and advise the Australian Government on all matters relating to the above objects
- 3.5 LGA nominations on outside bodies will, unless determined otherwise by the LGA Board of Directors, be currently serving council members or council staff.
- 3.6 The LGA nominated person previously on the Council is not eligible for re-appointment.
- 3.7 Nominations addressing the Selection Criteria provided in Part A (attached) for the Australia Day Council of SA Board of Management must be forwarded to [lgasa@lga.sa.gov.au](mailto:lgasa@lga.sa.gov.au) by a council using the Part B form (attached) along with an up-to-date CV/resume by COB Tuesday 16 July 2019.

### A - PREAMBLE

#### Power to Make Orders

1. The *Local Government Act 1999* requires the Council to prepare and adopt a policy for the operation of its order-making power. The policy is subject to public consultation, review and evaluation.
2. This Policy will apply to the matters set out in the *Local Government Act 1999* including:
  - a. Section 254 which empowers the Council to order a person to do or refrain from doing a thing under certain circumstances, namely:
    - i. Prevent or eliminate hazards on lands adjoining a public place
    - ii. Prevent the inappropriate use of vehicle (as a place of habitation).
  - b. Section 216 which empowers the Council to order the owner of a private road to carry out specified roadwork to repair or improve the road.
  - c. Section 218 which empowers the Council to order the owner of adjoining land to carry out specified work to construct, remove or repair a crossing place from the road to the land.
3. This Policy does not apply to other circumstances provided for in the *Local Government Act 1999* and other South Australian Legislation that specifically empower the Council to make orders, when appropriate and as the need arises.
4. The exercise of the Council's order-making power, in accordance with this Policy and relevant statutes, co-exists with the Council's other regulatory powers. For example, the Council has power to make and enforce by-laws in certain circumstances and to enforce compliance with the requirements of the *Local Government Act 1999* and a range of other legislation.
5. This policy is also to be read in conjunction with Councils Enforcement Policy.

**B - SCOPE**

1. This policy applies to all owners or occupiers of lands within the City of Salisbury Council boundaries.

***Matters to Which Policy Applies***

1. The matters to which this Policy applies are set out in Section 254 and Section 216 and 218 of the *Local Government Act 1999*.

**Section 254:**

2. The following table is an extract from the Act. The matters are stated in general terms with particular examples for illustration. These examples are not intended to be an exhaustive list of the circumstances in which the Policy will apply. They are included to assist the community to understand the purpose and intent of this Policy and the way in which it will be applied.

**Section 254 Power to make orders, states:**

**254.** A council may order a person to do or to refrain from doing a thing specified in Column 1 of the following table if in the opinion of the council the circumstances specified opposite it in Column 2 of the table exist and the person comes within the description opposite it in Column 3 of the table.

Column 1 To do or to refrain from doing what?	Column 2 In what circumstances?	Column 3 To whom?
1. Hazards on lands adjoining a public place		
(1) To fence, empty, drain fill or cover land (including land on which there is a building or other structure).	(1) A hazard exists that is, or is likely to become, a danger to the public.	(1) The owner or occupier of the land.
(2) To remove overgrown vegetation, cut back overhanging branches, or to remove a tree.	(2) The vegetation, branches or tree create, or are likely to create, danger or difficulty to persons using a public place.	(2) The owner or occupier of the land.
(3) To remove or modify a flag or banner, a flagpole or sign, or similar object or structure that intrudes into a public place.	(3) The relevant object or structure creates, or is likely to create, danger or difficulty to persons using a public place.	(3) The owner or occupier of the land.
(4) Where the public place is a road to take action necessary to protect the road or to remove a hazard to road users. Examples (1) To fill an excavation, or to prevent drainage of water across the road. (2) To construct a retaining wall or to remove or modify a fence. (3) To fence land to prevent the escape of animals. (4) To remove a structure or vegetation near an intersection.	(4) A situation exists that is causing, or is likely to cause, damage to the road or a hazard to road users.	(4) The owner or occupier of the land.

This policy sets out the matters about which orders will be made. The relevant principles, procedures and penalties that will be applied are also set out in this policy.

## D - DEFINITIONS

1. "The Act" means the Local Government Act 1999

## E - POLICY STATEMENT

### Principles

1. The Council will apply the following principles in the exercise of its powers to make orders:
2. In each situation in which the Council is considering making an order to require a person to act or to refrain from acting, within its powers to do so, the Council will investigate and consider (to the extent that is relevant and necessary) the following circumstances:

- The severity of the incident or circumstance;
- The hazard or danger posed to the community;
- The risk to health and safety of the community;
- Detraction from the amenity of the locality;
- The number of occurrences of the activity or incident;
- The impact of any previous actions to deal with the activity or incident;
- The significance of the breach, any other public interest or wellbeing considerations;
- The availability of a more appropriate response by the Council.

### **Procedures to be followed**

1. The procedures to be followed in the issuing an order must be in accordance with the requirements of Section 255 of the Act. Before making an order, unless the circumstances are urgent, the Council will take the following actions:
2. Give the person to whom an order is intended to be directed a notice in writing stating the:
  - Proposed action;
  - Terms of the proposed order;
  - Period within which compliance with the order would be required;
  - Reasons for the proposed order;
  - Invite the person notified to make representations, within a specified time, as to why the penalties for non-compliance;
  - Penalties for non-compliance.
3. The Council will take reasonable steps, within available resources, to resolve cases requiring an order by negotiation and agreement before issuing an order, except in cases of threat to life, an immediate threat to public health or safety or an emergency situation.
4. Where notice of a proposed order has been given to a person who is not the owner of the relevant land, the Council must take reasonable steps to serve a copy of the notice on the owner of the land.
5. After considering the representations made by the person to whom notice of the order is directed, the Council may
  - make an order in terms of the original proposal or
  - a modification of the original proposal or
  - Determine not to proceed with making an order.
  - the council is not required to give notice of an order with modifications
6. Upon issuing an order the Council may:
  - include two or more orders in the same instrument, or
  - direct two or more persons to do something specified in the order jointly
7. An order that is issued must:
  - specify a reasonable period within which the order must be complied with, and
  - state the reasons for the order.
8. An order must be served by the Council on the person to whom it is addressed. If the person to whom the notice and order are addressed is not the owner of the land, the Council must take reasonable steps to serve a copy of the notice and order on the owner of the land.
9. Service of orders is subject to the requirements of the Local Government Act Section 279— Service of documents by councils etc.
10. If the land is owned or occupied by more than one person, the order is not invalid merely because:
  - It is not directed to all the owners, and



- an owner or occupier who complies with an order may recover a fair contribution from the other owners or occupiers
11. The Council may at the request or agreement of the person to whom the order is directed, vary any order or may on its own initiative, revoke an order if satisfied it is appropriate to do so.
  12. If the Council in particular case considers:
    - An activity constitutes or is likely to constitute a threat to life or public health or safety, or
    - An emergency situation exists,
    - It may
    - Proceed to make an order without giving notice, and
    - Require immediate compliance with the order.

### **Rights of Review**

1. In accordance with Section 256 of the Act an order must include a statement setting out the rights of review. The review process includes:
  - The person to whom an order is directed may within 14 days after service of the order, seek a review of the order by SACAT under section 34 of the *South Australian Civil and Administrative Tribunal Act 2013*
  - The operation of an order continues pending the determination of an application for review, unless the South Australian Civil and Administrative Tribunal, or Council makes an interim order suspending the operation of the order; The South Australian Civil and Administrative Tribunal may, if on an application for review, affirm, vary, or set aside the order..
  - Council also has the ability to vary or revoke the order if satisfied that it is appropriate to do so;
  - If the order is not complied with within the time fixed for compliance or, if relevant, within 14 days after the completion of any review, then the council may—
    - take the action required by the order (subject to the outcome of any review); and
    - (ii) recover the reasonable costs and expenses incurred by the council in taking that action from a person who fails to comply with the requirements of the order.

### **Action on Non-Compliance with an Order**

1. Section 257 of the Act provides details of action to be taken in the case of non compliance of the order.
2. If the requirements of an order are not complied with in the time fixed for compliance or, if there is an application for review, within 14 days after the determination of the review, the council may (subject to the outcome of any review) take the action required by the order.
3. The Council or an employee of Council or another person authorized by Council, may, if the requirements of an order are not complied with within the time specified in the order, carry out the requirements of an order.
4. The reasonable costs and expenses of the Council in carrying out the requirements of an order may be recovered by the Council from the person who failed to comply with the order as a debt.
5. Where an amount is recoverable from a person by the Council, the Council may give that person notice in writing to pay the amount within no less than 28 days from the date of the notice.

6. If the person fails to pay the amount that person is liable to pay interest and, if the person is the owner of the land to which the order relates, the Council may impose a charge on the land for the unpaid amount and interest.
7. No civil liability attaches to a council, an employee of a council, or a person acting under the authority of a council, for anything done by the council, employee, or person under this section.

**Penalties**

1. Non-compliance with an order of the Council will constitute a breach of Section 258 of the Act and a person may incur statutory penalties provided for in the Act. The maximum penalty is \$2500 and the Expiation fee is \$210.
2. All orders of the Council will include the specific statutory penalty relevant to a breach of that particular order, and will advise of any applicable appeal rights.

**Council Endorsement of the Policy**

1. Any amendment or alteration to the Policy or a substitution of a new Policy is subject to public consultation provisions in Section 259(2) of the Local Government Act 1999. Council must, before adopting an amendment to a policy, commence public consultation unless the Council determines that the amendment is of only minor significance.

**Availability of the Policy**

1. This Policy will be available for inspection at the Council's principal office during ordinary business hours. Copies will also be provided to interested members of the community upon request, and upon payment of such fee (if any) as the Council may, in its discretion, fix.

## ATTACHMENTS

### **Attachment A: Guideline for the Operation of Section 254 of the Local Government Act 1999**

#### ***Pertaining to the “Inappropriate use of a Vehicle”***

The Council may make orders directed to an owner or occupier of land or a person apparently occupying a caravan or vehicle, which is used, as a place of habitation, to refrain from using the caravan or vehicle as a place of habitation if the following circumstances exist:

- Where use of a caravan or vehicle for habitation presents a risk to the health and safety of an occupant;
- Use of the vehicle as habitation causes a threat of damage to the environment;
- Use of the vehicle as habitation detracts significantly from the amenity of the locality.

Council has developed a list of guidelines that can be used by residents to assess their compliance with the above circumstances.

#### ***Where use of a caravan or vehicle for habitation presents a risk to the health and safety of an occupant***

- Caravans or vehicles used for habitation must be of a suitable standard with regards to, structural soundness, cleanliness and hygiene.
- The caravan or vehicles, walls, ceiling and floors must be constructed of adequate and sound materials, and be weatherproofed.
- There has to be adequate provision for lighting and natural ventilation.
- The fixtures, fittings and furniture must be clean and sanitary.
- Connections to a mains power supply must be in accordance with the provisions of the relevant power authority.
- The number of occupants must not exceed the recommended capacity of the van
- Adequate sanitary facilities and ablution facilities (toilet and shower) must be provided for the occupant.

Please note that the sanitary facilities and ablution facilities on the caravan or vehicle must not be used unless adequately connected to sewer. (Approval may be required for this)

#### ***Use of the vehicle as habitation causes a threat of damage to the environment***

- Areas of concern may include any impact on the environment including, air, water, soil or noise pollution, including;
- The improper discharge of solid or liquid wastes from the caravan or vehicle
- The emission of any offensive materials or odours from the caravan or vehicle
- The emission of excessive noise from the caravan or vehicle, or occupants

#### ***Use of the vehicle as habitation detracts significantly from the amenity of the locality.***

- Areas of concern that could be considered to detract significantly from the amenity of the locality, include:
  - Locating the caravan or vehicle in the front yard
  - Locating the caravan or vehicle up against a neighbouring fence, (a minimum distance of 600mm should be maintained between the caravan and fence, or 900mm if there is a window in the caravan that faces the neighbouring property.
  - An unsightly appearance of the caravan or vehicle
  -

- Note: Some allotments may not be suitable to accommodate a caravan or vehicle due to the size and shape.

***Development Controls***

In situations where;

- Occupancy of a caravan or vehicle for a period of greater than 12 months, or
- Where the subject land does not presently contain a lawfully habitable dwelling,
- Formal Development Approval is required from the Council

***Other Provisions***

The above examples are not to be considered to be absolute. Council may take other things into consideration when investigating an “Inappropriate use of a vehicle”. Each assessment will take into consideration relevant local factors and circumstances.

### A - PREAMBLE

#### Power to Make Orders

For example, the Council has power to make and enforce by-laws in certain circumstances and to enforce compliance with the requirements of the *Local Government Act 1999* and a range of other legislation.
5. This policy is also to be read in conjunction with Councils Enforcement Policy.

**B - SCOPE**

1. This policy applies to all owners or occupiers of lands within the City of Salisbury Council boundaries.

***Matters to Which Policy Applies***

1. The matters to which this Policy applies are set out in Section 254 and Section 216 and 218 of the *Local Government Act 1999*.

### **Attachment A: Guideline for the Operation of Section 254 of the Local Government Act 1999**

#### ***Pertaining to the “Inappropriate use of a Vehicle”***

The Council may make orders directed to an owner or occupier of land or a person apparently occupying a caravan or vehicle, which is used, as a place of habitation, to refrain from using the caravan or vehicle as a place of habitation if the following circumstances exist:

- Where use of a caravan or vehicle for habitation presents a risk to the health and safety of an occupant;
- Use of the vehicle as habitation causes a threat of damage to the environment;
- Use of the vehicle as habitation detracts significantly from the amenity of the locality.

Council has developed a list of guidelines that can be used by residents to assess their compliance with the above circumstances.

#### ***Where use of a caravan or vehicle for habitation presents a risk to the health and safety of an occupant***

- Caravans or vehicles used for habitation must be of a suitable standard with regards to, structural soundness, cleanliness and hygiene.
- The caravan or vehicles, walls, ceiling and floors must be constructed of adequate and sound materials, and be weatherproofed.
- There has to be adequate provision for lighting and natural ventilation.
- The fixtures, fittings and furniture must be clean and sanitary.
- Connections to a mains power supply must be in accordance with the provisions of the relevant power authority.
- The number of occupants must not exceed the recommended capacity of the van
- Adequate sanitary facilities and ablution facilities (toilet and shower) must be provided for the occupant.

Please note that the sanitary facilities and ablution facilities on the caravan or vehicle must not be used unless adequately connected to sewer. (Approval may be required for this)

#### ***Use of the vehicle as habitation causes a threat of damage to the environment***

- Areas of concern may include any impact on the environment including, air, water, soil or noise pollution, including;
- The improper discharge of solid or liquid wastes from the caravan or vehicle
- The emission of any offensive materials or odours from the caravan or vehicle
- The emission of excessive noise from the caravan or vehicle, or occupants

#### ***Use of the vehicle as habitation detracts significantly from the amenity of the locality.***

- Areas of concern that could be considered to detract significantly from the amenity of the locality, include:
  - Locating the caravan or vehicle in the front yard
  - Locating the caravan or vehicle up against a neighbouring fence, (a minimum distance of 600mm should be maintained between the caravan and fence, or 900mm if there is a window in the caravan that faces the neighbouring property.
  - An unsightly appearance of the caravan or vehicle

- Note: Some allotments may not be suitable to accommodate a caravan or vehicle due to the size and shape.

### ***Development Controls***

In situations where;

- Occupancy of a caravan or vehicle for a period of greater than 12 months, or
- Where the subject land does not presently contain a lawfully habitable dwelling,
- Formal Development Approval is required from the Council

### ***Other Provisions***

The above examples are not to be considered to be absolute. Council may take other things into consideration when investigating an “Inappropriate use of a vehicle”. Each assessment will take into consideration relevant local factors and circumstances.

## 1. BACKGROUND

- 1.1 Section 44 of the *Local Government Act 1999* provides Council may delegate a power or function vested or conferred upon by the *Local Government Act 1999* or another Act. Such powers and functions may be further delegated by the person occupying the office of Chief Executive Officer in accordance with Sections 44 and 101 of the *Local Government Act 1999* as the Chief Executive Officer sees fit. A delegation made pursuant to Section 44 of the *Local Government Act 1999* is revocable at will and does not prevent the Council from acting in a matter.
- 1.2 Councils have certain duties which they must perform, and certain powers which they may exercise, pursuant to the Local Government Act 1999 (the Act), as well as a range of other Acts. In most cases the relevant Acts grant those obligations and powers directly on the Council as a body.
- 1.3 Delegations are the way in which Council enables other people/bodies (usually Council Officers) to undertake these duties or exercise these powers on its behalf. Delegations enhance decision-making processes and allow nominated routine matters to be resolved efficiently and effectively without the need for submission to Council. However, in order to do this, Council must take formal steps to delegate to such people and bodies, the authority to make decisions, or undertake activities on its behalf. It is usual for Council to make delegations to the Chief Executive Officer who will then make sub-delegations to the appropriate Council Officers.
- 1.4 A full review of Delegations is usually undertaken on an annual basis. In addition, Norman Waterhouse Lawyers provide a quarterly service to the LGA whereby they monitor legislative amendments and distribute changes required to delegations via "Delegations Templates". In some instances the changes identified are editorial in nature only; other changes reflect legislative amendments that have occurred since the previous templates review which require new or changed delegations to be made.

- 1.5 Council last undertook its annual review of delegations in August 2017 and at that review Council retained the powers set out in Attachment 35 titled “Powers to Remain with Council”. Attachment 36 titled “Delegations to Remain with the Chief Executive Officer – Not to be Sub-Delegated” sets out the delegations held by the Chief Executive Officer that cannot be sub-delegated to staff. No changes, with the exception of those powers under legislation no longer in force, amendments as a result of the legislative audit conducted by Minter Ellison in 2017 or additions as a result of amendments to or new legislation, are proposed to the powers to remain with Council or Delegations to remain with the Chief Executive Officer.
- 1.6 In addition, since the last annual review, subsequent and regular reviews have been presented to Council as a result of the service provided by Norman Waterhouse to the LGA including:
- 1.6.1 **Local Government Act 1999 – New and Amended Provisions**  
New and amended delegations including the issuing/cancelling of permits and adopting/amending location rules for the purposes of mobile food vending businesses.
- 1.6.2 **Natural Resources Management Act 2004**  
To enable Council’s Water Business Unit to apply for permits, water licenses, variations of water licenses and transfer of water licenses.
- 1.6.3 **Environment Protection Act 1993**  
To enable Council’s Water Business Unit to make application for environmental authorisations and conditions requiring approval of certain works and processes.
- 1.6.4 **Heavy Vehicle National Law (South Australia) Act 2013**  
New provisions to provide a specific power of delegation in relation to Council’s power as a road manager.
- 1.6.5 **Expiation of Offences Act 1996 and Fines Enforcement and Debt Recovery Act 2017**  
A new enforcement regime under the *Fines Enforcement and Debt Recovery Act* and the *Expiation of Offences Act* which commenced on 30 April 2018.
- 1.6.6 **Development Act 1993, Development (Development Plans) Amendment Act 2006 and Development Regulations 2008**  
The delegation of power under regulation 83(3) of the *Development Regulations 2008* excludes power in relation to a designated building on which building work involving the use of a designated building product is carried out after the commencement of the *Development (Building Cladding) Variation Regulations 2018*
- 1.6.7 **Road Traffic Act 1961**  
New delegations introduced for new provisions under sections 17, 20 and 20A of the *Road Traffic Act 1961*. These sections concern traffic control devices, roadworks permits and work area/site signs.

1.6.8 **Liquor Licensing Act 1997**

Delegations for new powers under the *Liquor Licensing Act 1997* for councils to prohibit the consumption or possession or both of liquor in a public place(s) for a period not exceeding 48 hours.

1.6.9 **South Australian Public Health Act 2011 and Regulations**

Amendments to accommodate the new *South Australian Public Health (Fees) Regulations 2018*.

1.7 Ongoing review of Council's Delegations Register has occurred as amendments to legislation are introduced to update it in line with the current Instruments of Delegations as provided by the Local Government Association.

1.8 Recent amendments with variations to Delegations as a consequence of the following, not previously reported to Council, have also been incorporated into the recommendations of this report:

1.8.1 **New Delegation Template by Norman Waterhouse in LGA Circular 11.2 dated 7 March 2019**

*Electricity Act 1996 and Electricity (Principles of Vegetation Clearance) Regulations 2010*

The new instrument of delegation under the *Electricity Act 1996 and Electricity (Principles of Vegetation Clearance) Regulations 2010* provides delegations for council powers to agree for an electricity entity to carry out work on public land that the council is responsible for, and for council powers relating to vegetation clearance arrangements with an electricity entity.

*Gas Act 1997*

The new instrument of delegation under the *Gas Act 1997* provides delegations for council power to agree to a gas entity to carry out work on public land that the council is responsible for.

New provisions - Sections 128E(1), 128E(2), 128F, 128H(3), 128H(5), 128H(6), 128H(7)

*Local Government Act 1999*

Delegations have been added to reflect commencement of the new boundary reform provisions – please refer to shaded areas on Attachment 16.

Repealed provisions – Sections 28(6), 28(23)(f) and (g)

New provisions - Sections 28(1), 28(3), 31(2), 31(10)

- 1.9 Other Acts also contain specific provisions for the delegation of powers and functions to councils, such as the *Development Act 1993*, the *Food Act 2001* and the *Supported Residential Facilities Act 1999*. Delegations under these Acts form separate recommendations in this report.
- 1.10 The *Development Act 1993* requires that Council adopt a policy setting out the basis upon which delegations under that Act are made. Council last endorsed the Development Act 1993 and Development Regulations 2008 Delegation Policy on 28 August 2017. As part of the review of delegations process the policy has also be reviewed and an updated copy of the Policy is provided as Attachment 37 to this report for endorsement. Only minor editorial amendments have been made to the policy and these are marked with revisions.
- 1.11 Members are reminded that delegations to individuals under all Acts are revocable at will, and furthermore, do not prevent Council from acting in a matter. The exception to this is Section 34(24) of the *Development Act 1993* in relation to delegations by Council to the Development Assessment Panel.

## 2. REPORT

### **2018/19 Review of Delegations**

- 2.1 The City of Salisbury uses a database for management and maintenance of legislative delegations. The database was developed by the City of Charles Sturt in conjunction with the LGA for use by Councils.
- 2.2 The database acts as the City of Salisbury's Delegations Register required under Section 44(6) of the *Local Government Act 1999*.
- 2.3 This Register includes a record of the sub-delegations of these powers and functions by the Chief Executive Officer to specific officers in exercise of his powers under Sections 44(4) and 101 of the *Local Government Act 1999*. While these sub-delegations do not require the authorisation of Council, it is appropriate they be included in the publicly available Delegations Register.
- 2.4 Since the last annual review of delegations, Council Officers have reported any changes to Council and made the necessary adjustments as advised by Norman Waterhouse and updated the Delegations Register in accordance with the current Instruments of Delegation as provided by the Local Government Association.
- 2.5 It is important to note that within the listings in the Delegations Register, where there are no conditions/limitations imposed against delegations, these have been considered, but none applied.

**Process to be followed**

- 2.6 In order for the statements contained in the instruments of delegation to come into effect, Council must first resolve to revoke the existing delegations. Council then resolves to adopt the new delegations contained in the instruments of delegations.
- 2.7 If required, position titles will be updated within the delegations register to reflect changes as a result of implementation of any recent changes to titles or organisation structure. It is important to note, there is likely to be very few instances where this is required as Council's delegation decisions primarily relate to the delegation of powers/functions to the Chief Executive Officer.
- 2.8 Any sub-delegations that have been made in relation to the existing delegations become void as soon as the 'head' delegation is revoked. In order to ensure that Council Officers have the necessary powers to continue their duties, the resolution is worded so that revocation of the existing delegations does not come into force until such time as the sub-delegations are ready to be approved by the Chief Executive Officer. The new delegations will take effect immediately prior to the Chief Executive Officer approval of the sub-delegations.
- 2.9 The exercise of powers and functions delegated by Council shall be undertaken in accordance with existing Council policies. Even though Council may delegate its powers, functions and duties, this does not prevent the Council from acting in the same matters at any time should the need arise.

**Delegations Register**

- 2.10 The Delegations Register is available on the City of Salisbury website and available for inspection in the Publicly Available Documents Folder in the reception area of the Council offices.
- 2.11 Following Council consideration of this report, the Delegations Register will be updated and posted to Council's website and the Elected Member Portal and a printed copy will be made available in the Publicly Available Documents Folder.

**3. CONCLUSION / PROPOSAL**

- 3.1 The annual review of Council delegations has been conducted and is presented to Council for endorsement.

**POWERS AND FUNCTIONS DELEGATED IN THIS INSTRUMENT**

1.	<b>Offence to Dispose of Bodily Remains Except in Cemetery or Natural Burial Ground</b>
1.1	The power pursuant to Section 8(2) of the Burial and Cremation Act 2013 ( <b>the Act</b> ) to grant approval to a person to inter bodily remains in a prescribed area on land within the Council's area outside a cemetery or natural burial ground.
2.	<b>Opening of Interment Sites, Exhumation and Re-interment</b>
2.1	The power pursuant to Section 13(6) of the Act to consult with the Attorney-General in relation to an approval for the purposes of Section 13(1) of the Act where the Council is the relevant authority for the cemetery or natural burial ground.
3.	<b>Disposal of Unclaimed Cremated Human Remains</b>
3.1	The power pursuant to Section 18(2) of the Act, to, if the cremated remains of a deceased person processed at a crematorium are not claimed within 6 months, to dispose of them as the delegate thinks fit where the Council is the relevant authority for the crematorium.

1.2 The power pursuant to Section 25A(2) of the Act to make an appointment subject to conditions specified in the instrument of appointment.

**POWERS AND FUNCTIONS DELEGATED IN THIS INSTRUMENT**

<b>1. Power to Carry Out Work on Public Land</b>
1.1 The power pursuant to Section 47(3)(b) of the Electricity Act 1996 ( <b>the Act</b> ), to agree with an electricity entity to the entity carrying out work on public land that the Council is responsible for the management of.
1.2 The power pursuant to Section 47(4) of the Act, to include in an agreement under Section 47 of the Act such conditions the delegate considers appropriate in the public interest.
1.3 The power pursuant to Section 47(7) of the Act, if a dispute arises between an electricity entity and the Council about whether work should be permitted under Section 47 of the Act on the land or about the conditions on which work should be permitted on public land, to refer the dispute to the Minister.
1.4 The power pursuant to Section 47(9) of the Act, if a dispute is referred to the Minister under Section 47 of the Act:
1.4.1 to make representations to the Minister on the questions at issue in the dispute; and
1.4.2 to make a reasonable attempt to agree to settlement of the dispute on agreed terms.
<b>2. Duties in Relation to Vegetation Clearance</b>
2.1 The power pursuant to Section 55(3) of the Act, where vegetation is planted or nurtured near a public powerline contrary to the principles of vegetation clearance, and the Council has the duty under Part 5 of the Act, to keep vegetation clear of the powerline, to remove the vegetation and recover the

	cost of so doing as a debt from the person by whom the vegetation was planted or nurtured.
<b>3. Vegetation Clearance Schemes</b>

1.1	The duty pursuant to Section 9(1a) of the Freedom of Information Act 1991 ( <b>the Act</b> ) and in accordance with Section 9(2), (3) and (4) to cause, at intervals of not more than 12 months, an up to date information statement to be published in the manner prescribed by regulation.
<b>2.</b>	<b>Availability of Certain Documents</b>
2.1	The duty pursuant to Section 10(1) of the Act to cause copies of the Council's most recent information statement and each of its policy documents to be made available for inspection and purchase by members of the public.
2.2	The power pursuant to Section 10(2) of the Act to delete information from the copies of a policy document if its inclusion would result in the document being an exempt document otherwise then by virtue of Clause 9 or 10 of Schedule 1 to the Act.
2.3	The duty pursuant to Section 10(3) of the Act not to enforce a particular policy to the detriment of a person:
2.3.1	if the relevant policy document should have been, but was not, made available for inspection and purchase in accordance with Section 10 at the time the person became liable to the detriment; and

<b>1.1</b>	The power pursuant to Section 27 of the Real Property Act 1886 ( <b>the Act</b> ) and in accordance with Sections 27, 28 and 29 of the Act to, as to land heretofore alienated from the Crown in fee but not under the provisions of any of the Real Property Acts (whether such land shall constitute the entire or only part of the land included in any land grant), to apply to the Registrar-General in the form of Schedule 2 to the Act, or in a form to the like effect, to bring the said land under the provisions of the Act where:
<b>1.1.1</b>	the Council claims to be the person in whom the fee simple is vested either at law or in equity;
<b>1.1.2</b>	the Council has power to appoint or dispose of the fee simple, at law or in equity and the application is made for the purpose of carrying such power into effect.

2.1.2.1	the names and addresses of those persons affected who can be identified by reasonable enquiry; and
2.1.2.2	such information in relation to the land subject to the proposed road process as is required by the Surveyor-General.
2.2	The duty pursuant to Section 9(2) of the Act where the Council has proposed a road process and a preliminary plan and statement has been prepared pursuant to the requirements of Section 9(1) of the Act, to deposit a copy of the said preliminary plan and statement at the Adelaide office of the Surveyor-General together with the prescribed fee.
<b>3. Notification of Proposed Road Process</b>	
3.1	The duty pursuant to Section 10(1) of the Act where the Council commences a road process (where the Council is the relevant authority in relation to the road process) to –

3.1.1	after compliance with the requirements of Section 9 of the Act, give public notice, in accordance with the Regulations, of the proposal; and
3.1.2	at the same time to give notice in writing of the proposal on each person affected who can be identified by reasonable enquiry.

<b>22. Relevant Authority</b>
22.1 The power pursuant to Regulation 6(1)(b) of the South Australian Public Health (Wastewater) Regulations 2013 ( <b>the Wastewater Regulations</b> ) to, agree to act as the relevant authority for a matter relating to an on-site wastewater system with a capacity that does not, or will not, on completion of wastewater works, exceed 40 EP and that is located or to be located in another council area if the system is to be operated by another council or wastewater works related to the system are to be undertaken by another council, or by a person acting in partnership, or in conjunction with that other council.
<b>23. Public Notification of Proposed Community Wastewater Management System</b>
23.1 The power pursuant to Regulation 8(1) of the Wastewater Regulations to, if the Council proposes to establish a community wastewater management system for the whole or part of its area in the interests of public and environmental health, to give notice to the owners of land in the area affected by the proposal containing the prescribed details relating to the proposal and inviting submissions in relation to the proposal within a period (which must be at least 21 days) specified in the notice.
<b>24. Connection to Community Wastewater Management System</b>
24.1 The power pursuant to Regulation 9(1) of the Wastewater Regulations and subject to Regulation 9(2) of the Wastewater Regulations on obtaining a wastewater works approval for a community wastewater management system, to, by written notice, require the operator of an on-site wastewater system:
24.1.1 to connect the system to the community wastewater management system; and
24.1.2 for that purpose, to complete and submit an application to the Council, within the period specified in the notice, for a wastewater works approval for:

24.1.2.1	the connection; and
24.1.2.2	if necessary, consequential alterations to the on-site wastewater system.
24.2	The power pursuant to Regulation 9(4) of the Wastewater Regulations, if the operator of an on-site wastewater system does not submit an application within the period specified in a notice under Regulation 9(1) of the Wastewater Regulations, to grant a wastewater works approval for the required wastewater works as if the application had been made.
24.3	The power pursuant to Regulation 9(6) of the Wastewater Regulations, if wastewater works are not carried out in accordance with a wastewater works approval for the connection of an on-site wastewater system to a community wastewater management system required under Regulation 9 of the Wastewater Regulations, to cause the requirements to be carried out (and a person authorised to do so by the Council may enter land at any reasonable time for the purposes of carrying out the relevant work).
24.4	The power pursuant to Regulation 9(6) of the Wastewater Regulations to if wastewater works are not carried out in accordance with a wastewater approval for the connection of an on-site wastewater system to a community wastewater management system required under Regulation 9 of the Wastewater Regulations, authorise a person to enter land at any reasonable time for the purpose of carrying out the relevant work.
24.5	The power pursuant to Regulation 9(7) of the Wastewater Regulations to recover as a debt the costs and expenses reasonably incurred in exercising a power under Regulation 9(6) of the Wastewater Regulations and the prescribed fee that would have been payable had the application been made as required under Regulation 9(1) of the Wastewater Regulations from the person who failed to comply with the notice.
<b>25. Exemptions</b>

32.3	The power pursuant to Regulation 29(3) of the Wastewater Regulations, to authorise a person to enter land at any reasonable time for the purposes of the report.

**INSTRUMENT OF GENERAL APPROVAL**

**GENERAL APPROVAL FOR THE INSTALLATION, MAINTENANCE, ALTERATION,  
OPERATION OR REMOVAL OF TRAFFIC CONTROL DEVICES**

I, **Tom Koutsantonis, Minister for Transport and Infrastructure** in the State of South Australia, pursuant to section 12 of the *Road Traffic Act 1961* ("the Act"), hereby grant the following **GENERAL APPROVALS** to Council:

**A. Traffic Control Devices**

For the purpose of sections 17(1) and (2) of the Act, I grant Council **GENERAL APPROVAL** to install, maintain, alter, operate, or remove, or cause to be installed, maintained altered, operated, or removed any traffic control device on, above or near a road which is under its care, control and management subject to the following conditions **EXCEPT** those traffic control devices specified in Clause A.8 or those dealt with in other clauses of this instrument:

**A.1 Authorisation of other Officers**

Council may authorise any Officer to exercise the powers conferred on it pursuant to Clause A of this Instrument. Any Authorisations to any Officer must be made by instrument in writing and approved by the Chief Executive Officer on behalf of Council. All actions carried out by any Officer in accordance with Clause A must be done so "for, and on behalf of the Council". Records must be kept of any Authorisations made pursuant to this clause. Council may attach any conditions to such Sub-Authorisations that it considers appropriate.

**A.2 Conformity with the *Road Traffic Act***

All traffic control devices used pursuant to Clause A must conform to the requirements of the Act and any Rules and Regulations made under the Act.

#### A.3 Conformity with the Australian Standards and the Code

All traffic control devices must conform to the requirements of and be installed, maintained, altered, operated or removed in accordance with the applicable Australian Standards, and the provisions contained in the Code and the applicable Australian Standards, as amended from time to time.

The Code refers to and invokes the applicable Australian Standards. The Code must be read together with, but takes precedence over, all applicable Australian Standards.

#### A.4 Notification to adjoining Councils

Council must notify an adjoining Council before installing, altering or removing a traffic control device on a road that runs into or intersects with, or is otherwise likely to affect traffic on a road (including its flow, speed and composition) that is under the care, control and management of another Council.

Where a Council uses a traffic control device to effect section 32 of the Act, that is, closing a road for traffic management purposes, and the road runs into the area or along the boundary of another Council, each affected Council must concur with the road closure or part road closure.

#### A.5 Notification to the Commissioner of Highways

Council must notify the Commissioner of Highways before installing, altering or removing a traffic control device on a road that runs into or intersects with, or otherwise is likely to affect traffic on a road (including its flow, speed and composition) that is under the care, control and management of the Commissioner of Highways.

#### A.6 Consultation on traffic signals

If Council wishes the Commissioner of Highways to maintain Council's:

- (a) traffic signals at intersections;
- (b) emergency services traffic signals;
- (c) mid-block traffic signals (pedestrian actuated crossings);
- (d) signals at Koala crossings; or
- (e) signals at Wombat crossings with flashing lights,

then Council must consult with the Commissioner of Highways when proposing to install the said signals for the purpose of standardising the equipment and establishing a uniform maintenance program.

#### A.7 Traffic Impact Statement

Before any traffic control device is installed, altered or removed, a Traffic Impact Statement must be prepared by a person, who in the Council's opinion is an experienced traffic engineering practitioner.

The Traffic Impact Statement must be endorsed by a person authorised by Council.



The Traffic Impact Statement summarises the investigations undertaken to justify the installation, alteration or removal of traffic control devices and must address road safety issues and the traffic management effects for all road users, including cyclists and pedestrians. It need not be a lengthy document. The Code provides further guidance on the preparation of Traffic Impact Statements.

A Traffic Impact Statement is not required for the installation, alteration or removal of traffic control devices on road-related areas that do not constitute a public place.

#### A.8 Traffic control devices requiring separate approval

General approval does not apply to those traffic control devices:

- (a) specifically listed in the Code requiring separate approval; or
- (b) not contained in or referred to in the Australian Standards or the Code; or
- (c) not complying with clause A.3.

Council must obtain separate approval to install, maintain, alter, operate or remove, or cause to be installed, altered, operated or removed, any traffic control device specified in this clause.

Council must address applications for approval under this clause to the Commissioner of Highways who will consider the application as the Minister's delegate. The application must include a Traffic Impact Statement, any plans, and relevant supporting documentation.

### B. Speed Limits at Works on Roads

For the purpose of section 20(2) of the Act, I grant Council **GENERAL APPROVAL** to place signs on a road for the purpose of indicating the maximum speed to be observed by drivers while driving on, by or towards

- a work area; or
- a work site

where workers are engaged, or works are in progress at the direction of Council, subject to the following conditions:

#### B.1 Authorisation of other Officers

Council may authorise any Officer to exercise the powers conferred on it pursuant to Clause B of this Instrument. Any Authorisations to any Officer must be made by instrument in writing and approved by the Chief Executive Officer on behalf of Council. All actions carried out by that Officer in accordance with Clause B must be done so "for, and on behalf of the Council". Records must be kept of any authorisation made pursuant to this clause. Council may attach any conditions to such Sub-Authorisations that it considers appropriate.

**B.3 Conformity with the *Road Traffic Act***

The maximum speed to be indicated by signs must be in accordance with section 20 of the Act.

**B.4 Conformity with the SA Standards**

All traffic control devices must conform to the requirements of and be installed in accordance with the provisions contained in the SA Standards.

**B.5 Persons who may act on behalf of Council**

For the purposes of this clause, the following people may act on behalf of Council:

- (a) an employee of Council; or
- (b) an employee of a contractor or sub-contractor engaged to carry out works on a road on behalf of Council.

**B.6 Training and Accreditation**

At all times when a worker is present at a work area or work site at least one worker must:

- have gained accreditation in the DPTI Workzone Traffic Management Training Program; and
- carry a card or certificate certifying accreditation in this course when engaged at a work area or work site; and
- have undertaken re-training in the DPTI Workzone Traffic Management Training Program within the last 3 years.

**B.7 Record Keeping**

Any person acting on behalf of Council pursuant to Clause B must comply with the SA Standards that outline the procedures and guidelines for record keeping required for the overall safety and smooth operation of a traffic guidance scheme.

**C. Traffic Control Devices at Works on Roads**

For the purposes of sub-section 17(3) of the Act, I grant Council **GENERAL APPROVAL** to install, display, alter, operate, or remove, any traffic control device in relation to an area where persons are engaged in work or an area affected by works in progress, or in relation to part of a road temporarily closed to traffic under this Act or any other Act. This approval is subject to the following conditions:

**C.1 Authorisation of other Officers**

Council may authorise any Officers to exercise the powers conferred on it pursuant to Clause C of this Instrument. Any Authorisations to any officer must be by instrument in writing and approved by the Chief Executive Officer on behalf of Council. All actions carried out by that Officer in accordance with Clause C must be done so "for, and on behalf of the Council". Records must be kept of any authorisation made pursuant to

this clause. Council may attach any conditions to such Sub-Authorisations that it considers appropriate.

#### C.2 Conformity with the Road Traffic Act

All traffic control devices must conform to the requirements of, and be installed, displayed, altered, operated or removed in accordance with the Act and any Rules and Regulations made under the Act.

#### C.3 Conformity with the Code, and SA Standards

All traffic control devices must conform to the requirements of and be installed, displayed, altered, operated or removed in accordance with the provisions contained in the Code, the SA Standards and the applicable Australian Standards.

#### C.4 Persons who may act on behalf of Council

For the purposes of this clause, the following people may act on behalf of Council:

- (a) an employee of Council; or
- (b) an employee of a contractor or sub-contractor engaged to carry out works on a road on behalf of Council.

#### C.5 Training and Accreditation

At all times when a worker is present in an area where persons are engaged in work or an area affected by works in progress at least one worker must:

- have gained accreditation in the DPTI Workzone Traffic Management Training Program; and
- carry a card or certificate certifying accreditation in this course when engaged at a work area or work site; and
- have undertaken re-training in the DPTI Workzone Traffic Management Training Program within the last 3 years.

#### C.6 Record Keeping

Any person acting on behalf of Council pursuant to Clause C must comply with the SA Standards that outline the procedures and guidelines for record keeping required for the overall safety and smooth operation of a traffic guidance scheme.

#### D. Temporary Parking Controls

For the purpose of sub-section 17(3) of the Act, I grant Council **GENERAL APPROVAL** to install, display, alter, operate, or remove a traffic control device for the purposes of imposing, varying or abolishing a parking control on a temporary basis on a road which is under its care, control and management, subject to the following conditions:

**D.1 Authorisation of other Officers**

Council may authorise any Officers to exercise the powers conferred on it pursuant to Clause D of this Instrument. Any Authorisations to any Officer must be made by instrument in writing and approved by the Chief Executive Officer on behalf of Council. All actions carried out by that Officer in accordance with Clause D must be done so "for, and on behalf of the Council". Records must be kept of any authorisation made pursuant to this clause. Council may attach any conditions to such Sub-Authorisations that it considers appropriate.

**D.2 Conformity with the Act**

All temporary parking controls must conform with the requirements of, and be installed, displayed, altered, operated or removed in accordance with the Act and any Rules and Regulations made under the Act.

**D.3 Conformity with Australian Standards and the Code**

All temporary parking controls must conform to the requirements and be installed, displayed, altered, operated or removed in accordance with the provisions contained in any applicable Australian Standards and the Code.

The Code refers to and invokes the Australian Standards. The Code must be read together with, but takes precedence over, all applicable Australian Standards.

**D.4 Information on Signs**

A temporary parking control used in accordance with Clause D must display the words "TEMPORARY PARKING CONTROL" in a prominent position.

**D.5 Limitation of Temporary Parking Controls**

A temporary parking control used in accordance with Clause D cannot have effect for a period exceeding 35 days.

**D.6 Records of Temporary Parking Controls**

Council must keep records of any use of temporary parking controls.

**E. TRAFFIC CONTROL DEVICES FOR EVENTS**

For the purposes of section 17 of the Act, I grant Council **GENERAL APPROVAL** to install, maintain, alter, operate or removed, or cause to be installed, maintained altered, operated, or removed, a traffic control device for the purpose of an event other than those specified in Clause A.8 of this Instrument, on, above or near a road which is under its care, control and management subject to the following conditions:

**E.1. Conformity with the Road Traffic Act**

All traffic control devices used pursuant to Clause E of this Instrument must conform to the requirements of the Act, and any Rules and Regulations made under the Act.

#### E.2. Conformity with Plan

All traffic control devices must be installed in accordance with a Traffic Management Plan prepared by a person who in the opinion of the Council has an appropriate level of knowledge and expertise in the preparation of traffic management plans.

Council need not comply with Clause A.7 of this Instrument where using a traffic control device for the purpose of an event.

#### E.3. Notification to adjoining Councils

Council must notify an adjoining Council before installing, altering or removing a traffic control device on a road that runs into or intersects with, or otherwise is likely to affect traffic (including its flow, speed and composition) on a road that is under the care, control and management of another Council.

#### E.4 Notification to the Commissioner of Highways

Council must notify the Commissioner of Highways before installing, altering or removing a traffic control device on a road that runs into or intersects with, or otherwise is likely to affect traffic on a road (including its flow, speed and composition) that is under the care, control and management of the Commissioner of Highways.

---

### INSTRUMENT OF DELEGATION

I, **Tom Koutsantonis, Minister for Transport and Infrastructure** in the State of South Australia, pursuant to section 11 of the *Road Traffic Act 1961* ("the Act") hereby **DELEGATE** the powers as detailed in the following clauses –

#### F. GRANT APPROVAL TO ANOTHER ROAD AUTHORITY

I **DELEGATE** to **Council** the power conferred on the Minister pursuant to section 17 of the Act to **SPECIFICALLY APPROVE** the installation, maintenance, alteration, operation or removal of a traffic control device in the municipality or district of Council by a road authority on, above or near a road under the care, control and management of the said road authority subject to the following conditions:-

**F.1 Sub-Delegation and Authorisation to other Officers**

This delegation cannot be sub-delegated without my express approval. Council may, however, authorise any officers to exercise the powers conferred on Council pursuant to Clause F of this Instrument.

Any Authorisations to any Officer should be made by instrument in writing and approved by the Chief Executive Officer on behalf of Council. All actions carried out by that officer in accordance with Clause F must be done so "for, and on behalf of the Council". Records must be kept of any authorisation made pursuant to this clause.

**F.2 Conformity with the Road Traffic Act**

All traffic control devices used pursuant to Clause F of this Instrument must conform to the requirements of the Act, and any Rules and Regulations made under the Act.

**F.3 Conformity with the Australian Standards and the Code**

All traffic control devices must conform to the requirements of and be installed, maintained, altered, operated or removed in accordance with the provisions contained in the applicable Australian Standards and the Code.

The Code refers to and invokes the Australian Standards. The Code must be read together with, but takes precedence over, all applicable Australian Standards.

**F.4 Power of approval subject to same Conditions in Clause A**

The power of Council to grant approvals under Clause F is subject to the same conditions that apply to Council under Clause A where Council itself is the road authority.

**F.5 Record Keeping**

Council must keep accurate records of any approval granted to another road authority pursuant to Cause F of this Instrument.

**G. CLOSE ROADS AND GRANT EXEMPTIONS FOR EVENTS**

I **DELEGATE** to Council my power in sub-section 33(1) of the Act to declare an event to be an event to which section 33 applies and make orders directing:

- (a) that specified roads (being roads on which the event is to be held or roads that, in the opinion of the Council, should be closed for the purposes of the event) be closed to traffic for a specified period; and
- (b) that persons taking part in the event be exempted, in relation to the specified roads, from the duty to observe the Australian Road Rules specified in Clause G.4 subject to the conditions in Clause G.5

**G.1 Sub-Delegation to other Officers**

Council may sub-delegate the power delegated to Council pursuant to Clause G of this Instrument subject to the following conditions:

1. Council may only sub-delegate the power to the person for the time being occupying the position of Chief Executive Officer of Council; and
2. Any such sub-delegation must be made by instrument in writing by Council resolution; and
3. The sub-delegate cannot direct the closure of a road or and grant an exemption for an event on a road that runs into or intersects with, or is otherwise likely to affect traffic (including its flow, speed and composition) on a road that is under the care, control and management of another Council or the Commissioner for Highways; and
4. Council's sub-delegate is subject to all conditions that are imposed on Council under Clause G, in relation to the closure of a road or the grant of an exemption for an event; and
5. Council may impose any other conditions deemed necessary on its sub-delegate in relation to the closure of a road or the grant of an exemption for an event; and
6. Council cannot authorise any other person to exercise the powers conferred on Council, pursuant to G of this Instrument.

#### G.2 Roads and Road-Related Areas to which Delegation Applies

Council may only exercise the powers of the Minister in sub-section 33(1) of the Act with respect to a road under its care, control and management.

#### G.3 Conformity with the Road Traffic Act

Council when exercising the powers of the Minister in sub-section 33(1) of the Act must comply with the requirements of section 33 of the Act.

#### G.4 Exemption from Australian Road Rules

Council can only grant exemptions from the following Australian Road Rules and subject to the conditions listed in Clause G.5:

1. Rule 221: Using hazard warning lights;
2. Rule 230: Crossing a road — general;
3. Rule 231: Crossing a road at pedestrian lights;
4. Rule 232: Crossing a road at traffic lights;
5. Rule 234: Crossing a road on or near a crossing for pedestrians;
6. Rule 237: Getting on or into a moving vehicle;
7. Rule 238: Pedestrians travelling along a road (except in or on a wheeled recreational device or toy);
8. Rule 250: Riding on a footpath or shared path;

9. Rule 264: Wearing of seat belts by drivers;
10. Rule 265: Wearing of seat belts by passengers 16 years old or older;
11. Rule 266: Wearing of seat belts by passengers under 16 years old;
12. Rule 268: How persons must travel in or on a motor vehicle;
13. Rule 269: Opening doors and getting out of a vehicle etc;
14. Rule 298: Driving with a person in a trailer.

#### G.5 Conditions on Exemptions from Australian Road Rules

Council may only grant exemption from the following Australian Road Rules provided any such exemption contains the following minimum conditions:

1. Rule 237: Getting on or into a moving vehicle – provided the speed of the vehicle does not exceed 5 km/h;
2. Rule 264: Wearing of seat belts by drivers – provided the speed of the vehicle does not exceed 25 km/h;
3. Rule 265: Wearing of seat belts by passengers 16 years old or older – provided the speed of the vehicle does not exceed 25 km/h;
4. Rule 266: Wearing of seat belts by passengers under 16 years old – provided the speed of the vehicle does not exceed 25 km/h;
5. Rule 268: How persons must travel in or on a motor vehicle – provided the speed of the vehicle does not exceed 25 km/h;
6. Rule 269: Opening doors and getting out of a vehicle etc – provided the speed of the vehicle does not exceed 5 km/h;
7. Rule 298: Driving with a person in a trailer – provided the speed of the vehicle does not exceed 25 km/h.

#### G.6 Notification to Commissioner of Highways

Council must notify the Commissioner of Highways of any declaration under sub-section 33(1) at least two weeks prior to the date of the event.

#### G.7 Notification to Emergency Services and Public Transport Services Division

Council must notify the SA Metropolitan Fire Service, SA Country Fire Service, SA State Emergency Service, the SA Ambulance Service and the Public Transport Services Division of the Department of Planning, Transport and Infrastructure ("DPTI") as appropriate, of any declaration under sub-section 33(1) at least two weeks prior to the date of the event.

#### G.8 Notification to Traffic Management Centre, Metropolitan Region

Where an event requires intervention by DPTI to ensure the safe and efficient conduct and movement of traffic, Council must ensure that it or the event organiser contacts the Traffic Management Centre, Metropolitan Region (ph: 1800 018 313) no less than 15 minutes prior to the commencement of the event and immediately upon completion of the need for such intervention.

#### G.9 Notification to Commissioner of Police

Council must notify the Commissioner of Police of any declaration under sub-section 33(1) at least two weeks prior to the date of the event.

#### G.10 Agreement of Commissioner of Police

If Council proposes to make an order under sub-section 33(1) that involves any motor vehicular traffic, Council must first obtain the agreement of the Commissioner of Police before making an order that exempts a person from any of the following Australian Road Rules: 230, 231, 232, 234 and 238.

#### G.11 Use of Advance Warning Signs

Where the event will significantly and/or adversely affect a road which is under the care, control and management of the Commissioner of Highways, Council must ensure that the event organisers place advance warning notification signs on the affected roads. The signs must clearly indicate to the public the times and dates of the temporary road closure.

#### G.12 Effect on Roadside Furniture

Where an event affects any roadside furniture owned or maintained by the Commissioner of Highways or road markings, Council must ensure that it or the event organiser reinstates such furniture or markings to its original condition.

### H. DEFINITION OF TERMS

For the purposes of this Instrument, unless a contrary intention appears:  
Words defined in section 5 of the Act have the same meaning as in the instrument.

A reference to a road includes a reference to a road-related area unless it is otherwise expressly stated.

**Council** means a council constituted under the *Local Government Act 1999*;

**Code** means the Code of Technical Requirements, as amended from time to time (formerly known as the Code of Technical Requirements for the Legal Use of Traffic Control Devices);

**Event** means event as defined in section 33 of the *Road Traffic Act 1961* namely an organised sporting, recreational, political, artistic cultural or other activity, and includes a street party;

**Officer** means Council employee

**SA Standards** means the Department of Planning, Transport and Infrastructure's SA Standard for Workzone Traffic Management;

**Work area** means work area as defined in section 20(1) of the Act, namely a portion of road on which workers are, or may be, engaged;

**Work site** means a portion of road affected by works in progress, together with any additional portion of road used to regulate traffic in relation to those works or for any associated purpose.

**I. FUTURE VARIATIONS TO THIS INSTRUMENT**

This Instrument may be revoked or varied by a subsequent Instrument in writing.

<b>1. Deciding Request for Consent Generally</b>
<p><b>1.1</b> The power pursuant to Section 156(1) of the <i>Heavy Vehicle National Law (South Australia) Act 2013 (the Act)</i>, to, subject to Sections 156(2), (3) (4) and (6) of the Act, if the Regulator asks for the Council's consent to the grant of a mass or dimension authority, decide to give or not to give the consent:</p>
<p><b>1.1.1</b> within:</p>
<p><b>1.1.1.1</b> 28 days after the request is made, unless Section 156(1)(a)(ii) of the Act applies; or</p>
<p><b>1.1.1.2</b> if Section 156 of the Act applies because the Council gave the Regulator a notice of objection to the grant under Section 167 of the Act – 14 days after giving the notice of objection; or</p>
<p><b>1.1.2</b> within a longer period, of not more than 6 months after the request is made, agreed to by the Regulator.</p>
<p><b>1.2</b> The power pursuant to Section 156(2) of the Act, to ask for a longer period under Section 156(1)(b) of the Act only if:</p>
<p><b>1.2.1</b> consultation is required under a law with another entity (including, for</p>

<b>1.2.2</b>	the delegate considers a route assessment is necessary for deciding whether to give or not to give the consent; or
<b>1.2.3</b>	the Council is the road authority for the participating jurisdiction and the delegate considers that a local government authority that is not required under a law to be consulted should nevertheless be consulted before deciding whether to give or not to give the consent.
<b>1.3</b>	The power pursuant to Section 156(2)(c) of the Act to, in relation to the Regulator obtaining the consent of the road manager for a road for the purpose of granting a mass or dimension authority make submissions where the road manager is the road authority for the participating jurisdiction and considers that the Council, whilst not required under a law to be consulted should nevertheless be consulted before the road manager decides whether to give or not to give consent.

1.4A	The power pursuant to Section 156A(2) of the Act, if the delegate considers that the consent would be given if the mass of the vehicle under the application for the authority was less than applied for, to give the consent subject to a road condition that the vehicle not exceed the mass.
1.5	The power pursuant to Section 156A(3) of the Act, in deciding whether or not to give the consent, to have regard to:
1.5.1	for a mass or dimension exemption – the approved guidelines for granting mass or dimension exemptions; or
1.5.2	for a class 2 heavy vehicle authorisation – the approved guidelines for granting class 2 heavy vehicle authorisations.

2.2.2	the delegate has not yet decided to give or not to give the consent,

2.2.3	decide not to give the consent, on the ground that the consent would be inoperative; or
2.2.4	decide to give the consent.
<b>3. Deciding Request for Consent if Route Assessment Required</b>

6.1	The power pursuant to Section 162(1) of the Act, where the delegate gives consent to the grant of the authority to ask the Regulator to impose a stated vehicle condition on the authority.
<b>7. Expedited Procedure for Road Manager's Consent for Renewal of Mass or Dimension</b>	

<b>Authority</b>	
7.1	The power pursuant to Section 167(2)(b) of the Act, to give the Regulator a notice of objection to the application of Section 167 of the Act to the proposed replacement authority within the period of:
7.1.1	14 days after the request for consent is made; or
7.1.2	28 days after the request for consent is made if the delegate seeks the extension of time within the initial 14 days.
<b>8. Granting Limited Consent for Trial Purposes</b>	
8.1	The power pursuant to Section 169(1) of the Act to give consent to the grant of a mass or dimension authority for a trial period of no more than 3 months specified by the delegate.
<b>9. Renewal of Limited Consent for Trial Purposes</b>	
9.1	The power pursuant to Section 170(3) of the Act to give the Regulator a written objection within the current trial period to the renewal of a mass or dimension authority for a further trial period of no more than 3 months.
<b>10. Amendment or Cancellation on Regulator's Initiative</b>	
10.1	The power pursuant to Section 173(3)(d) of the Act to make written representations about why the proposed action should not be taken.

### LOCAL GOVERNMENT ACT 1999

#### Instrument of Sub Delegation

In exercise of the power contained in Sections 44 (4) and 101 of the Local Government Act 1999, I hereby sub-delegate to the To remain with Council and any person appointed to act in that position, the following powers and functions which have been delegated to me by Council pursuant to Section 44 of the Act.

#### **DEVELOPMENT ACT 1993**

##### **Council to Establish Development Assessment Panels**

The duty pursuant to Section 56A(3) of the Act to appoint a presiding member to the council development assessment panel in accordance with the requirements set out in Section 56A(3)(b) of the Act. LIMITATIONS:

The duty pursuant to Section 56A(3) of the Act to appoint the remaining members of the council development assessment panel in accordance with the requirements set out in Section 56A(3)(c) of the Act. LIMITATIONS:

The duty pursuant to section 56A(3)(d) of the Act to ensure that, unless granted an exemption by the Minister, at least 1 member of the panel is a woman and at least 1 is a man and to ensure that insofar as is reasonably practicable, the panel consists of equal numbers of men and women. LIMITATIONS:

The duty pursuant to Section 56A(3)(e) to determine the term of office for a member of the council development assessment panel, which period cannot exceed 2 years. LIMITATIONS:

The duty pursuant to Section 56A(3)(f) of the Act to determine any other conditions of appointment of the members of the council development assessment panel. LIMITATIONS:

The power pursuant to Section 56A(3)(g) of the Act to remove a member of the council development assessment panel from office for:

36.6.1 breach of, or failure to comply with, the conditions of appointment; or

36.6.2 misconduct; or

36.6.3 neglect of duty; or

36.6.4 incapacity to carry out satisfactorily the duty of his or her office; or

36.6.5 failure to carry out satisfactorily the duty of his or her office; or

36.6.6 failure to comply with a requirement under Section 34(6) or (7) of the Act or a breach of, or failure to comply with, a code of conduct under Section 21A of the Act. LIMITATIONS:

#### Committees

The power pursuant to Section 41(1) and (2) of the Act to establish committees. LIMITATIONS:

The power pursuant to Section 41(3) of the Act to determine the membership of a committee. LIMITATIONS:

The power pursuant to Section 41(4) of the Act to appoint a person as a presiding member of a committee, or to make provision for the appointment of a presiding member. LIMITATIONS:

The power pursuant to Section 41(6) of the Act to appoint the principal member of the Council as an ex officio member of a committee. LIMITATIONS:

The power and duty pursuant to Section 41(8) of the Act, to, when establishing a committee, determine the reporting and other accountability requirements that are to apply in relation to the committee. LIMITATIONS:

#### Principal Office

The duty pursuant to Section 45(1) of the Act to nominate a place as the principal office of the Council for the purposes of the Act. LIMITATIONS:

The power and duty pursuant to Section 45(2) of the Act to determine the hours the principal office of the Council will be open to the public for the transaction of business and the duty to keep the principal office of Council open to the public for the transaction of business during hours determined by the Delegate or the Council. LIMITATIONS:

The power pursuant to Section 45(3) of the Act to consult with the local community in accordance with Council's public consultation policy about the manner, places and times at which the Council's offices will be open to the public for the transaction of business and about any significant changes to those arrangements. LIMITATIONS:

#### Commercial Activities

Subject to the Act, the power pursuant to Section 46(1) of the Act to, in the performance of the Council's functions, engage in a commercial activity or enterprise ('a commercial project'). LIMITATIONS:

The power pursuant to Section 46 (2) of the Act, to, in connection with a commercial project:

12.2.1 establish a business;

12.2.2 participate in a joint venture, trust, partnership or other similar body. LIMITATIONS:

#### Meetings to be Held in Public Except in Special Circumstances

The power pursuant to Section 90(8a)(a) of the Act to adopt a policy on the holding of informal gatherings or discussions subject to Section 90(8b) of the Act. LIMITATIONS:

The power pursuant to Section 90(8c) of the Act, to, from time to time, alter the Council's policy or substitute a new policy. LIMITATIONS:

The duty pursuant to Section 90(7) of the Act to make a note in the minutes of the making of an order under Section 90(2) of the Act and the grounds on which it was made. LIMITATIONS:

## Attachment 1 - Powers to Remain With Council

### **Obstructing of Meetings**

The power pursuant to Section 95 of the Act to take proceedings under the Act against a person who intentionally obstructs or hinders proceedings at a meeting of the Council or a Council committee or at a meeting of electors. LIMITATIONS:

### **Internal Control Policies**

The duty pursuant to Section 125 of the Act to ensure that appropriate policies, practices and procedures of internal control are implemented and maintained in order to assist the Council to carry out its activities in an efficient and orderly manner, to achieve its objectives, to ensure adherence to management policies, to safeguard the Council's assets, and to secure (as far as possible) the accuracy and reliability of the Council's records. LIMITATIONS:

### **Audit Committee**

The power and duty pursuant to Section 126(1) of the Act to appoint an audit committee in accordance with Section 126(2) of the Act. LIMITATIONS:

If an audit committee is appointed by the Delegate or the Council, the power to determine the membership of any audit committee in accordance with Section 126(2) of the Act. LIMITATIONS:

### **The Auditor**

The power and duty pursuant to and in accordance with Section 128(2), (3) (4), (4a), (5), (6), (7) and (8) of the Act to appoint an auditor on the recommendation of the Council's audit committee. LIMITATIONS:

The duty pursuant to Section 128(8) of the Act to comply with any requirements prescribed by the Regulations with respect to providing for the independence of the auditor. LIMITATIONS:

The duty pursuant to Section 128(9) of the Act to ensure that the following information is included in the Council's annual report:

39.3.1 information on the remuneration payable to the Council's auditor for work performed during the relevant financial year, distinguishing between:

- 39.3.1.1 remuneration payable for the annual audit of the Council's financial statements; and
- 39.3.1.2 other remuneration;

39.3.2 if person ceases to be the auditor of the Council during the relevant financial year, other than by virtue of the expiration of his or her term of appointment and is not being reappointed to the office - the reason or reasons why the appointment of the Council's auditor came to an end. LIMITATIONS:

### **Other Investigations**

The power, pursuant to and in accordance with Sections 130A(1) and (2) of the Act, as the Delegate thinks fit, to request the Council's auditor, or some other person determined by the Delegate to be suitably qualified in the circumstances, to examine and report on any matter relating to financial management, or the efficiency and economy with which the Council manages or uses its resources to achieve its objectives, that would not otherwise be addressed or included as part of an annual audit under Division 4 of Chapter 8 of the Act and that is considered by the Delegate to be of such significance as to justify an examination under this Section. LIMITATIONS:

## Attachment 1 - Powers to Remain With Council

Unless Section 130A(7) of the Act applies, the duty pursuant to Section 130A(6) of the Act to place the report prepared pursuant to Section 130A(1) of the Act on the agenda for consideration:

41.2.1 unless Section 130A(6)(b) of the Act applies - at the next ordinary meeting of the Council in accordance with Section 130A(6)(a), of the Act;

41.2.2 if the agenda for the next ordinary meeting of the Council has already been sent to members of the Council at the time that the report is provided to the principal member of the Council - at the ordinary meeting of the Council next following the meeting for which the agenda has already been sent unless the principal member of the Council determines, after consultation with the Chief Executive Officer, that the report should be considered at the next meeting of the Council as a late item on the agenda in accordance with Section 130A(6)(b) of the Act.

LIMITATIONS:

### **Preliminary**

The power pursuant to Section 159(3) to grant a rebate of rates if satisfied that it is appropriate to do so (whether on application or on the Delegate's own initiative). LIMITATIONS:

The power pursuant to Section 159(4) of the Act to increase the rebate on the Delegate's initiative, if a rebate specifically fixed by Division 5 Chapter 10 of the Act is less than 100%. LIMITATIONS:

### **Rebate of Rates - Community Services**

The power pursuant to Section 161(1) and (3) of the Act to grant a rebate of more than 75% of the rates on land being predominantly used for service delivery or administration (or both) by a community service organisation, where that organisation:

61.1.1 is incorporated on a not-for-profit basis for the benefit of the public; and

61.1.2 provides community services without charge or for charge that is below the cost to the body of providing their services; and

61.1.3 does not restrict its services to persons who are members of the body. LIMITATIONS:

### **Rebate of Rates - Educational Services**

The power pursuant to Section 165(1) and (2) of the Act to grant a rebate of rates at more than 75% on land:

62.1.1 occupied by a Government school under a lease or license and being used for educational purposes; or

62.1.2 occupied by non-Government school registered under the Education and Early Childhood Services (Registration and Standards) Act 2011 and being used for educational purposes; or

62.1.3 land being used by University or University College to provide accommodation and other forms of support for students on a not-for-profit basis. LIMITATIONS:

## Attachment 1 - Powers to Remain With Council

### Discretionary Rebates of Rates

The duty pursuant to Section 166(1a) of the Act to take into account, in deciding an application for a rebate under Section 166(1)(d), (e), (f), (g), (h), (i) or (j):

63.1.1 the nature and extent of the Council's services provided in respect of the land for which the rebate is sought in comparison to similar services provided elsewhere in its area; and

63.1.2 the community need that is being met by activities being carried out on the land for which the rebate is sought; and

63.1.3 the extent to which activities carried out on the land for which the rebate is sought provides assistance or relief to disadvantaged persons;

63.1.4 any other matter considered relevant by the Council or the Delegate. LIMITATIONS:

The power pursuant to Section 166(1), (2) and (4) of the Act and taking into account Section 166(1a) of the Act and in accordance with Section 166(3b) of the Act to grant a rebate of rates or service charges on such conditions as the Delegate sees fit and such rebate may be up to and including 100% of the relevant rates or service charge, in the following cases:

63.2.1 where the rebate is desirable for the purpose of securing the proper development of the area or part of the area;

63.2.2 where the rebate is desirable for the purpose of assisting or supporting a business in the area;

63.2.3 where the rebate will be conducive to the preservation of buildings or places of historic significance;

63.2.4 where the land is being used for educational purposes;

63.2.5 where the land is being used for agricultural, horticultural or floricultural exhibitions;

63.2.6 where the land is being used for a hospital or health centre;

63.2.7 where the land is being used to provide facilities or services for children or young persons;

63.2.8 where the land is being used to provide accommodation for the aged or disabled;  
LIMITATIONS:

The power pursuant to Section 166(3) of the Act to grant a rebate of rates or charges for a period exceeding 1 year but not exceeding 10 years in the following cases:

63.3.1 where the rebate is desirable for the purpose of securing a proper development of the area or part of the area; or

63.3.2 where the rebate is desirable for the purpose of assisting or supporting a business in the area; or

63.3.3 where the rebate relates to common property or land vested in a community corporation under the Community Titles Act 1996 over which the public has a free and unrestricted right of access and enjoyment. LIMITATIONS:

The power pursuant to Section 166(3a) of the Act to grant a rebate of rates or charges under Section 166(1)(l) of the Act for a period exceeding 1 year but not exceeding 3 years.

LIMITATIONS:

## Attachment 1 - Powers to Remain With Council

### Valuation of Land for the Purpose of Rating

The power pursuant to Section 167(1) of the Act to adopt valuations that are to apply to land within the Council's area, for rating purposes for a particular financial year. LIMITATIONS:

For the purpose of adopting a valuation of land for rating, the duty pursuant to Section 167(2) of the Act and in accordance with Section 167(3), (4) and (5) of the Act, to adopt:

64.2.1 valuations made, or caused to be made, by the Valuer-General; or

64.2.2 valuations made by a valuer employed or engaged by the Council, or by a firm or consortium of valuers engaged by the Council;

or a combination of both. LIMITATIONS:

### Payment of Rates - General Principles

The power pursuant to Section 181(11) of the Act to grant discounts or other incentives in order to encourage:

73.7.1 the payment of instalments of rates in advance; or

73.7.2 prompt payment of rates. LIMITATIONS:

The power pursuant to Section 181(12)(b) of the Act to impose a surcharge or administrative levy not exceeding 1% of the rates payable in a particular financial year with respect to the payment of rates by instalments under Section 181(4)(b) of the Act. LIMITATIONS:

The power pursuant to Section 181(15) of the Act to decide that rates of a particular kind will be payable in more than 4 instalments in a particular financial year and in such case:

73.10.1 the instalments must be payable on a regular basis (or essentially a regular basis) over the whole of the financial year, or the remainder of the financial year depending on when the rates are declared; and

73.10.2 the Delegate must give at least 30 days notice before an instalment falls due.

LIMITATIONS:

### Remission and Postponement of Payment

The power pursuant to Section 182(3) of the Act to grant other or additional postponements of rates:

74.3.1 to assist or support a business in the Council's area; or

74.3.2 to alleviate the effects of anomalies that have occurred in valuations under the Act. LIMITATIONS:

The power pursuant to Section 182(4) of the Act to grant other or additional remissions of rates on the same basis as applies under the Rates and Land Tax Remission Act 1986, (such remissions will be in addition to the remissions that are available under that Act). LIMITATIONS:

The power pursuant to Section 182(6) of the Act to revoke a determination under Section 182(4) of the Act at any time (but the revocation will not effect an entitlement to remission in relation to rates declared before the revocation takes effect). LIMITATIONS:



## Attachment 1 - Powers to Remain With Council

The power pursuant to Section 182(1) of the Act to decide on the application of a ratepayer that payment of rates in accordance with the Act would cause hardship and, if so, to:

74.1.2 remit the rates in whole or in part. LIMITATIONS:

### **Postponement of Rates - Seniors**

#### E - POLICY STATEMENT

1. Council supports the objectives of the Development Act 1993 [and Planning, Development and Infrastructure Act 2016](#).
2. Council actively supports the growth of the City through appropriate development that maintains and enhances the social, economic and environmental conditions desired by the community.
3. Council acknowledges that an effective and efficient development assessment system is critical to the achievement of community and council goals.
4. The authority to determine development applications is delegated to Authorised Officers where timely decisions can be made, except for those classes of applications delegated to the [Development-Council](#) Assessment Panel.
5. The [Development-Council](#) Assessment Panel will determine the following types of development applications;
  - Applications where third party representors indicate a desire to be heard by the relevant authority.
