1. BACKGROUND

- 1.1 On 27 May 2019, Council adopted the recommendations of the Policy and Planning Committee meeting, Contained in the report to Council (Item No. 5.1 on the agenda for the Council meeting held on 27 May 2019), and listed below:
 - 1. That it be noted that:

1.1.2 Public Art Framework

- 1. The Public Art Framework be endorsed.
- 2. Elected Members Cr M Blackmore and Cr K Grenfell to be appointed to a Public Art Panel to assist with guiding public art development consistent with the Public Art Framework.

- 3. Public Art Panel Terms of Reference in Attachment 7 of this report be endorsed.

- 6. Note that the administration will further develop projects through the Public Art Program (Create a Place) in consultation with the Public Art Panel.
- 7. Mayor G Aldridge be appointed as ex-officio member of the Public Art Panel.
- 1.2 This report provides Council with a budget bid for 2020/21 for development of a major artwork.
- 1.3 Following a review of public art sites, the Salisbury Art trail is to be promoted on Discover Salisbury in the New Year. Following completion of an audit, further information regarding maintenance and upgrade of existing public art works across the City will also be reported.
- 1.4 Public art is used throughout the world to enliven areas, create a sense of pride and belonging, create a wayfinding and points of interest, generate economic activity, and improve amenity within the community.
- 1.5 The City Plan Vision includes the following desired outcomes that can be linked with the public art agenda;
 - Well designed and maintained neighbourhoods and places that are inclusive and accessible
 - New communities and a regeneration of existing urban areas
 - Increased investment and a wider range of job opportunities
- 1.6 Under the heading "the Livable City" the following actions are relevant;
 - Enhance our neighbourhoods, streets and public spaces so they are welcoming and connected
 - Provide experiences that make our places livelier and more interesting
 - Provide opportunities for the community to engage in learning

- 1.7 The City Pride Strategy 2020 has a strong focus on improving the public realm and working collaboratively with ratepayers, residents, traders and organisations to improve the amenity and visual appearance of the City.
- 1.8 City Pride Strategy 1.6 states "Improve the appearance of non-residential areas" with the following critical action "Pilot a project, working in partnership with local businesses in a non-residential area, to improve streetscape appearance including the frontage of private properties".
- 1.9 Community street and public art can also contribute to the City of Salisbury Tourism and Visitor Strategy 2016-2021. Objective 3 seeks to "create new visitor experiences that address identified gaps, capitalise on key themes, precincts and attractions; and increase visitor spend". Strategy 3.6 specifically states to "work with industry, community groups and tourism stakeholders to develop new tourism and visitor attractions, products and experiences". One of the key areas of focus for strategy 3.6 is arts and culture.
- 1.10 There have been a number of community and public art projects undertaken at locations across the City of Salisbury over an extended period of time; however most of these have been one off projects that have not been integrated into a single city-wide approach.
- 1.11 A cultural development review was undertaken in 2014 and this has been referenced in the development of the Public Art Framework endorsed by Council in May 2019.

2. CITY PLAN CRITICAL ACTION

- 2.1 The City Plan Vision outlines the following outcomes if the plan is achieved. These outcomes include;
 - Well designed and maintained neighbourhoods and places that are inclusive and accessible
 - New communities and a regeneration of existing urban areas

 - Enhance our neighbourhoods, streets and public spaces so they are welcoming and connected

- 3.2.2 Community consultation through an online survey was conducted where feedback was received regarding themes and locations.
- 3.2.3 An expression of interest process was conducted to identify locations and artists for projects through the Public Art Program (Create a Place).

4. REPORT

- 4.1 The Public Art Framework provides Council and the broader communities with a guide to better understand, make use of, and develop public art with a more consistent approach. In developing the framework the cultural development review undertaken in 2014 and the mapping Salisbury strategy in 2009 have helped to inform the development of the Public Art Framework.
- 4.2 Through community consultation workshops, the following themes in the following table were identified and are used by the Public Art Panel to develop and regulate Public Art across the City of Salisbury.

4. Key Themes

In developing and regulating public art within the City of Salisbury, Council will reference the following themes that are based directly on feedback from the community.

Artwork Locations

- 4.3 The Public Art Framework supports that public art is developed in locations that provide a sense of place and establishes distinctive markers within the landscape that mark an arrival into the City of Salisbury and its key precincts.
- 4.4 An example of these locations include:
 - Entrances to the City of Salisbury
 - Major traffic thoroughfares or intersections
 - Prominent parks or places

Feature Artworks

- 4.5 The Public Art Framework seeks support and/or facilitating the development of up to four feature artworks over the next ten years in the City of Salisbury.
- 4.6 Staff have been working with the Public Art Panel to scope a piece of major work (major work being of significant size and scale, and likely to exceed the total budget of the Public Art Program) for consideration as part of the 2020/21 budget process.
- 4.7 The Public Art Panel recommend a budget bid be included for consideration by Council for up to \$200,000 in the 2020/21 financial year, to complete one (1) feature artwork
- 4.8 As per the Public Art Framework, the location should be of significance either as an entry to the City or highly visible to large numbers of people.
- 4.9 Subject to endorsement, further consideration will be given to preferred locations with a further report prepared for Council consideration of locations in March 2020.
- 4.10 Once a site has been selected, should funds be included in the 2020/21 budget for the project, the appropriate procurement process will be undertaken to seek designs that are considerate of the selected location.

5. CONCLUSION / PROPOSAL

- 5.1 The Public Art Framework seeks support and/or facilitating the development of up to four feature/hallmark artworks over the next ten years in the City of Salisbury.
- 5.2 The Public Art Panel recommend a budget bid be included for \$200,000 for consideration through the 2020/21 financial year budget process.
- 5.3 Subject to endorsement, staff will seek external funding towards the project to reduce the overall Council contribution.
- 5.4 Staff will continue to work with the Public Art Panel to identify suitable locations with a further report to be brought back to Council in March 2020 with recommendations.

It will identify opportunities for public art and give advice regarding the Salisbury Art Trail. Members of the Public Art Panel will act as ambassadors and advocates for quality public art in the City of Salisbury.

TERMS OF REFERENCE

To provide advice on:

Public Art Framework:

- · Review and comment on Public Art prior to it being considered by Council for endorsement;
- Identify key issues relating to the strategic development and management of public art and its contribution to the City of Salisbury;
- Ensure feedback to Council staff regarding the opportunities for public art within the City of Salisbury;
- Monitor progress of all public art activities through meetings on an as needs basis.

Outdoor Gallery Projects:

- As appropriate and/or required by the Public Art Panel, assess and advise on public artwork proposals:
- Review and advise on artist briefs and short listed artists.

Integrated Art Projects:

- · Identify public art work potential within significant capital works project;
- Review and recommend Artists for Public Art Program (Create a Place) projects;
- Recommend public art projects identified as appropriate for the Public Art Program (Create a Place);
- · Comment on artists proposals as required.

Existing Public Art Collection:

- When required provide advice on artistic and cultural value of artworks;
- When required provide advice on priorities for asset management funding allocation;

 When required provide advice on removal, relocation, sale or disposal of public art deaccessioning.

External Public Art

• When required provide advice on Public Art proposals from external groups or individuals.

CONDUCT

The Public Art Panel will operate according to principles of mutual respect, confidentiality and civility and will be under the direction of the Convener. As the Public Art Panel will not be a decision-making forum, there will be no provision for formal voting or adoption of positions.

While the Convener will seek to facilitate consensus where relevant, it is anticipated (and desirable) that the Public Art Panel express a range of differing views on any particular public art issue. The Public Art Panel members will have a copy of their Terms of Reference at each meeting as a standing agenda item so that roles and responsibilities are clearly understood and open.

MEMBERSHIP

The Public Art Panel will be formed on a needs basis and consist of relevant local and industry experts relevant to Panels deliberations at the time of formation. It is intended that the arts community representative and the community representative would be selected in consultation with the Elected Members at the time of formation, and that the selection of representatives would be dependent on the expertise and advice required at the time of formation. It is not intended that the Panel meet on a regular basis unless required and/or be formed with the same membership in an ongoing way with the exception of the Elected Member Representation. The Public Art Panel membership will be comprised of:

- Two (2) Council Elected Members
- One (1) Arts Community Representative
- One (1) Community Representative
- One (1) Council staff representative

The Public Art Panel may request focus groups as required to consult with additional Key Stakeholders. No sitting fees will be paid to members of the Public Art Panel.

MEETINGS

The Round Table will meet as required, at dates/times and in a location determined by the Chief Executive Officer (or nominee) after consulting with the members of the Public Art Panel. Notes from Public Art Panel meetings may be reported to Council if required.

1. BACKGROUND

- 1.1 Community street and public art programs are used throughout the world to enliven areas, create a sense of belonging, generate economic activity, improve amenity and provide upskilling opportunities within the community.
- 1.2 At the Council Meeting on 24 June 2019, Council resolved:

"That a report be prepared by December 2019 providing advice on the establishment of a 'stobie pole painting' policy, as part of our street art program, including operational rules and guidelines, and potential for funding/grant options that provide residents with the opportunity to make proposals to decorate stobie poles, to support Salisbury's Liveable City agenda".

1.3 This report provides Council with a draft policy for consideration and subject to any feedback, also seeks endorsement of the policy.

- 4.1 Opportunities for creative contributions from community groups and local schools in the form of community and public art installations for SA Power Networks stobie poles and/or City of Salisbury light poles are being encouraged through the development of a process around artwork on stobie poles, light poles and similar infrastructure.
- 4.2 This application process ensures that relevant stakeholders within proximity of the infrastructure are consulted with and that the proposed artwork is both safe and reflective of City of Salisbury and community values.
- 4.3 Stobie poles are the property of SA Power Networks. Applicants must first obtain written approval from the City of Salisbury who will make an application to SA Power Networks.
- 4.1 Many light poles within the City of Salisbury are owned and managed by the City of Salisbury; applications for artwork on this infrastructure must be forwarded to the City of Salisbury in the first instance for approval.
- 4.2 As part of the Public Art Framework, staff have developed a process around artwork on stobie poles, light poles and like-minded infrastructure which includes;
 - Guidelines for public art on stobie poles, light poles and like-minded infrastructure.
 - Application form for artwork on stobie poles, light poles and like-minded infrastructure.
 - Template letter for neighbouring property owners.

- Applicants are responsible for the preparation, maintenance and removal of any authorised artwork on the relevant infrastructure. This includes the application of suitable durable and safe paint product or equivalent.
- 4.3 This process is to assist in the streamlining of the SA Power Networks process for community groups or local schools that may wish to explore this as an opportunity.
- 4.4 The Public Art Panel has recommended that these groups are eligible to apply for the Create a Place Public Art Project funding to cover the cost of supplies up to the value of up to \$200 per project. It be noted that no more than \$5,000 is expended annually on stobic pole art applications from the current Create a Place Public Art funding.
- 4.5 An application to apply stobie pole art is not an assurance of approval, and that any application still must meet associated guidelines and budgetary requirements, where Council choose at its absolute discretion to assist with funding an application.
- 4.6 Clause 2 of the Terms and Conditions within the application process requires any applicant to provide their own applicable insurance cover. The intent of this program should not be for Council to cover the insurance requirements of any requests.

Promotion

- 4.7 This information will be hosted on the City of Salisbury website with appropriate guidelines and application form; further enquiries can be directed to Community Planner Arts & Culture.
- 4.8 Additional promotion on Facebook via a post with a link back to the website will be scheduled once information has been loaded on the website.

5. CONCLUSION / PROPOSAL

- 5.1 The proposed stobic poles, light poles and like-minded infrastructure guidelines and application process will assist in the streamlining of the SA Power Networks process for community groups or local schools that may wish to explore this as an opportunity.

The City of Salisbury understands the benefits of public art and is committed to the development of public art that enhances the landscape throughout the neighbourhoods, retail centres, civic places and green spaces across the City. From a policy perspective, Council has many roles in relation to public art; it is both manager and regulator but also a facilitator and developer that creates public art both independently and in collaboration with other stakeholders.

The City of Salisbury encourages creative opportunities for individuals and community groups where they look to express this creativity on stobie and light poles and like-minded infrastructure. This application process ensures that relevant stakeholders within proximity of the infrastructure are consulted with and that the proposed artwork is both safe and reflective of City of Salisbury and community values.

Stobie-Poles are the property of SA Power Networks. Applicants must first obtain written approval from the City of Salisbury who will make an application to SA Power Networks. Many light poles within the City of Salisbury are owned and managed by the City of Salisbury; applications for artwork on this infrastructure must be forwarded to the City of Salisbury in the first instance for approval. Approved artwork on any stobie or light pole does not confer ownership or copyright of this infrastructure to any party other than the owner of the infrastructure.

Before seeking Council approval to place artwork on a stobie or light pole the artist must consider:

- Requests must be made in writing via this Proposal of Stobie-Pole & Light Poles Artwork Application Form to Council, and will, as part of the approval process be forwarded to SA Power Networks for applications for stobie-poles;
- The artwork shall not be higher than two (2) metres from ground level;
- The artwork does not constitute commercial advertising e.g. business name or logo, political material, local messages or directions or any other material likely to offend;
- Certain colours and combination of colours arranged in a particular pattern have become associated with trades or firms and will be regarded as commercial advertising and therefore banned from display on stobie and light poles;
- The six (6) adjoining residents directly adjacent the proposed site must be consulted with and provide approval prior to commencement of the artwork;
- The artist is responsible for all ongoing maintenance of the artwork, and understands that if
 the artwork is vandalised or breaches any terms and conditions, SA Power Networks or
 Council will paint over the artwork at their discretion. Where the artwork is proposed to be
 exhibited for a long term the artist is encouraged to apply an anti-graffiti coating;
- The applicant will ensure the materials used are fit-for-purpose and do not pose any risk to the public or infrastructure. During preparation and painting the applicant must consider the safety of the artist and the public, e.g. use of hazard cones, bunting and high visibility vests, or the implementation of a traffic management plan where appropriate; the applicant must remove and appropriately dispose of all excess materials and waste from the site and
- The City of Salisbury is supplied with digital images of the proposed artwork as part of this
 application and digital images of any completed artwork.

Applications to apply artwork will not be granted for:

- Ground mounted equipment, enclosures, inspection point covers or like-minded infrastructure;
- Stobie and light poles containing equipment such as pole top transformers, high voltage isolators, capacitors, under/over cable arrangements;
- Identification marks such as switching point identifiers i.e. DF and AB numbers or asset identifiers i.e. public light numbers;

I acknowledge that as the Applicant I shall be responsible for the prepration, ongoing maintenance and removal of the proposed artwork, and understand that if the artwork is vandalised or breaches any terms and conditions Council, in consultation with SA Power Networks, will paint over the artwork at their discretion. All artwork will be applied with fit-for-purpose products and sealed with an anti-graffiti finish.

SUMMARY

The Salisbury Oval Master Plan was originally endorsed by Council in March 2017 and put in place a framework for the development of Salisbury Oval as an integrated recreation, sporting, open space and residential precinct. The Master Plan strongly aligned with the strategic directions contained in Council's Salisbury City Centre Renewal Strategy.

Since Council's endorsement of the Masterplan new community expectations for sport and recreation land and facilities on Salisbury Oval have arisen. There have also been concerns expressed over the proposed residential development on the former St Jays site.

As a result of this feedback Council reconsidered aspects of the Master Plan, and at the 23 April 2019 Council meeting passed a resolution to amend the Master Plan (*Resolution 0132/2019*)

Council endorsed a revised community consultation program for aspects of the Salisbury Oval Master Plan in September 2019 (*Resolution 0270/2019*) with a further report to be brought back from the public consultation detailing the findings, including any plan modification and associated budget adjustments required to align with community feedback.

This report addresses the community feedback received as a result of community engagement program conducted during October and early November 2019.

RECOMMENDATION

- 1. That the report be received
- 2. That council notes the summary report from GHD on the Community Engagement program on the revised Salisbury Oval Master Plan conducted in October and early November 2019, forming Attachment 1 to the Policy and Planning Committee Agenda 9/12/2019 Item 1.1.4.
- 3. That Council endorses proceeding to the detailed design and construction phases of the recreation facilities and landscape for Brown Terrace, in alignment with existing budget provisions of \$2.7m for sports and recreation upgrades to the Oval precinct and design plans shown in the recent community engagement program (Attachment 2 Salisbury Oval Masterplan Precinct Plans Policy and Planning Committee Agenda 9/12/2019 Item 1.1.4)
- 4. Council endorses the retention of the portion of the former St Jays Site and the former Salisbury Bowling Club Land purchased by Council for development designated on the revised Master Plan as 'Future Development Site' for the purposes of future non-recreational or sporting uses in accordance with the objectives of the Salisbury City Centre Renewal Strategy.
- 5. A further report be brought back through the Strategic Property and Development Sub Committee by April 2020 regarding options for development of the 'Future Development Site' designated in the revised Salisbury Oval Master Plan (portion of the former St Jays Site and the former Salisbury Bowling Club Land purchased by Council for development), having regard to development options identified in the Council's community engagement process.

1. BACKGROUND

- 1.1 The Salisbury Oval Masterplan endorsed by Council March 2017 put in place a framework for the development of Salisbury Oval as an integrated recreation, sporting, open space and residential precinct. The masterplan is strongly aligned with the strategic directions contained in Council's approved Salisbury City Centre Renewal Strategy, and is nominated by Council as a Critical Action in the City Plan 2030.
- 1.2 The development of the Masterplan involved extensive community engagement and the end Masterplan endorsed by Council reflected community engagement outcomes at the time.
- 1.3 Since Council's endorsement of the Masterplan new community expectations for sport and recreation land and facilities on Salisbury Oval have arisen. These changed community expectations were reflected in a petition from 2081

- signatories received by Council at its December 2018 meeting (*Resolution 0042/2018*), opposing the sale of land at Neales Green and portions of Salisbury Oval.
- 1.4 The Salisbury Football Club also expressed revised requirements regarding future playing and training facility needs since the consultation on the original Master Plan.
 - These changed community expectations were addressed in a report to Council's Strategic Property Development Sub-Committee (SPDSC) in March 2019.
- 1.5 The SPDSC recommended and Council subsequently resolved at its March 2019 meeting:
 - 1. Consideration of this matter (SPDSC2, Strategic Property Development Sub Committee 13/03/2019) be deferred to the April 2019 meeting of the Strategic Property Development Sub Committee pending the outcome of a confidential workshop to be convened in relation to the Expression of Interest Process.
 - 2. New construction works associated with landscaping, access into the Salisbury Oval and the provision of other sport and recreation facilities at Salisbury Oval be placed on hold pending the outcome of the confidential workshop and consideration of this item.

 (Resolution 0116/2019)
 - 6 Council, at its 23 April 2019 meeting resolved that:
 - 1. That the information be received.
 - 2. That Council confirms that Neales Green and all of Brown Terrace, including section of Brown Terrace known as St Jays Site (level with Salisbury Oval boundary fence along Brown Terrace), be removed from consideration for residential development, and that the Salisbury Oval Masterplan be amended to reflect this.
 - 3. That Council confirms its commitment to retain Neales Green and all of Brown Terrace as community land for recreation purposes and authorises staff to begin process to reclassify this land to Community Title.
 - 4. Staff continue discussions with and negotiations with Sportsman Association and Salisbury Football Club regarding the use of Neales Green for future use for junior training and games.
 - 5. That staff bring back detailed design of recreation facilities and landscaping for Brown Terrace, including play equipment, nature play space and adult exercise equipment. Detailed design to go out for public consultation and subject to public consultation with local residents, ratepayers and community groups, then be incorporated into the Salisbury Oval Master Plan.
 - 6. Staff bring back a report with design and costing of a public toilet to be installed at the Neales Green end of Brown Terrace to service the public and the Club. The provision of toilet facilities be included in the public consultation process for detailed design of landscaping and recreational facilities along Brown Terrace.
 - 7. That the balance of residential parcels (St Jays site and Bowling Club land) identified in the Salisbury Oval Master Plan does not proceed until further public consultation occurs with local residents, ratepayers and community groups regarding the proposed density of housing and invite local residents and the community to provide feedback about other potential land uses for this

- site, such as a medical facility, nursing home or other suggestions made by the community.
- 8. Council defer consideration of the access road depending outcome of consultation as per part 7.
- 9. That staff bring back a further report to the Policy and Planning Committee about public consultation process to be undertaken and revised draft Salisbury Oval Master Plan incorporating changes outlined in part 2, 5 and 6 of this Motion. - 4.1 In alignment with the endorsed consultation plan the consultation period for the Amended Salisbury Oval Master Plan ran from 9th October 9th November 2019.
- 4.2 During this period a variety of engagement activities were undertaken (as highlighted in attachment 1 "Community Engagement Outcomes Report") which consisted of:
 - 4.2.1 Online Survey
 - 4.2.2 Notices print media
 - 4.2.3 "Have Your Say" City of Salisbury Website
 - 4.2.4 Social Media Campaign
 - 4.2.5 Mail out to 1563 properties in the area surrounding the Salisbury Oval
 - 4.2.6 Door knock of 78 properties
 - 4.2.7 Meeting with representatives of the Salisbury Oval Sportsman's Association, Salisbury Football Club and Salisbury Cricket Club
- 4.3 A total of 223 responses were received through the survey with a further eight responses received via phone and email that have been included within the report.
- 4.4 The detailed findings can been seen in attachment 1 'Community Engagement Outcomes Report" sections;
 - 4.2 Survey Response Summary
 - Appendix A Survey Responses

- 4.5 In alignment with Council's resolution (*Resolution 0270/2019*) the community engagement included promotion of the amended Salisbury Oval Master Plan and sought feedback on three key areas;
 - 4.5.1 Recreation facilities and landscaping for Brown Tce, including a portion of the former St Jays land.
 - 4.5.2 Public toilet facilities
 - 4.5.3 Future development site (portion of the former St Jays Site, and former Bowling Club land purchased by Council for development.)

Brown Terrace Recreation Facilities and Landscaping

- 4.6 The consultation design for Brown Tce included multiple recreation facilities, open space and landscaping consisting of the following key elements;
 - 4.6.1 Playground
 - 4.6.2 Multi-use games area
 - 4.6.3 Adult exercise equipment
 - 4.6.4 Fitness loop
 - 4.6.5 Picnic setting
 - 4.6.6 Bike racks
 - 4.6.7 Landscaping
 - 4.6.8 Kick-about space
 - 4.6.9 Nature play area
- 4.7 All the key elements ranked highly amongst the respondents.
- 4.8 During the consultation period there was some comments made about the suitability of the former St Jays site to host senior football. Meetings were held with the Salisbury Oval Sportsman's Association, Salisbury Football Club, and Salisbury Cricket Club to discuss this matter and other aspects of the amended Salisbury Oval Master Plan. All of these key stakeholders have indicated that they have no interest in the former St Jays site for senior football and understand the impact on the character of the site if the site was prepared for junior football.

Public Toilet Facilities

- 4.9 The consultation provided the opportunity for feedback regarding the installation of a public toilet facility in the recreation space.
- 4.10 90% of the respondents selected 'yes' for the installation of a toilet facility.
- 4.11 60% of those respondents agreed that the toilet facility should be located near the Neales Green end of the proposed recreation space.

Future Development Site

4.12 In alignment with the Council resolution, consultation was undertaken as follows with three key survey questions (detailed findings can be seen in attachment 1, noting that question 16 and 17 were optional);

- 4.12.1 Q15 Would you like to comment on the use of the future development site (formerly home to St Jay's Recreation Centre and former Bowling Club Land)
 - 203 of the total 223 respondents (91%) answered 'yes' and 18 respondents answered 'no' to Question 15. 20 respondents skipped this section.
- 4.12.2 Q16 if Housing was selected as the preferred development for the site what types(s) of housing do you consider appropriate (check all that apply)?
 - 74 of the 203 respondents to Question 16 (which equates to 33% of the total survey respondents) selected at least one option for this question. Responding to this question was not mandatory and could be skipped in the on-line and interview/phone survey.
 - Of those who answered this question, the most numerous of which were single storey detached housing and single storey row housing
- 4.12.3 Q17 What other development would you support for the former St Jays Site (Check all that apply)?
 - 192 of the respondents to Question 17 (which equates to 86% of the total survey respondents) selected at least one option for this question. Responding to this question was not mandatory and could be skipped in the on-line and interview/phone survey.
 - 45 respondents selected medical facility (which equates to 23% of the total survey respondents)
 - 38 respondents selected nursing home (which equates to 20% of the total survey respondents)
 - 145 respondents provided alternative options, the most numerous of which were recreational uses (suggested by 103 of the respondents to Question 17, which equates to 70% of the total respondents). Multiple suggestions were made regarding alternative options.

4.13 Having regard to:

- the total number of respondents to the survey overall and to this section of the survey;
- the disparate nature of the survey responses in relation to the 'Future Development Site';
- the outcomes of previous surveys undertaken in relation to the Salisbury Oval Master Plan; and
- the Council's endorsed objectives and strategies for the broader Salisbury
 City Centre precinct outlined in the Salisbury City Centre Renewal
 Strategy, City Plan 2030, and associated strategic documents, and the role
 the Salisbury Oval precinct plays in the attainment of those objectives;

it is considered that the 'Future Development Site' designated on the revised master plan be confirmed by Council for future non-recreational and sporting development, and that the nature and type of future development be considered through a future report to Council through the Strategic Property

Development Sub-Committee. Options for development on this site should be assessed against the attainment of Council's endorsed strategic objectives under the Salisbury City Centre renewal Strategy and associated documents.

In the current Long Term Financial Plan, Council has included estimates of potential costs and income associated with the investment into the Salisbury Oval Masterplan.

As noted earlier in this report the recreational components of the plan, including the recent community feedback, can be delivered within the planned budget.

In regard to the planned income associated with the development of the future development sites, Council will based on the outcome from the further consideration need to make the appropriate adjustments to the Long Term Financial Plan.

5. CONCLUSION / PROPOSAL

- 5.1 In alignment with the endorsed consultation plan a community engagement program was conducted for the Amended Salisbury Oval Master Plan between 9th October and 9th November 2019
- 5.2 Feedback received indicates that there is strong support in the community for proceeding with the recreation facilities along Brown Terrace, and it is recommended that this part of the Salisbury Oval Master Plan be progressed to finalising the design and construction.
- 5.3 Feedback from the consultation on the former St Jays site will be used to inform the future development options of this site in line with the Master Plan and Salisbury City Centre Renewal Strategy, and a further report will be prepared for consideration by the Strategic Property Development Sub-Committee in April 2020 canvassing options for this site.
- 5.4 Council support for the development of the St Jays and adjacent Bowling Club site for usage other than recreation/open space is considered appropriate in light of the response to the Community Consultation, and having consideration to Council's endorsed objectives and strategies for the broader Salisbury City Centre precinct outlined in the Salisbury City Centre Renewal Strategy, City Plan 2030, and associated strategic documents



1. Introduction

In response to changing community needs and sentiment, the City of Salisbury (Council) recently amended the Salisbury Oval Masterplan. The City of Salisbury engaged GHD Pty Ltd (GHD) to prepare and deliver an appropriate community engagement strategy to facilitate the involvement of the community, and key stakeholders, to provide input and refine the design of the proposed recreational spaces at Salisbury Oval adjacent to Brown Terrace, including Neales Green. The engagement process also included seeking feedback from the community on the density of housing, and other potential land uses for the former St Jay's Recreation Centre site.

An online survey was created to give the community and key stakeholders the opportunity to provide their feedback and comments on these topics. In order to give a wide and diverse proportion of the community the opportunity to participate in this survey, a series of engagement activities were undertaken:

- Properties within the line of sight of the Salisbury Oval Precinct were doorknocked.
 These residents were informed about the project and given the opportunity to participate in the survey with the assistance of the project team
- A letter containing the amended masterplan was sent to all properties within 500 metres of the precinct
- The broader community were notified through public notices published on the Weekly Northern Messenger, the City of Salisbury 'Have Your Say' Website and the City of Salisbury Facebook page.

All notices and letters included information about the project and details on how to participate in the online survey.

This Outcomes Report elaborates on these activities and presents and summarises the key themes and results captured during the engagement period of the amended Salisbury Oval Masterplan.

2. Background

In 2017, as part of its program of investment, the City of Salisbury endorsed an integrated recreation and residential masterplan for the development of Salisbury Oval as a key destination within the Salisbury City Centre Renewal.

The Salisbury Oval Masterplan sought to improve open space, optimise social and economic outcomes, deliver high quality built form and improve pedestrian and vehicle movements. The vision for Salisbury Oval was to create a High quality integrated precinct that provides a complementary mix of amenities including a premier sporting facility, open space, community services and residential areas which are accessible and have strong links to the Salisbury City Centre and surrounding areas.

Through extensive community engagement the City of Salisbury asked for feedback on the Salisbury Oval Masterplan and community land revocation before the Masterplan was approved in March 2017. Since that time, the needs of the sporting clubs based at Salisbury Oval have changed, particularly the Salisbury Football Club, and some residents also raised concerns about the loss of recreation and open space along Brown Terrace.

While a range of works has commenced on the sporting recreation projects, the City of Salisbury at its meeting on 23 April 2019, resolved that Neales Green and all of Brown

Terrace be removed from consideration for residential development, and that the Salisbury Oval Masterplan be amended to reflect this.

It was decided that residential parcels identified in the previous Masterplan at the former St Jay's site not proceed until further public consultation occurs. In addition, future consultation was to consider the proposed density of housing and invite the community to provide feedback about other potential land uses for this site.

1.1 Legislative requirements

This project does not have a legislated consultation requirement, but allows for a 21 day consultation period which aligns with the City of Salisbury's Public Consultation Policy.

1.2 Community Engagement

Section 194(2) of the Local Government Act 1999 states the City of Salisbury must follow the relevant steps set out in its Community Engagement (Public Consultation) Policy.

Before the City of Salisbury proceeds with the Masterplan, community engagement should be carried out to provide an opportunity for local residents, key stakeholders, businesses, site users and the broader community to provide feedback.

1.3 Previous engagement

The following table lists all previous engagement activities undertaken with regards to the Salisbury Oval Masterplan.

3. Overview of Community Engagement Activities

In order to reach a wide and diverse proportion of the community, a series of engagement activities were undertaken.

3.1.1 Survey

An online survey was created to give the community the opportunity to provide feedback on the Amended Salisbury Oval Masterplan. of the survey's key objective was to give the community the opportunity to provide input into the design of the proposed recreational spaces on Brown Terrace, location of toilet facilities and to give feedback on the density of housing, and other potential land uses for the former St Jay's Recreation Centre site, such as a medical facility, nursing home or other suggestions made by the community.

The survey was divided into three sections for comment:

- Recreational space along Brown Terrace
- Public toilet facility
- · Future development on the former St Jay's Site.

The survey used skip logic which allowed participants to customise their responses based on their interests. The survey opened on 9 October 2019 and closed on the 9 November 2019. There were four ways in which the community could complete the survey:

- Online
- Doorknock
- Telephone
- Email.

3.1.2 Notices - print media

A public notice was published in the Northern Weekly Messenger on 9 October 2019 (a copy of this notice can be found in Appendix B) informing the broader community about the Salisbury Oval Masterplan project and inviting them to provide their feedback via the survey.

3.1.3 'Have Your Say' - the City of Salisbury website

The City of Salisbury's 'Have Your Say' website informed users of the amended masterplan and survey on recreational space design and future development site preferences. A link to the online survey was also provided.

3.1.4 Social media campaign

A notice was published on the City of Salisbury's Facebook account to notify the broader community about the project and invite them to provide their feedback via survey. Elected Members were encouraged to share this link on their personal social media pages. (A copy of this notice can be found in Appendix B)

3.1.5 Mail out

Letters were sent out to the residents and owners of all properties within 500 metres of the Salisbury Oval Precinct indicated in Figure 1Error! Reference source not found. The letter informed recipients of the amended masterplan and invited them to participate in an online

survey. A phone number and email were provided for residents who needed assistance to complete the survey or had any queries. (A copy of this letter can be found in Appendix B)

3.1.6 Doorknock




Figure 1 Doorknock survey and mailout area

The project team undertook a doorknock to all houses that were within the line of sight of the Salisbury Oval Precinct as indicated in Figure 1. The purpose of the doorknock was to ensure that residents of these properties were informed about the project, could have any questions answered and undertake the survey with assistance if needed.

4. Community Engagement Outcomes

The consultation period for the Amended Salisbury Oval Masterplan went from 9 October – 9 November 2019. During this period a total of 223 responses were received through the survey regarding the amended Masterplan.

In addition, another eight responses were received (via phone and email), that had insufficient detail to be logged in the survey results. However, these responses have been considered in this report.

In order to provide a greater level of transparency in reporting the community engagement outcomes, the City of Salisbury engaged GHD to undertake the engagement and analyse the results.

4.1 Engagement Activity Summary

4.1.1 Mailout




Figure 2 Houses that completed online survey with doorknock team

Letters were sent out to 1,563 residents and owners of all properties within 500 metres of the Salisbury Oval Precinct indicated in Figure 2

- 36 letters came back as return to sender
- 8 of these were within the doorknocking zone.

The letter informed properties of the project and provided:

- · Information about the project
- Amended Salisbury Oval Masterplan
- · Link to online survey and the City of Salisbury's Have Your Say website.

4.1.2 Survey (doorknock)

The project team doorknocked properties within line of site of the Salisbury Oval Precinct (doorknock catchment area) as indicated in Figure 1. The objective of the doorknock was to provide residents who would be directly impacted by the project the opportunity to participate in the survey, with the assistance of a project team member. The survey team doorknocked all houses within the catchment area twice over a two day period to try and capture as many residents as possible.

- 78 houses were doorknocked
- 17 houses completed the survey (as illustrated with purple dots Figure 2).

Residents who didn't want to participate in the survey at that time were advised that they could complete the survey themselves online at a more convenient time. These residents were provided with the full information pack.

From the 78 houses doorknocked, 34 residents accepted the letter instead of undertaking the survey with a team member.

The Dunbar Homes on Orange Avenue were doorknocked and 8 residents answered and one completed the survey.

Three businesses were doorknocked:

- Meals on Wheels
- Adelaide AutoWorx
- Industrial Business.

Businesses showed little interest in commenting on the Amended Masterplan. The doorknock project team was advised by Meals on Wheels staff that the volunteers may have an interest in the project but were not present at the time.

4.1.3 Survey (online)

To capture the broader community, including those outside the suburb of Salisbury, the survey was promoted on the:

- · Weekly Northern Messenger
- The City of Salisbury's Social Media (Facebook)
- · The City of Salisbury's Have Your Say website
- Mailout to residents and businesses identified in the catchment area Figure 1.

The online Survey received 223 responses, with 17 of these captured during the doorknock. (A copy of the survey results can be found in Appendix A)

The responses were predominately from people residing in the suburb of Salisbury (57%) as illustrated in dark gold shading in Figure 3Figure 3 Survey participation by suburb




Figure 3 Survey participation by suburb

4.1.4 Telephone survey

A telephone number was provided to respond to queries and give an additional medium for the community to provide their feedback.

Twenty-five calls were received in response to the Salisbury Oval Precinct Masterplan. Of these:

- 22 participants completed the survey
- 3 participants left a message.

Feedback left in a message by the 3 participants was still considered in this report.

4.1.5 Project email

A project email was established to respond to queries and give an additional medium for the community to provide their feedback.

Three emails were received and responded to within the consultation period however, they did not provided sufficient information for feedback to be entered into the survey. An additional three emails were received after the consultation period had closed. All comments received have been considered within this report.

4.2 Survey Response Summary

4.2.1 Section 1: - Information on this survey

Section 1 of the online survey gathered information to identify who was undertaking the survey.

Survey respondents identified as follows:


- 41% were a City of Salisbury ratepayer or resident
- 26% were a local resident (within 500m of the Oval Precinct)
- 15% were a neighbouring resident (facing the Oval Precinct)
- 1.3% were a neighbouring business (within 100 metres of the Oval Precinct)
- 1.3% were a Local business / Not for Profit Organisation
- 0.9% were a Northern Districts Cricket Club Member
- 0.9% were a Salisbury Bowling Club Member
- 0.9% were a Salisbury Croquet Club Member
- 11% Specified other.

Of the 11% that selected other, 33% were involved with the Salisbury Football Club and 17% were involved with the 1st Salisbury Scout Group.

53% of participants provided their email address to receive information on the outcomes of this survey.

Question six asked participants to select their age group. The majority of participants were age 35 years and older and 55 - 64 years made up 21% of participants, the highest selected age group.

4.2.2 Section 2: Brown Terrace Recreation Spaces

177 participants commented on what recreational uses they would like to see along Brown Terrace. In general, the majority of participants were in favour of most recreational elements. Participants could select more than one answer.


- 67% selected Picnic Setting with BBQ
- 65% selected a Playground Area
- 58% selected Landscaping
- 29% selected other

- Dog Park
- Facilities for those with a disability (toilets/play equipment)
- Water Play
- · Maintain/retain as is
- Community Garden

- Skate Ramp
- Amphitheatre
- · Cycle/walking trail & Criterion Track
- Farmers Market

Q6. What facilities would attract you to use the recreational space along Brown Terrace (Check all that apply)?




175 participants commented on what landscaping features they would like to see on Brown Terrace, broken down as follows:

- 78% selected a Shared Use Path
- 77% selected Lighting
- 72% selected Park Furniture (seating and tables)
- 21% selected other.

Other comments tended to focus on the retention of existing trees and maintaining or enhancing the natural environment.

Q11. What landscaping features would you like along Brown Terrace? (Check all that apply)




4.2.3 Section 3: Public Toilet Facilities

194 participants selected Yes to having toilet facilities within the Salisbury Oval Precinct.

- 10% of participants did not think a public toilet should be located at the Oval Precinct
- 63% selected separate men's and women's toilets.


Q14. Should the toilet facility be separate men's and women's or unisex?

- At the Salisbury Football Oval.


4.2.4 Section 4: Future development site




74 (33%) of the total survey respondents provided their responses on what they considered to be appropriate housing types if housing was selected as the preferred development for the site.

Of those who answered this question, general preferences were expressed towards:

- · Single storey housing
 - Detached (61%, n=45)
 - Row houses (28%, n=21)
 - Group houses (19%, n=14)
- · Double storey housing
 - o Townhouse (18%, n=13)
 - o Apartments (18%, n=13)

This question was also optional and 149 respondents skipped this question.


192 (86%) of the total survey respondents commented on what other development they would support at the former St Jay's site. 31 respondents skipped this optional question. Of those who answered this question,:

- 23% of the respondents (n=45) supported Medical/health facility
- 20% of the respondents (n=38) supported Nursing Home
- 76% of the respondents (n=145) selected Other and provided comments.

The following graph depicts the range of suggestions by survey participants who selected 'Other'. Given that there was no restriction on a number of suggestions one respondent could provide, multiple suggestions were recorded therefore the total number of suggested uses do not match up with the number of respondents.

Of the 145 respondents who suggested other uses, recreational use was the most popular response (70%, n=103). Recreational use suggested by the respondents included:

- Recreation Centre
- Open Space
- · Sporting Oval and Facilities
- Swimming pool

- Gym
- Dog park
- Lake
- Bike tracks

Of the 145 respondents who suggested other uses, 43 respondents (30%) explicitly made comments opposing housing as the future use. However, 13 respondents (9%) expressed their support for housing including aged care housing, social / emergency housing and nursing home.

Additional comments provided in support for housing included:

- Support for development that is sympathetic with surrounding area (e.g. single storey detached housing)
- Retain trees
- Recreational space / high amenity public spaces to support residential development that are accessible by everyone.

4.3 Key Themes

The following key themes were highlighted throughout the engagement process:

4.3.1 Salisbury Oval Precinct retained for recreational use

The survey data indicates that 46% (n=103) of the 223 community members expressed their preferences for Salisbury Oval Precinct to be retained for recreational use and activities when asked "What other type of development would you support for the St Jay's site?" (Question 17).

Of the 103 respondents to Q.17 who suggested recreational use to be retained at the future development site, most common suggestions were:

- Open space (31%, n=32)
- Recreation centre (26%, n=27)
- Indoor swimming pool (12%, n=12)
- Gym (9%, n=9).

Of the emails and phone calls received during the consultation period, that could not be included in the survey results, all (3) emails and all (3) phone calls, expressed their preference to keep Salisbury Oval Precinct for sporting and recreation use.

4.3.2 Housing development within the Salisbury Oval Precinct

The community's survey responses were mixed towards the development of housing at the former St Jay's site at the Salisbury Oval Precinct. Of the 223 total respondents, 74 respondents provided responses to Question 16 "If housing was selected as the preferred development, what type(s) of housing do you consider appropriate?". 20 respondents skipped Question 15 "Would you like to comment on the use of the future development site (formerly home to St Jay's Recreation Centre and former Bowling Club land)?" and further 18 respondents answered 'no' to this question.

Based on the above, it can be assumed that a total of 112 respondents (50%) are either explicitly supportive of the idea to develop the future development site for housing or feels neutral about the housing development. The other half of the total respondents preferred alternative uses with 18% (n=43) strongly opposing housing development.

Three of the emails and one phone call received during the consultation period each stated that they did not want housing developed at the former St Jay's site. They could not be included in the survey results.

4.3.3 Retention of existing trees, green space and natural environment

Most participants, were in favour of the recreational facilities suggested in the survey for Brown Terrace however, many prefaced they would like to see existing trees retained, particularly the large gums.

Participants made specific comments relating to Brown Terrace remaining untouched in question 10. Survey participants also highlighted they would like to see the preservation of the existing natural environment, retention of trees and inclusion of greenspace in the *Other* option of questions 10, 11 and 17.

12% of survey participants suggested leaving Brown Terrace untouched (Question 10 Other)

23% of survey participants wanted to retain existing trees and preserve or enhance the natural environment (Question 11 *Other*)

20% commented for the Salisbury Oval Precinct to have lots of green space (Question 17 Other)

Comments include:

- Leave section along Brown Terrace as it is or only enhance the biodiversity. That is leave trees, perhaps add some vegetation such as Banksia, Grevillia for nectar lovers and resident possums, absolutely no disturbance of the ecosystem or habitat of current wildlife
- Retain trees and increase vegetation, reinstate and incorporate eucalypts that grow to huge sizes e.g. Flowering Gums, which were once in the centre of Salisbury.
 There are multiple benefits from trees such as this
- Leave untouched as it currently supports wildlife, at most enhance eco-system.

4.3.4 The community support a toilet facility within the Salisbury Oval Precinct

The survey data suggests that the community support a toilet facility within the Salisbury Oval Precinct.

Section 3 of the survey asked questions relating to the inclusion of toilet facilities at the Salisbury Oval Precinct. The community survey results concluded that the vast majority (90%) of participants were in favour of the inclusion of a toilet facility. The majority (59%) expressing that close to the playground, near Neales Green was the preferred location. 29% of survey participants were in favour of toilet facilities being located more centrally along Brown Terrace near the multi-use courts.

The majority of participants (63%) also preference separate Men's and Women's facilities. Question 14 uses the Bridgestone Reserve toilet facility as an example of what may be proposed at the Precinct. The Reserve is located approximately 700 metres from the Salisbury Oval Precinct and appeared to be well known by survey participants. The Bridgestone Reserve Toilet facility consists of three unisex toilets. Some participants changed their preference from separate men's and women's facilities to unisex when they learned that the facilities at Bridgestone Reserve were unisex.

The project team observed that survey participants whom they spoke to during the doorknock and phone calls, often expressed that safety was a key issue for them regarding toilet facilities.

21 participants suggested alternative toilet locations under *Other* 29% of those, suggested the precinct should include two toilet facilities, one at the proposed location and the second near St Jay's to service each end of the precinct.

Of the emails and phone calls received during the consultation period, that could not be included in the survey results, none made mention to agree with, or oppose, the inclusion of a public toilet facility at the Salisbury Oval Precinct.


Q5 Are you a female or male?


Q6 What is your age group?


Q12 Do you think a public toilet facility should be located within the Salisbury Oval Precinct - Recreation Space?




Q14 Should a proposed toilet block similar to the Bridgestone reserve facility (as shown in the photo) be considered. Would you prefer it to be:




Q16 If housing was selected as the preferred development for the site, what type(s) of housing do you consider to be appropriate? (Check all that apply)

- Protection of habitat, existent biodiversity and ecosystem, which is flora, fauna, insects, etc.
- Leave section along Brown Terrace as it is or only enhance the biodiversity. That is
 leave trees, perhaps add some vegetation such as banksia, grevillea for nectar lovers

1.1 Motion on Notice 2 states:

That a report be brought forward, which investigates the appropriateness and feasibility of establishing a 'half court or full court' basketball court in the Cascade Estate at Mawson Lakes, and other suitable locations within the City of Salisbury.

- 3.1 The City Landscape Plan identifies that the reserve such as that located centrally within Cascade Estate, Mawson Lakes could host a multi-use half court under its classification of Local Reserve.
- 3.2 The nearest sport court location is Mawson Lakes Primary School and Mobara Park east of the rail corridor, approximately 1.5 kilometres from Cascade Village Reserve.
- 3.3 The key issue of Cascades Village Reserve is the lack of space suitable to construct a half court. The turf area approximately, 1200 square metres, adjacent the existing play space is the only space which is separated from the local street network and the lake located within the reserve which is able to cater for kick and catch activities within the reserve. The turf area is a part of the localised storm water network with the turf surfacing contributing to cleansing the water as it traverses the site.
- 3.4 It is not possible to achieve a sports court at the identified location without impacting on the turf/ kick and catch and creating risks for reserve users due to level change required. Greater excavation will be required to minimise the risks to the users of the reserve so that there is a smooth transition.
- 3.5 Considering all the above mentioned points, it is not seen as suitable for the construction of a sports court of any size within this reserve.
- 3.6 With respect to the second part of the motion dealing with identifying other suitable locations across Salisbury for the construction of half or full basketball courts, the Place Activation Strategy due to be completed in mid 2020 will assist in setting service standards for reserves throughout the City where similar facilities may be considered.

4. CONCLUSION / PROPOSAL

- 4.1 The key issue of Cascades Village Reserve is the lack of space suitable to construct a half court.
- 4.2 With further concerns being raised by the localised conditions and restrictions due to this turf area being part of the local storm water network and being the only available space within the reserve for informal active recreation.
- 4.3 Due to the above considerations, it is not seen as suitable for the construction of a sports court of any size within this reserve.
- 4.4 The Place Activation Strategy due to be completed mid 2020 will assist in setting service standards for reserves throughout the City where similar facilities may be considered.

Some of the current Youth Council members were involved in the consultation process for the development of the strategy.
- 1.3 A list of 5 project ideas were developed and discussed, with Youth Council members (being involved in a simple voting process to select priority projects).
- 1.4 At the Youth Council meeting in February 2019, Youth Council recommended the establishment of two project teams and the appointment of project team leaders.

DV & Family Violence

- 3.1 The aim of this project was to create awareness about the issues of DV & Family Violence in our community and to inform young people of where they can access assistance.
- 3.2 Key outcomes for this project included:
 - 3.2.1 Partnering with SAPOL for their White Ribbon Walk on July 26. Youth Council designed a banner which they carried at the front of the walk, provided local school children with black and white balloons to carry, and assisted with the promotion of the event at their schools, Universities and workplaces.
 - 3.2.2 The second phase of the project was developing art collaboration between a young local artist and local school students using 'Create a Place' public art funding. The mural is located at Salisbury North Skate Park was officially opened at a launch on September 13, 2019. Guest speakers from the Northern Domestic Violence Service and the Port Adelaide Football Club Youth Empowerment program participated in the event.
 - 3.2.3 In October, the project team was invited to a tour of the Port Adelaide Football club where they met Jake Battifuoco, Youth Programs Manager and other members of the Youth Empowerment Team to discuss what the club does in this area, and to share with the football club what Youth Council Members do in the community.

Life Beyond 18

- The aim of this project is to assist young people to navigate through life beyond 18 years of age by providing education, information and practical skills.
- 3.4 Key outcomes for this project included:
 - 3.4.1 The development of an eight week program outline and implementation of a pilot program. Long term outcomes included ensuring the sustainability of the program which will be repeated either at Twelve25 or another space in 2020.

- 3.4.2 The Life Beyond 18 Program concluded with a graduation held on October 28 at Twelve25. The graduation was attended by participants and their families, Youth Council members and community partners who assisted with content creation and program facilitation.
- 3.4.3 Participants made significant social connections as a result of the program and have now formed a social group that meets regularly. They have also engaged with services that presented during the program, and are eager to hear about future Twelve25 programs.
- 3.4.4 Youth Council has now been approached by several organisations who have an interest in delivering the Life Beyond 18 program. Meetings to discuss these opportunities will be held following a program evaluation and minor changes being implemented. Community partners involved in the program have once again agreed to participate in future programs.

3.4 Youth Council Members have been assisting the Councils Access and Inclusion Project Officer by providing feedback.

on the Ability Inclusion Strategic Plan to ensure that young people are having their needs met. This is a follow on from hosting a Disability inclusion forum as part of their project and attending the forum in 2018.

Youth INC

- 3.5 Youth INC is a private Senior Secondary School based in Adelaide with approximately 35% of their students currently residing in the Northern Suburbs.
- 3.6 In 2020 Youth Council will assist Youth INC to facilitate an Anti-Bullying Forum for their students, and are also in discussions to develop monthly employment focused workshops (based in Salisbury) for young people in the local region.

National Youth Commission

- 3.7 The National Youth Commission (NYC) is an independent, non-partisan community inquiry into the challenges faced by young people preparing for and seeking work now and into the future.
- 3.8 Youth Council was invited to present at a Public Hearing held in June at the University of South Australia on issues of unemployment/underemployment and possible solution ideas for young people in the north.

SA Youth Parliament

- 3.9 Youth Council Deputy Chair Monu Chamlagai participated in SA Youth Parliament 2019 along with two young people who reside in the City of Salisbury. Monu received sponsorship from the City of Salisbury through Youth Council.
- 3.10 Monu subsequently presented at the October Youth Council Sub Committee and Council meetings on her Youth Parliament experience and the bills they presented.

Every Life Matters, Salisbury Suicide Prevention Network

- 3.11 Every Life Matters is a Community Network supported by the City of Salisbury that shares information about services and starts conversations about suicide prevention.
- 3.12 In 2019 a Youth Focus Group was formed as part of the Network by Youth Council members. The Network applied for and received funding from SA Health that is enabling the group to do valuable work in the community. To date achievements include: hosting an event in Judd St Laneway, assisting with the Youth Council Life Beyond 18 project by creating resources and also facilitating a well-being session and Safe Talk Training for local young people in collaboration with Headspace/Sonder.

YACSA

3.13 Youth Council Member Luke Hall was part of a Youth focus group with the Youth Affairs Council of South Australia who worked on the Youth Strategy for SA that YACSA presented to Parliament. Youth Council members also attended a Pizza & Politics Night hosted by YACSA to discuss youth issues.

SAPOL

3.14 The Domestic Violence & Family Project team partnered with SAPOL for their Annual White Ribbon walk held in July. Youth Council Members promoted and attended the walk, carrying the banner they produced. Local school students from Salisbury primary school also participated in the walk, with Youth Council providing them with black and white balloons to carry. Numbers for the march significantly increased from previous years, which was excellent to see.

- 3.1 This report provides a summary of youth programs delivered by Twelve25, Community Centre's and the Community Learning Programs team across the City of Salisbury. Programs include:
 - 3.1.1 **Salisbury High School Wellbeing Expo | 1 Nov.** Three Youth Council Members (Megan, Nicolette & Tyler), with support from Twelve25 staff hosted a stall promoting youth programs, which included Youth Council, volunteering opportunities and alcohol education (utilising drinking

- goggles as a learning activity). Approximately 800 students from Years 8-12 attended over the course of the day.
- 3.1.2 **Rattle N Snap Aerosol & Photography Exhibition** | **7 Nov.** Northern Adelaide Senior College's Aerosol Art & Photography programs took place at Twelve25 through-out Terms 3 & 4. Outcomes for students included: re-engagement in learning through alternative education, an introduction to new pathways (including arts & enterprise skills) and SACE accreditation (Stage 1, 10 credits Community Studies). The program concluded with a celebration displaying their creative works where they also received a certificate presented by the Deputy Mayor, of the City of Salisbury Julie Woodman.
- 3.1.3 **Getting Your L's** | **11 November.** A two day workshop was held at Twelve25 with fourteen young people booked to attend. This is the last workshop of the year, with planning under way for next year's dates. Expressions of interest can be submitted via the website-http://www.salisbury.sa.gov.au/GettingLs Workshops continue to be in demand by young people who require additional support in learning to successfully obtain their L's.
- 3.1.4 **The Duke of Edinburgh International Award** | **14 Nov.** Thirty young people from Parafield Gardens High School, with support from Twelve25 recently completed their Award. Participants completed the physical activity, skills, voluntary service and Adventurous Journey elements (20 Bronze, 5 Silver & 5 Gold) and on the 14th of November celebrated their achievements with family and friends. The Bronze Award Holders received their First Aid certificates, while the Silver and Gold participants upgraded their leadership skills by planning and facilitating activities on the Adventurous Journey at West Beach Parks in the October School Holidays.
- 3.1.5 **Christmas Lunch** | **25 December.** The Salisbury City Rotaract Club & Parafield Gardens Community Club will host a free community Christmas Day lunch at the Parafield Gardens Community Club. The previously well attended shared lunch will bring together people who may not have anywhere else to go with other members of the community. Bookings can be made on 8182 3444, with further information available from Damien Walker on 0423 914 675 or <u>SalisburyCity@rotaract.org.au</u>
- 3.1.6 **School holiday activities** | **December January.** Twelve25 & Youth Council are hosting 'Shred, Sizzle & Slam' at the Salisbury North Skate Park on 23rd January 2020. In addition to young people skating, a free sausage will be provided, with music, basketball challenges and other games and activities. Staff from Headspace will also attend to interact with the young people. More information on the School Holiday Program can be found at: www.salisbury.sa.gov.au/shp
- 3.1.7 **The Mawson Centre** | The Mawson Centre has conducted a range of after school learning programs including 'LEGO, Mindstorms and Robotics' over the past Term. Current programs include: Coding Club, Chess Club and Computer Animation for children 7 years +. From February 2020 cartooning workshops will be introduced to the existing after school program.

- 3.1.8 **Burton Community Centre** | **School Holiday Program.** 'Lego, Robotic Mindstorm' sessions were held in Term 2 School Holidays, with much success. Over the past two years the School Holiday Program attendance has been supported by a larger cohort of 7-17 year olds due to the introduction of 'Lego, Robotics & Mindstorm'. Prior to this, younger children (7-10 years old) typically attended the program.
- 3.1.9 **Burton Community Centre** | **After School Program.** 'Lego, Robotic Mindstorm' and an 'Introduction to Bionics' sessions were held during Terms 2 and 3. The After-school Program attracted 10 students (17 years and under) from various backgrounds who have demonstrated an aptitude for bionics and robotics. This content is not offered at their school and in addition participants are experiencing learning barriers such as mental health issues and bullying that may lead them to disengage from school.

With this in mind, the Burton Community Centre, in conjunction with Tutor for Robotics and Bionics, TAFE SA and Festo Australia (maker of Bionics4Education) will collaborate to host a pilot STEM focused program. Particular emphasis will be placed on preparing participants (16-18 years) for TAFE enrolment and beyond over a 20 week period. Term 1 and 2 classes have already reached capacity.

3.1.10 Salisbury East Neighbourhood Centre | Adulting for Teens | 2020 Funding has been secured to run an additional Term of the 10 week 'Adulting for Teens' program, aimed at young people with a disability from Salisbury East High School.

Students will build on skills learnt from the previous Term (developing a sense of self and healthy relationships) and gain practical life skills to look after themselves. The program includes; cooking, self-care, budgeting and developing independence.

- 3.1.11 Salisbury East Neighbourhood Centre | Work Ready Skills. This program will be run over two Terms and is designed for disengaged youth to gain work ready skills to build confidence to enter the workplace. Students will gain accreditation in First Aid, Child Safe Environments, Barista, White Card and will include resume writing and interview skills. As of writing this 60+ students have completed the courses.
- 3.1.12 **E-sports tournaments & workshops 2020** | Planning is underway for the 5th Rocket League Tournament which is a collaboration between the Digital Literacy Programs Coordinator, Twelve25 staff, Northern Adelaide Senior College's teachers and Academy Gaming Film Animation students. Workshops on 'Model a 3D logo', 'Introduction to streaming/recording', 'Introduction to Game Footage Highlight Reels' and a 'League of Legends' tournament will be held at the Salisbury Community Hub. Bookings and details will be available at: www.salisbury.sa.gov.au/SESL This program continues to align with the Youth Strategic Action Plan in the key area of *Jobs and Education* by *developing programs for digital learning*.

3.1.13 Salisbury Secret Garden 2020 | Theatre Performance & Open Mic Night. The Salisbury Youth Performing Arts Group meet Thursday afternoons at Twelve25 and will be performing 'I Hate Shakespeare!' by Steph DeFerie in two shows on Thursday 27th February. One show will be for high school students with the other open to the public. Tickets will be available at: https://adelaidefringe.com.au/fringetix/i-hate-shakespeare-af2020

Twelve25 & Youth Council are hosting a free Open Mic Night on Friday 28th February with an opportunity for young people 16-25 years of any skill level to perform in front of an encouraging audience. - 4.1 Len Beadell Library operations have moved to the Salisbury Community Hub, commencing 30 November 2019.
- 4.2 Council endorsed a sales process for the former Len Beadell Library site at its meeting on 28 October 2019. This process has commenced and a tender has been released to secure a commercial property agent to undertake this work. As per the time frames endorsed by Council it is anticipated that the site will not be released to market until mid-2020.
- 4.3 Additionally, Council resolved to investigate short term activation options for the site, pending the marketing, sale and eventual redevelopment and or/re-use of the site.
- 4.4 Given the uncertainties regarding the duration of activation that will be required at this stage, the preferred option is to adopt, as an interim measure, an approach whereby the site will be made available for short term use by community groups that are looking for space but their activities are incompatible with the Salisbury Community Hub and/or unable to be accommodated in other Council facilities.
- 4.5 Hiring of this site will be managed in the same manner as the Salisbury Community Hub, supported by Community Development.
- 4.6 Further to this the frontage on Church Street will be managed to ensure that the building remains attractive to passers-by. This may include opportunities for display and sale of products by users of the facility, such as artwork.

5. CONCLUSION / PROPOSAL

- 5.1 This report summarises the short term approach for the activation of the former Len Beadell Library site.
- 5.2 This approach enables the site to be put to good use while Council seeks potential developers or organisations to deliver the type of jobs and investment envisaged in the Salisbury City Centre Renewal Strategy. Council has considered car parking in the Salisbury City Centre and Mawson Lakes Interchange area, and the potential for permit parking in the Sexton Car Park. There is a requirement to report back in December 2019 on the endorsed actions.

The actions can be grouped into ongoing, advocate, land strategy, and investigations. The most significant updates are the investigations into the Waterwheel long term carpark usage, which found limited usage and no demonstrated demand to expand the car park, and Sexton Car Park time changes, which did not receive substantive opposition and is being progressed.

1. BACKGROUND

4.2 Ongoing Actions

4.2.1 Time limits at Salisbury and Mawson Lakes be monitored and managed

Parking controls continue to be regularly managed and monitored by General Inspectorate as an ongoing requirement. Further work will be undertaken over the next three months to review and assess the appropriateness of existing time limits for on street parking in the Salisbury City Centre with a view to identifying opportunities to either increase parking turnover in areas of high demand or potentially increasing time limits to enable longer term parking to occur.

4.2.2 Exemption for small business from car parking contributions

A further review of the exemption is scheduled for June 2020. The Planning and Design Code outcomes will be considered in the review.

4.2.3 Permit parking in Salisbury City Centre and Mawson Lakes not be pursued except for disability and high needs users

Parking management continues to occur. The Licence Plate Recognition trial and road sensor trial findings are being reported on separately to Council in the January round of meetings.

4.3 Advocate for changes

4.3.1 Improved train services to Parafield Station

The matter has been raised through discussions with DPTI and Renewal SA and will be followed up with correspondence to the Minister for Transport and Infrastructure and DTPI.

4.3.2 Benefits of mixed use development incorporating deck parking at Mawson Lakes Interchange

The matter has been raised with DPTI and Renewal SA through the Mawson Lakes Exit Deed negotiations on the future use options for the site.

4.4 Land strategy

4.4.1 Market interest in car parking development on Council sites in Salisbury City Centre

The GTA Consultants study for the Salisbury Car Parking Scenarios found that deck parking could be considered after other options to maximise carpark use have been exhausted. JLL in its market assessment of the Salisbury City Centre noted the challenges of the commercial viability of this form of car parking in the initial stages of a city centre renewal strategy, in that deck parking has a high cost per parking space compared to at-grade parking options, and deck parking under these scenarios can be underutilised until the intensity of development occurs to generate the parking demand. In addition, the GTA study identified that overall parking numbers in the Salisbury City Centre are generous, but with locations of high demand.

4.5 <u>Investigations</u>

4.5.1 Waterwheel Carpark be monitored

There have been 30 parking utilisation counts conducted at the Waterwheel carpark at various times of the day over September, October and November 2019. A total of 29 cars were counted in that period. Given that this carpark is unrestricted and available for all day parking, some of these vehicles may have parked for the day and therefore counted multiple times in counts undertaken on the same day. In addition, 11 buses were counted over the same period. The largest single count result was eight vehicles on Wednesday, 16th October at 9.30am.

There are currently 23 car park spaces provided.

The on line public information on parking in the City Centre has been updated to identify its availability as an unrestricted area. A copy of the parking plan is attached (Attachment 1).

It is considered from the survey results that current demand is limited, with capacity for any increased demand over the Christmas period. Expansion is not considered to be warranted at this time.

4.5.2 **Sexton Carpark parking times**

The affected landowners and business adjacent the car park have been consulted by the Salisbury Business Association on behalf of Council on the proposal to change the current time limits to 'Three Hour Parking between 8am and 5pm Monday to Friday".

There were no substantial objections and the changes were initiated under delegation.

Orders for changed signage have been placed and will be installed when available.

5. CONCLUSION / PROPOSAL

5.1 It is considered that some of the identified actions are ongoing in nature, some are dependent upon further studies and consideration by Council, and some have been concluded.
