1. BACKGROUND

- 1.1 In November 2015, the City of Salisbury signed a Friendship City Agreement with the Linyi Municipal Government, when the former Mayor of Linyi Zhang Shuping visited Salisbury. The Agreement sought to promote cooperation and exchange across a range of economic, social and cultural fields.
- 1.2 In October 2019, the Mayor, Councillor Graham Reynolds, the Chief Executive Officer, representatives from the Northern Adelaide Waste Management Authority, and Mr Sean Keenihan – SA President Australia China Business Council, attended the Shandong International Sister Cities Cooperation and Development Conference in Jinan and the China (Linyi) Cooperation and Exchange Forum.
 - 1.2.1 During this visit, the Agreement formulated in 2015 was further reiterated and enhanced with the signing of a MOU between the Mayor of Salisbury and the Mayor of Linyi.

Invitation - 2020 Linyi International Cooperation and Exchange Meeting – Experience New Shandong - Video

- 3.1 The Mayor has received an invitation from the Linyi Municipal Government to record a short video of congratulations to be played at the *2020 Linyi International Cooperation and Exchange Meeting – Experience New Shandong*. A copy of this invitation is provided as Attachment A to this report.
- 3.2 The Linyi session of the International Cooperation and Exchange Meeting will be held on 18 October 2020 with the theme *New Challenge and New Opportunity*. At the meeting, it is proposed discussion topics will include intensifying international exchanges and cooperation in the post-pandemic era.
- 3.3 The First Linyi Import Commodities Fair will occur during the *2020 Linyi International Cooperation and Exchange Meeting – Experience New Shandong*. The purpose of the Linyi Import Commodities Fair is to enhance international cooperation and promote common development.
- 3.4 The Mayor is supportive of the request for a video of congratulations from the Linyi Municipal Government, and the request has been acknowledged and accepted, also noting the timing of the event. The congratulatory message will align to the key principles in the Agreement that was signed in October 2019, reinforcing the City of Salisbury’s commitment to the key areas of cooperation. A copy of the draft script for the congratulatory message is attached for information (Attachment 2)
- 3.5 Noting current sensitivities and commentary in respect to the relationship between Australia and China, advice was sought through the Office of the Minister for Investment and Trade - South Australian Government and from the Department of Foreign Affairs and Trade (DFAT) State Office in respect to this invitation, and the draft script is consistent with the advice received in relation to its content.

4. CONCLUSION / PROPOSAL

- 4.1 In November 2015, the City of Salisbury entered into a Friendship City Agreement with the Linyi Municipal Government. The Agreement was further reiterated and enhanced with the signing of a MOU between the Mayor of Salisbury and Mayor of Linyi in October 2019.
- 4.2 The Mayor has received an invitation from the Linyi Municipal Government to record a short video of congratulations to be played at *2020 Linyi International Cooperation and Exchange Meeting* on 18 October 2020.

- 4.3 The video of congratulations builds upon the City of Salisbury's relationship with the City of Linyi and reinforces our commitment to the Agreement signed in October 2019.


