4. **REPORT**

- 4.1 Background
 - 4.1.1 Salisbury E-sports is an online gaming program that was established in 2017, and is delivered in collaboration between Twelve 25 Youth Centre and the Community Learning & Development team.
 - 4.1.2 The program was developed as a replacement for the Midnight Basketball program as a way of engaging young people who may not be involved in traditional sports or accessing council services or spaces.
 - 4.1.3 Esports also presented an excellent opportunity to engage young people with creative technologies programs such as game design, 3D modelling and video production.
- 4.2 Programs and Events
 - 4.2.1 In the last three years 28 events have been conducted, including;
 - Individual and team tournaments (sports such as FIFA, Teamfight Tactics, Smash Bros, League of Legends)
 - Online tournaments during the COVID-19 lockdown (live streamed via Twitch)
 - Learning programs
 - Come and play days for younger participants
 - Drop in gaming sessions
 - 4.2.2 These events engaged over 650 participants and spectators. This does not include online engagement as many of the tournaments were broadcast online.
 - 4.2.3 Feedback received from participants was extremely positive with 81% of participants stating that they enjoyed themselves and the key outcomes being participating in a fun and positive environment, creating new connections/friends and feeling a stronger sense of community.
- 4.3 Program evolution
 - 4.3.1 The program currently boasts multiple collaborators, including a partnership with teachers and students at Northern Adelaide Senior College (NASC) and their Academy of Gaming, Film and Animation (AGFA) course which teaches students about game development, event management and AV production.
 - 4.3.2 In 2020 Salisbury E-sports underwent a brand refresh which saw the creation of the Northern Adelaide Esports League (NOADE). The league already possessed strong brand recognition which is highly respected in gaming circles, however the rebrand enabled new social media channels to be established and presents an opportunity for growth and

collaboration with other councils. An excellent opportunity to collaborate exists with the META High School Esports Association as co-hosts of events.

4.3.3 Initial funding of the Esports program facilitated the acquisition of specialist gaming equipment, enabling the delivery of a range of tournaments and learning programs. This included the purchasing of 13 PCs which were used for 3D modelling, gaming and video editing. These programs will be augmented by the new Creative Technologies suite at Burton Community Hub which includes the provision of E-sports compatible PCs.

5. CONCLUSION / PROPOSAL

- 5.1 Twelve25 Youth Centre is the heart of youth service delivery in the City of Salisbury, providing programs and activities that serve as a pathway to education, employment and enterprise for young people aged 12 to 25 who live, work, study or volunteer in the area.
- 5.2 In 2017 council committed \$25,000 per financial year via a budget bid towards 'Youth at Risk Esports gaming tournaments'.
- 5.3 The program achieved significant outcomes and excellent participation rates for young people over the 3 years including the delivery of 28 events which engaged over 650 participants.
- 5.4 Given the success of the program the continuation of the E-Sports program should be considered as part of the 2022/23 budget process.
