- 6.1 Approves (6.1) as part of any sale agreement with the school, the administration incorporates specific initiatives to be provided by the school which addresses matters raised through community consultation such as increased car parking, installation of landscaping and appropriate boundary treatments to address loss of vegetation and visual amenity at the boundary interface.
- 6.2 Consideration of allocation of funds to traffic management improvements in the vicinity of the school including changes to parking and pedestrian crossings.

4.1.5 Revocation of Community Land Classification - Portion Burton Drainage Reserve for Disposal

That Council:

- 1. Approves the revocation of the Community Land Classification of portion of Allotment 23 in Deposited Plan 68667, Certificate of Title Volume 6080 Folio 161, also known as Burton Drainage Reserve and measuring approximately 3,007 square metres, pursuant to the provisions of Section 194(3) (b) of the Local Government Act 1999 having complied with all the requirements.
- 2. Authorises the Manager Property and Buildings to remove the above-mentioned portion of land from the City of Salisbury's Community Land Register.
- 3. Authorises the Manager Property and Buildings to lodge all necessary documentation with the Land Titles Office to allow for the removal of this portion of land as Community Land and transfer to the owner of the adjoining property as previously approved by Council on the 26th of July 2021, Item 4.4.1, Resolution Number 1039/2021.

 - a. Requesting DIT to specifically include in the traffic network analysis consideration of an upgrade/duplication of Kings Road west of Salisbury Highway and similar upgrade to Waterloo Corner Road for its inclusion in the planning studies.
 - b. DIT to also include in the planning studies network options for consideration of the future development of the Salisbury Centre level crossing.
 - c. The City of Salisbury also reinforce our opposition to any closure of passenger rail level crossing, and Council's preference for an under or overpass.

 - 2.2 Target Hill Right Turn into Main North Road
 - 2.3 The Grove Way Canterbury Drive intersection
- 3 Notes that there is no funding in Council's Long Term Financial Plan to contribute to the upgrade of these Department for Infrastructure and Transport controlled road junctions.

- 4. Approves that the Fairbanks Reserve Upgrade project proceed to detailed design and construction in the 2022/2023 financial year.
- 5. Approves the location of the toilet and the rage cage and that construction for these elements commences as soon as possible ahead of the main works.
- 6. Approves for a non-discretionary budget bid of \$1,350,000 to be considered in the 2022/2023 financial year budget process to fund the remainder of the Fairbanks Reserve Upgrade project.

 - Non-disclosure of the matter and discussion of this item in confidence would protect confidential information provided by the Tenant.

1. BACKGROUND

1.1 City Infrastructure is responsible for the capital works, associated plant and fleet, building, traffic and civil engineering services, landscape and environmental works. Specifically, these works involve project management, design specification development, construction and recurrent maintenance. Service provision is undertaken by both internal resources and external consultants/contractors. City Infrastructure provides periodic progress reports for these projects.

2. CONSULTATION / COMMUNICATION

2.1 As part of the management of the City Infrastructure Capital Works Program, communication of the program occurs on a monthly basis via the Urban Services Committee, with highlights included within the City of Salisbury internet site, social media and in the periodic publication *Salisbury Aware*.

3. REPORT

- 3.1 With the opening of State borders in December 2021, the delivery of the 2021/22 Capital Works Program continues to be managed within the constraints associated with this changing pandemic. The construction industry generally undertakes a closure period over Christmas and the New Year, therefore current impacts to companies may not yet be apparent. The level of infections and requirements to isolate are expected to impact various industries and the ability of companies to sustain the required staffing levels. Where project delays are identified and determined, these will be reported accordingly.
- 3.2 Despite these challenges, there have been various recent noteworthy achievements which have been included within this report. Plus, there are works which currently remain scheduled for construction and / or commencement in January 2022, including traffic improvements along Redhill Road, Ingle Farm, and Daphne Road, Salisbury East, tennis court renewal at Valley View Tennis Club and the renewal of lighting and irrigation at Davey Oval, Salisbury.
- 3.3 Significant erosion control and mitigation works have been progressively constructed along sections of Dry Creek in Pooraka. Works included stabilisation, waterway alignment and gabion basket installation.



3.4 Within Walkley Heights new path connections and asphalt paths have been completed. Noting this included the construction of a new accessible path to Walkleys Road and a section of asphalt path which required collaboration with the City of Port Adelaide Enfield to manage works across City boundaries.



3.5 Creation of parking facilities and a cricket pitch at Hausler Reserve, Paralowie, were completed, providing the community with new amenities to engage in outdoor sporting activities.



3.6 The renewal of the playspace at Amsterdam Reserve, Salisbury Downs, was completed and opened for the community to enjoy over the summer school holidays.



3.7 The clubrooms at Twell Green, Para Hills, were renewed and recently completed, which complements the adjacent tennis courts.



Program Amendments

3.8 Coordination and monitoring of the Capital Works Program is ongoing, partly to ensure it best meets the needs of the community whilst maintaining infrastructure condition. As a result, the following changes are requested:

Amendment to Budget

PR17598 Minor Capital Works Grants Program

As reported, in April 2021, via the Community Wellbeing and Sport Committee, Salisbury North Football Club were awarded \$50k towards the construction of a new electronic signboard via the Minor Capital Works Grants Program. The associated \$29k club contribution is now sought and will be included within the budget; reflected as an amendment via the Second Quarter 2021/22 Budget Review.

<u>Recommendation</u>: Approves the inclusion of a Second Quarter 2021/22 nondiscretionary bid to reflect the additional \$29k of income and expenditure associated with the installation of a new electronic scoreboard at Salisbury North Oval as part PR17598 Minor Capital Works Grants Program.

Impact: No impact, income received to offset additional expenditure

PR22118 Bituminous Paths

As reported, in September 2021, via the Urban Services Committee, asphalt renewal works were approved for delivery of path works at Walkley Heights within the Bituminous Paths Program. These works required coordination with the City of Port Adelaide Enfield to achieve a seamless connection between both Councils. As part of this, the City of Port Adelaide Enfield has agreed to contribute \$8k towards the cost which is proposed to be reflected within the Second Quarter 2021/22 Budget Review.

<u>Recommendation</u>: Approves the inclusion of a Second Quarter 2021/22 nondiscretionary bid to reflect the additional \$8k of income and expenditure associated with the construction of asphalt paths at Walkley Heights as part PR22118 Bituminous Paths Program.

Impact: No impact, income received to offset additional expenditure

PR13725 Major Traffic Improvements Program

As reported, in November 2021, via the Urban Services Committee, as part of the Revised Capital Infrastructure Program, planned traffic improvement works in the Greenfields Industrial Estate will be deferred to a future year, noting the associated grant funding had not been secured. Accordingly, approval is sought to remove the \$450k income budget associated with this project as part of the Second Quarter 2021/22 Budget Review.

<u>Recommendation</u>: Approves the inclusion of a Second Quarter 2021/22 nondiscretionary bid to reflect the \$450k of income not received as part of PR13725 Major Traffic Improvements Program for works at Greenfields Industrial which is not proceeding in 2021/22.

Impact: No impact, removal of income budget with project deferral approved in

November 2021.

Amendment to Program

PR21412 Kerb Ramp Construction / Upgrade Program

Following receipt of a request and contractor availability, a new kerb ramp connection was constructed at Karingal Crescent, Salisbury Park, as part of the 2021/22 Kerb Ramp Construction / Upgrade Program. Formal program inclusion is now sought with the works aiding in the provision of connectivity within the City and able to be funded via existing budgets.

<u>Recommendation</u>: Approves the program inclusion of Karingal Crescent, Salisbury Park, within the 2021/22 Kerb Ramp Construction / Upgrade Program, PR21412.

Impact: No impact

PR18097 Building Renewal Program

In order to address a current priority, approval is sought to include the \$20k renewal of a portion of the roof at Jack Young Centre, Salisbury, to effectively seal the building. It is proposed to fund these works via the reactive portion of the budget which currently has sufficient funding to do so.

<u>Recommendation</u>: Approves the program inclusion of roof renewal works at Jack Young Centre, Salisbury, within the 2021/22 Building Renewal Program, PR18097.

Impact: No impact

4. CONCLUSION / PROPOSAL

- 4.1 The City Infrastructure Capital Works Program continues to be delivered despite the challenges and constraints associated with the COVID pandemic.
- 4.2 The amendment of income and expenditure budgets associated with the following projects have been included for inclusion within the Second Quarter 2021/22 Budget Review to reflect the associated budget changes:
 - 4.2.1 Installation of a new electronic signboard at Salisbury North Oval, reflect an additional \$29k of income and expenditure
 - 4.2.2 Asphalt paths at Walkley Heights, reflect an additional \$8k of additional income and expenditure
 - 4.2.3 Greenfields Industrial Estate Traffic Improvement works, removal of \$450k income budget which will not be received, and with the project deferral previously approved.
- 4.3 The following program inclusions are noted within this report for formal program inclusion;
 - 4.3.1 Karingal Crescent, Salisbury Park, within the Kerb Ramp Construction / Upgrade Program
 - 4.3.2 Jack Young Centre, Salisbury, partial roof replacement within the Building Renewal Program.
