1. BACKGROUND

- 1.1 At its meeting held on Monday, 27 April 2021 Council resolved:

“That a standing report be established for every meeting of the Tree Management Appeals Sub Committee to inform Council of every application received for tree removal and the outcome of that request.”

- 1.2 Staff currently upload a removal request information table to the Elected Members Portal. This document has been adapted to provide further information and will now be reported to each meeting of the Environmental Sustainability and Trees Sub Committee.

3. DISCUSSION

- 3.1 The attached tables summarise requests for tree removals received and actioned by staff during the past month and have been provided on the Elected Member Portal for July, August and September 2024.

July 2024

- 3.1.1 Forty-six (46) tree removal requests were received in July 2024.
- 3.1.2 Of these requests, twenty-six (26) were approved for removal of which twenty-two (22) were significant or regulated trees and approved through development applications and 4 were non-regulated or significant.
- 3.1.3 Twenty (20) requests were refused. Of these, nineteen (18) are related to significant or regulated trees under the *Planning Development and Infrastructure Act 2016*.

August 2024

- 3.1.4 Seventy-nine (79) tree removal requests were received in August 2024.
- 3.1.5 Of these requests, fifty-seven (57) were approved for removal of which twenty-four (24) were significant or regulated trees and approved through development applications.
- 3.1.6 Twenty-two (22) requests were refused. Of these, nineteen (19) are related to significant or regulated trees under the *Planning Development and Infrastructure Act 2016*.

September 2024

- 3.1.7 Fifty-seven (57) tree removal requests were received in September 2024.
- 3.1.8 Of these requests, forty-nine (49) were approved for removal of which twenty-one (21) were significant or regulated trees and approved through development applications.
- 3.1.9 Eight (8) requests were refused. Of these, all eight (8) are related to significant or regulated trees under the *Planning Development and Infrastructure Act 2016*.
- 3.2 Tree removal requests often result in ongoing dialogue between the owner of the property and Council on the proposed tree removal and subsequent discussions around the species type and location of the new street tree.
- 3.3 It is important to note that through various annual programs Council plants 2,000 trees each year. These programs include the Street Tree Renewal Program, In-fill Planting Program, Tree Screen Renewal Program, Reserve Upgrade Program, Feature Landscape Renewal Program, Greening Program, School Tree Planting Program, Major Projects and ad-hoc planting requests. These tree renewal programs are cognisant of regulated, significant trees or those forming habitat corridors.

4. FINANCIAL OVERVIEW

- 4.1 The budget allocation for reactive tree removals for 2024/25 is \$394,200.
- 4.2 As of 30 September 2024, the total spend was \$85,185, with \$298,914 allocated budget remaining.



3. Refuses the removal of the one (1) *Regulated* tree located at 26 Cawarra Crescent, Paralowie.
4. Refuses the removal of the one (1) Significant tree located at 26 Cawarra Crescent, Paralowie.

1. BACKGROUND

- 1.1 In line with the approved tree removal procedure, residents are able to appeal decisions relating to the retention of trees. This appeal process involves:
- Report to the Environmental Sustainability and Trees Sub Committee (ESATS)
 - Notification of outcome to residents

2. EXTENERAL CONSULTATION / COMMUNICATION

- 2.1 Residents
- 2.2 Ward Councillors in line with the adopted procedures

3. DISCUSSION

- 3.1 Significant and regulated trees are offered protection through the *Planning Development and Infrastructure Act 2016* (the Act) and require development applications for removal. Objectives for assessment of development applications are contained within the Regulated and Significant Tree Overlay of the Act:

Regulated trees are retained where they:

- *make an important visual contribution to local character and amenity;*
- *are indigenous to the local area and listed under the National Parks and Wildlife Act 1972 as a rare or endangered native species; and/or*
- *provide an important habitat for native fauna.*

Significant trees are retained where they:

- *make an important contribution to the character or amenity of the local area;*
- *are indigenous to the local area and are listed under the National Parks and Wildlife Act 1972 as a rare or endangered native species;*
- *represent an important habitat for native fauna;*
- *are part of a wildlife corridor of a remnant area of native vegetation;*
- *are important to the maintenance of biodiversity in the local environment; and/or*
- *form a notable visual element to the landscape of the local area.*

- 3.2 These objectives are distinct from City of Salisbury criteria for removal, which are not a consideration through the development assessment.
- 3.3 The following appeal has been lodged under the Tree Removal Procedure and the resident is seeking removal of the tree.

- 3.4 The initial assessment for this appeal has identified that the tree is healthy, in good condition without any structural flaws and didn’t meet City of Salisbury criteria for removal.
- 3.5 Where appropriate, pruning or canopy reduction has been undertaken to help alleviate concerns raised and actively manage the trees.
- 3.6 Following notification of appeal from the resident, and where appropriate, site meetings were arranged given the history with the trees.
- 3.7 Any further information provided by residents was reviewed and the appeals are presented directly to the Environmental Sustainability and Trees Sub Committee for recommendation to Council for consideration.
- 3.8 **26 Cawarra Cres, Paralowie (regulated tree)**
 - 3.8.1 The Euc sideroxylon tree is noted as regulated under the amended PDI Act in May 2024 and has been inspected by two independent bodies.
 - 3.8.2 Preliminary Planning Advice for a Regulated Tree was sought and a Development Application is not likely to be supported.
 - 3.8.3 The tree is in good health and doesn’t achieve removal through the current criteria framework.



3.9 **26 Cawarra Cres, Paralowie. (significant tree)**

- 3.9.1 The Euc sideroxylon tree is noted as significant under the amended PDI Act in May 2024 and has been inspected by two independent bodies.
- 3.9.2 Preliminary Planning Advice for a *Significant Tree* was sought and a Development Application is not likely to be supported.
- 3.9.3 The tree is in good health and doesn't achieve removal through the current criteria framework.



4. FINANCIAL OVERVIEW

4.2 All costs are inclusive of the development approval fee, tree removal cost, traffic management and stump grinding.

- 5.2 Site meetings have been completed and the Environmental Sustainability and Trees Sub Committee can now decide to approve removal, refuse removal or recommend that a Development Application be lodged for removal in line with the Sub Committee's adopted Terms of Reference.

1. BACKGROUND

- 1.1 On 26 June 2023, Council adopted the Sustainability Strategy 2035 ([Sustainability Strategy 2035 • City of Salisbury](#)).
- 1.2 A report on the first six-months of implementation of the Sustainability Strategy was provided in March 2024 for the period July to December 2023.
- 1.3 Council resolved at its meeting held on 25 March 2024 that it:

“Approves the provision of six-monthly reports on the implementation of the Sustainability Strategy as detailed in Attachment 1 of the report (Item No ESATS5 Environmental Sustainability and Trees Sub Committee 12 March 2024).”
- 1.4 This report provides the second six-month report on the implementation of the Sustainability Strategy 2023 for the period January to June 2024.

2. EXTERNAL CONSULTATION / COMMUNICATION

2.1 No external consultation was required in the preparation of this report.

3. DISCUSSION

Status of Actions

3.1 Of the 48 actions in the Sustainability Strategy the status of progress includes:

- 30 (63%) actions that are on track.
- 16 (33%) actions are progressing, but scope or funding needs to be resolved (e.g. pending outcomes of strategy development or budget bids).
- One (2%) action is complete.
- One (2%) action that is highly dependent on State Government partnership and funding - “Partnering with the State Government to deliver a Sustainability Centre for Excellence and eco-tourism destination at St Kilda to support biodiversity conservation and education”.

3.2 A list of Sustainability Strategy 2035 actions and the status of actions is provided in Attachment 1.

3.3 The action item code from the attached table is included in brackets against each of the key achievements and plans summarized in the report.

Biodiversity Salisbury Theme

3.4 The key achievements during January to June 2024, against the Biodiverse Salisbury theme actions are summarised in points 3.4.1 to 3.4.10:

- 3.4.1 Engagement and support of the community across four biodiversity planting events where 2,000 native seedlings were planted by over 125 community members and students (B1 & B3).
- 3.4.2 Ongoing monitoring and management at six key biodiversity sites and planting of an additional 1,250 native seedlings by Field Services (B2).
- 3.4.3 Collaboration and partnership with Green Adelaide to host two plant propagation workshops, a 'come and meet your local environmental volunteer group' event and a 'come and try environmental volunteering' event (B3).
- 3.4.4 Launch of the community led ‘Our Big Backyard’ project to connect people with nature in the Little Para River area with project team members including Riverdale Primary School, Council, Green Adelaide, Riverview Preschool, Kurna community and Morella Community Centre (B3).
- 3.4.5 Multiple environmental education events and projects at community centres were supported by the Green Adelaide Education Team (B3).
- 3.4.6 The Green Adelaide Education Team supported 24 school sites as part of the Sustainable Schools program (increase from 20 schools in 2023) and provided on-going support to three City of Salisbury schools with their Grassroots Grants projects (B3).

- 3.4.7 The Nurturing Nature subsidised plant voucher sale was launched in mid-May 2024. All 300 vouchers (10 plants for \$10) sold out within a month (B4).
- 3.4.8 The Nurturing Nature for Education Sites Program was launched for sites to receive plant donation vouchers. Eight education sites received vouchers in June (B4).
- 3.4.9 Continued liaison with the Department for Environment and Water in relation to the management of the St Kilda Mangrove Trail and surrounds. Terms of reference for a working group were developed (B5).
- 3.4.10 Utilisation of the new tree canopy cover 2022 dataset released in April 2024 to review the connectivity of vegetation across the City commenced (B7).
- 3.5 The key plans for 2024/25 to progress against the Biodiverse Salisbury theme actions are summarised in points 3.5.1 to 3.5.7:
 - 3.5.1 One community planting event and one school planting event will be held in mid-2025 (B1 & B3).
 - 3.5.2 The Green Adelaide Education Team will continue to support and recruit schools (24 schools in 2024) for the Sustainable Schools and Climate Ready Schools programs in City of Salisbury (B3).
 - 3.5.3 The BiblioTrek trial (a Thrive Action Plan action) commenced during the July school holidays and will inform future library programing. BiblioTrek is a nature-based learning program consisting of libraries sessions delivered in outdoors settings, and the production of materials to facilitate self-guided learning about local flora and fauna (including mangroves, bird and marine life) (B3).
 - 3.5.4 The 2024 Nurturing Nature voucher schemes will be finalised and the next round of vouchers launched from May 2025 to coincide with the planting season (B4).
 - 3.5.5 Meetings of the Mangrove Trail Working Group will be held (B5).
 - 3.5.6 Work on an Open Space Strategy will commence and incorporate strategic direction for biodiversity areas, reserves and recreation areas (B6).
 - 3.5.7 An exemplar Biodiversity Sensitive Urban Design (BSUD) landscape design for the Grove Way Major Entry will be developed for discussion with the Department for Infrastructure and Transport and will be delivered as funding allows (B8).

Carbon Responsible Salisbury

- 3.6 The key achievements during January to June 2024 against the Carbon Responsible Salisbury theme actions are summarised in points 3.6.1 to 3.6.10:
 - 3.6.1 Completion of the new Aquatic Centre that is all-electric with 150 kW of solar PV (C2).
 - 3.6.2 A Fleet Low Emission Transition Feasibility Study was completed. Findings and proposed next steps were presented to Executive (C3) and Elected Members at the November CEO Briefing.

- 3.6.3 Options for how to support clubs with increasing energy bills were considered (C4).
- 3.6.4 The new Sustainability Grant stream as part of the Community Grant Program opened on 1 July 2024 (C4 & C8).
- 3.6.5 City of Salisbury participated in the LGA Net Zero 'Accelerate' Program and received an Emissions Summary Report prepared by dsquared. This report will inform development of an Organisational Emissions Reduction Action Plan (C5 & C6).
- 3.6.6 Progress was made on the Low Carbon Road and Footpath project that City of Salisbury is partnering on with nine Councils (managed by City of Charles Sturt with 50% of funding from Local Government Research and Development Fund). The project is on track to deliver case studies, decision support tools and summary report by end of 2024 (C6).
- 3.6.7 An initial meeting was held in February 2024 between City of Playford, Town of Gawler, Green Adelaide, Department for Environment and Water, NAWMA and LGA on scope and governance of a Regional Climate Partnership trial (as agreed by Council in December 2023). Since this meeting informal meetings have been held every 6-8 weeks with City of Playford and the Town of Gawler to share knowledge and identify opportunities to collaborate. This work will inform a report to Council in January 2025 (C7).
- 3.6.8 Secured funding from the State Government to deliver the next stage of the Gawler Greenway between Parafield and Salisbury railway stations and commenced discussions with the Department for Infrastructure and Transport on the design (C10).
- 3.6.9 Renewed bitumen paths throughout Mawson Lakes which provide local connections facilitating increased active travel options (C10).
- 3.6.10 Ongoing delivery of the successful Cycle Salisbury social rides program (C10).
- 3.7 The key plans for 2024/25 to progress against the Carbon Responsible Salisbury theme actions are summarised in points 3.7.1 to 3.7.10:
 - 3.7.1 As the Aquatic Centre reaches full operation, electricity use will be closely monitored and energy efficiency optimisation implemented where possible (C1).
 - 3.7.2 Public lighting renewal works at Mawson Lakes is progressing (C1).
 - 3.7.3 The Fleet Low Emission Transition Feasibility Study will be presented to Council (C3).
 - 3.7.4 A scope will be developed to complete a more detailed electrical analysis, assessment of electric vehicle charging requirements, energy solution options and funding opportunities for the Operations Centre to inform future decision-making (C2).
 - 3.7.5 Energy audits of 52 clubs to be completed to inform potential upgrade priorities to assist with energy cost management as well as consideration of funding options for implementation (C4).

- 3.7.6 Building on the Net Zero 'Accelerate' Program Emissions Summary Report an Organisational Emissions Reduction Action Plan will be developed and presented to Council (C5).
- 3.7.7 The findings of the Low Carbon Road and Footpath Project will inform development of the Organisational Emissions Reduction Action Plan and the tools will be trialed on concept and detailed designs (C6).
- 3.7.8 A report to Council on progress of discussions on a Regional Climate Partnership for Northern Adelaide trial will be provided in January 2025 (C7).
- 3.7.9 A small business sustainability support program for northern Adelaide will be delivered in partnership with the Office for Small and Family Business and City of Playford (C8).
- 3.7.10 Delivery of the next stage of the Gawler Greenway through Parafield Gardens in Summer 2024/25 (C10).

Climate Resilient Salisbury

- 3.8 The key achievements during January to June 2024 against the Climate Resilient Salisbury theme actions are summarised in the points 3.8.1 to 3.8.12:
 - 3.8.1 The final tree canopy and urban heat mapping reports and spatial data were delivered by the Department for Environment and Water in February 2024. The reporting and data were reviewed and reported to Executive in June and Council in July along with the Draft Urban Greening Strategy (CR1).
 - 3.8.2 Work continued on the development of a Flood Emergency Response Plan for vulnerable residents (with funding support from National Emergency Management Agency Preparing Australian Communities – Local grant program) (CR1).
 - 3.8.3 A Climate Adaptation Plan for the Walkleys Road Corridor Strategic Development Project was completed (CR1).
 - 3.8.4 Final updates were completed on the draft Adams Creek and draft Greater Edinburgh Park Stormwater Management Plans and work continued on the draft Dry Creek Stormwater Management Plan (CR3).
 - 3.8.5 Flood mitigation works were completed at Frost Road, Salisbury South and at Diagonal Road and Main North Road, Pooraka (CR3).
 - 3.8.6 New culverts and a swale were established on Waterloo Corner Road and works on Jobson Road, Bolivar were completed to rectify the road open channel ponding as part of the local flooding program (CR3).
 - 3.8.7 The RediCommunities group of culturally and linguistically diverse community leaders established in June 2023 completed the program's five structure workshops and planned a community workshop for September 2024 (CR4).

- 3.8.8 Community Gardens and related community programs and workshops continue at Salisbury East Neighbourhood Centre, Para Hills and Burton Community Hub. Community Garden Clubs that meet and share knowledge and skills also meet at Bagster Road Community Centre and Mawson Centre (CR5).
- 3.8.9 The Emergency Risk Assessment in accordance with National Emergency Risk Assessment Guidelines was completed in April 2024 (CR7).
- 3.8.10 Two workshops were held with key relevant staff as part of the Economics of Trees research project led by the University of Adelaide (CR8).
- 3.8.11 The Climate Change Risk Assessment report was finalised in January 2024 and reported to Council in March 2024. Council approved development of a Climate Change Adaptation Action Plan building on the risk assessment (CR9).
- 3.8.12 The Strategic Asset Management Plan was reviewed and updated to reference to the climate change risk assessment and include a Performance Target of "Integration of climate adaptation actions for specific asset types as part of development of an organisation wide Climate Change Adaptation Action Plan in 2024/25" (CR10).
- 3.9 The key plans for 2024/25 to progress against the Climate Resilient Salisbury theme actions are summarised in points 3.9.1 to 3.9.9:
 - 3.9.1 The tree canopy and urban heat mapping data will be used to inform the development of the Open Space Strategy and review of the Tree Asset Management Plan in future years (CR1).
 - 3.9.2 The Flood Emergency Response Plan for vulnerable residents (with funding support from National Emergency Management Agency Preparing Australian Communities – Local grant program) will be completed (CR1).
 - 3.9.3 The Walkleys Road Corridor Strategic Development Project design guidelines including climate adaptation initiatives will be finalised by the end of 2024 (CR2).
 - 3.9.4 The EOI tender for three demonstration homes, one showcasing sustainability, as part of the Walkleys Road Corridor Strategic Development Project was released (CR2).
 - 3.9.5 Community consultation on the draft Adams Creek and draft Greater Edinburgh Parks Stormwater Management Plans will be completed following Council approval in July and the plans will be finalised (CR3).
 - 3.9.6 The draft Dry Creek Stormwater Management Plan will be presented to Council in late 2024 seeking approval for community consultation (CR3).
 - 3.9.7 The RediCommunities group of culturally and linguistically diverse community leaders delivered a community workshop in September and continue to meet every 4-6 weeks informally supported by the Red Cross until the project concludes in December 2024 (CR4).

- 3.9.8 A cool spaces trial is proposed for summer 2024/25 which may include opening a community centre or library for extended hours during heat waves to provide air-conditioned spaces for the community (CR4).
- 3.9.9 A Climate Change Adaptation Action Plan will be developed with technical support from a consultant and engagement with staff including identification of climate adaptation priorities for each asset type. The infrastructure related outcomes of the Action Plan will be implemented over time (CR9 & CR10).

Resourceful Salisbury

- 3.10 Key achievements during January to June 2024 against the Resourceful Salisbury theme actions are summarised in points 3.10.1 to 3.10.7:
 - 3.10.1 Ongoing successful delivery of the Food Organics Green Organics (FOGO) Bin Program (as reported to Council in March 2024) has supported uptake of FOGO kerbside bins by over 80% of households (up from 63% in 2021) and has positively contributed to a shift to reduce waste going to landfill (from 54% diversion in 2021 to 48% diversion in early 2024) (R1).
 - 3.10.2 Following a Motion on Notice in May 2024 to investigate free community green waste drop off discussions commenced with NAWMA in relation to options (R2).
 - 3.10.3 NAWMA and City of Salisbury partnered with Green Industries SA as part of a metropolitan wide GIVE A SHEET for the planet event on 25 May 2024. On the day 884 kg of linen was dropped off by residents for recycling by BlockTexx (R3).
 - 3.10.4 New event waste management arrangements were implemented for three large events - Australia Day Celebration 26 January 2024 at Carisbrooke Park, Salisbury Fringe Carnival 23 & 24 Feb 2024 at Carisbrooke Park and Salisbury Community Fun Day 2 June 2024 Cobbler Creek Recreation Park. A total of 3.17 tonnes of waste was collected from these events with 25% sent for composting, 18.3% for recycling and 56.8% to energy recovery (R5).
 - 3.10.5 In response to a Motion on Notice in December 2023 a report was provided to Council regarding Re-use and Recycle Hubs in our Community Centres in June 2024. Council requested a follow up report be provided based on discussion with NAWMA which includes an operational model (R7).
 - 3.10.6 The road renewal program contract with Fulton Hogan was finalised in March 2024 and incorporates a Key Result Area to "Achieve an average 10% recycled asphalt across all asphalt related reseal projects" (R3).
 - 3.10.7 Contribution was made into NAWMA's collection contract procurement to ensure data can be collected and provided to inform community behaviors regarding waste to inform the Waste Management Strategy (R11).

- 3.11 Key plans for 2024/25 to progress against the Resourceful Salisbury theme actions are summarised in points 3.11.1 to 3.11.5:
- 3.11.1 The remaining three Community Fun Days for 2024 will be delivered with a three bin system and waste contractor collection to divert waste from landfill (R6).
 - 3.11.2 Council operations will be considered as part of a waste audit. This will provide data regarding how the waste hierarchy can be more effectively applied and to inform development of a Waste Management Strategy to be developed in 2025/26 (R5, R6 & R11).
 - 3.11.3 A revised Council report on an operational model for a Reuse and Recycling Hub will be delivered and decision implemented (R7).
 - 3.11.4 A new Partnerships Document is being prepared based on projects listed in the new City Plan 2040 which provides an opportunity to include advocacy on circular economy related initiatives (R9).
 - 3.11.5 Continue to work with NAWMA to review the Service Level Agreement and arrange for the agreement to be endorsed by Council (R2).

Waterwise Salisbury

- 3.12 Key achievements during January to June 2024 against the Waterwise Salisbury theme actions are summarised in points 3.12.1 to 3.12.6:
- 3.12.1 Watercourse management work delivered in Dry Creek, Little Para and Adams Creek catchments (W1).
 - 3.12.2 Upgrade of the Springbank Boulevard Reserve irrigation system (W2).
 - 3.12.3 The Salisbury Water Managed Aquifer Recharge Monitoring & Reporting Program is ongoing and a 5 yearly catchment risk review was completed (W5).
 - 3.12.4 The Catchment Water Quality Monitoring Network is ongoing and a 5 year Data Summary Report was provided by Water Data Services in March 2024 (W5).
 - 3.12.5 The Green Adelaide Education Team worked with Salisbury Water to support Science at the Wetlands by hosting a guided night walk for 60 participants (W4).
 - 3.12.6 Representatives from City of Salisbury attended two Resilient Water Futures Strategy workshops (W6).
- 3.13 Key plans for 2024/25 to progress against the Waterwise Salisbury theme actions are summarised in points 3.13.1 to 3.13.3 below.
- 3.13.1 The Salisbury Water distribution network will be extended to Electra Reserve and Louisa Reserve in Parafield Gardens and Keyworth Green in Ingle Farm (W3 & CR6).
 - 3.13.2 Little Para Golf Course Irrigation Upgrade is planned and will provide a water saving due to many leaks in the current system (W2).
 - 3.13.3 Two new irrigated open space areas will be established to meet community requests (Ascot Dr reserve and Coogee Ave reserve) (W7).

4. FINANCIAL OVERVIEW

- 4.1 No financial implications. All budgets for Sustainability Strategy actions are assessed as part of the annual budget bid and business planning process.

5. CONCLUSION

- 5.1 Of the 48 actions in the Sustainability Strategy the status of progress includes:
- 30 (63%) actions that are on track.
 - 16 (33%) actions that are progressing, but scope or funding needs to be resolved (e.g. pending outcomes of strategy development or budget bids).
 - One (2%) action is complete.
 - One (2%) action that is highly dependent on State Government partnership and funding - “Partnering with the State Government to deliver a Sustainability Centre for Excellence and eco-tourism destination at St Kilda to support biodiversity conservation and education”.
- 5.2 A key highlights version of progress against the Sustainability Strategy for 2023/24 will be graphically designed for community release.
